



Effective from 1 March 2008, Fubon Bank (Hong Kong) Limited (the "Bank") will charge a new service fee and the existing charges for bank services will be revised as follows:

### Low Balance Monthly Service Fee

Customers whose Monthly Asset Under Management (AUM) is below HK\$5,000 or equivalent will be charged a Low Balance Monthly Service Fee of HK\$50 or equivalent per month. Monthly AUM is the monthly aggregate daily balance of all HK dollar and foreign currency deposits, securities, unit trusts and structured investment products under the same customer record of the Bank divided by the number of calendar days of the month. If customers with Monthly AUM HK\$5,000 equivalent or above, the monthly service fee will be waived.

Note:

1. The fee will be charged to the customers' account designated by the Bank monthly based on the Monthly AUM in the previous month. For foreign currency account, the monthly fee will be converted to respective foreign currency.
2. Joint name account will be counted as separate entity.
3. Monthly fee is not applicable to customers of Ambassador Banking, SME Banking, Corporate Banking, Mortgage Loan, Personal Installment Loan and Life Insurance.

由2008年3月1日起，富邦銀行(香港)有限公司(「本行」)將徵收新收費及對現行銀行服務收費作出調整，現詳列如下：

### 低額結存服務月費

「每月資產總值」低於港幣\$5,000或等值之客戶，每月須繳付港幣\$50或等值之「低額結存服務月費」。該月費的計算方法為每月客戶於本行相同名下紀錄的每日所有港幣及外幣存款、證券、基金及結構性投資產品金額之總和除以該月的日數。若客戶之「每月資產總值」為港幣\$5,000等值或以上，將豁免收取有關月費。

註：

1. 有關月費將根據客戶上月之「每月資產總值」於本行指定之客戶戶口每月收取。若該戶口為外幣戶口，服務月費將折算為相關外幣計算。
2. 聯名客戶將作單一客戶計算。
3. 服務月費不適用於 Ambassador Banking、中小企、企業銀行、樓宇按揭、定額私人貸款及人壽保險客戶。
