- 5. Addition of disclosure of "Risk of providing an authority to repledge the Customer's securities collateral etc." (Please refer to Clause 23.9 of Section III E of the Global T&C)
- 6. Addition of disclosure of "Risk of Trading in leveraged foreign exchange contracts" (Please refer to Clause 23.10 of Section III E of the Global T&C)
- Addition of disclosure of risks on "Additional Risk for Bonds Trading General" (Please refer to Clause 23.13.2 of Section III E of the Global T&C)
