Terms and Conditions under Application For Transfer of Credit (Form no. BIB 009 12/2015)

GENERAL

- 1. Any notice or demand by you under this application or in connection with this transfer may be given to us by telephone or facsimile transmission, or served to us by post and shall be deemed to have been duly received by us on the day of dispatch if given by telephone or facsimile transmission or on the day following the day of posting if sent by post addressed to the address given hereunder or last known to you, its return by the post office to you notwithstanding.
- You are irrevocably instructed to advise amendments to the original credit, except increase of credit amount, quantity of goods, unit price, and extension of presentation period, shipment and expiry dates to the transferee, without our prior consent.
- 3. In consideration of your transferring the above-mentioned credit at our request, we undertake to promptly and fully indemnify you and your agents and correspondents on demand against all liabilities, claims, demands, losses, damages, taxes, costs, charges and expenses of any kind (including, without limitation, legal fees on a full indemnity basis) which may be suffered or incurred by you or any of your agents or correspondents and all actions or proceedings which may be brought by or against you or any of your agents or correspondents whether in contract, tort or otherwise arising from or in connection with the transfer of the subject credit and/or the exercise or preservation of your powers and rights under these terms and conditions.
- 4. We undertake to deliver to you all amendment(s) relating to the subject credit at the time of transfer or immediately after receipt of same. Without prejudice to the generality of Clause 3 above, the indemnity in Clause 3 above shall apply if we fail to deliver to you the amendment(s) as aforesaid.
- 5. We further agree that neither you nor your agents or correspondents shall be responsible for the description, quantity, quality or value of the merchandise shipped under the transferred documentary credit, nor for the correctness, genuineness or validity of the documents, nor for any other cause beyond your or their control.
- 6. The original advice of credit is enclosed herewith and we shall be glad if you will notify the transferee.
- 7. Except so far as otherwise expressly stated, the transfer of the documentary credit and the transferred documentary credit are subject to the version of Uniform Customs and Practice for Documentary Credits of the International Chamber of Commerce that applies to the original documentary credit. This application and the transfer of the documentary credit are also subject to the terms and conditions of the document(s) relating to trade financing transactions (including your General Commercial Agreement) executed by us and on file with you (as they may be amended from time to time).
- 8. We confirm that no person other than you and we will have any right under the Contracts (Rights of Third Parties) Ordinance (Chapter 623 of the laws of the Hong Kong Special Administrative Region) to enforce any terms and conditions of this application.
- 9. This application and these terms and conditions are governed by, and shall be construed in accordance with, the laws of the Hong Kong Special Administrative Region.
