




Advances to Customers less Impairment 客戶貸款減減值

In 2011, Fubon Bank (Hong Kong) Limited and its subsidiaries ("The Group") achieved a net profit of HK\$280 million, with an increase of 5.1% over 2010. The return on average assets was 0.46% and return on average equity was 5.53%. During the year total customer deposits and medium term funding decreased by 3.1% to HK\$45.4 billion. Advances to customers less impairment increased by 11.7% to HK\$32.2 billion. Total assets decreased 2.5% to HK\$60.3 billion. The Group had total equity funds of HK\$5.05 billion, and a capital adequacy ratio of 15.89%.
