# Corporate Profile 公司簡介

Fubon Bank (Hong Kong) Limited ("Fubon Bank") is a wholly owned subsidiary of Fubon Financial Holding Co., Ltd. ("Fubon Financial Holdings"), a leading financial services group in Taiwan which is engaged in institutional banking, consumer finance, wealth management, investment management and insurance. Fubon Financial Holdings is now the only Taiwanese financial institution with banking subsidiaries in China, Taiwan and Hong Kong. Fubon Bank operates 22 branches, 3 Securities Services Centres and 1 Personal Loan Centre in Hong Kong, providing a wide range of financial services encompassing consumer and wholesale banking, wealth management, financial markets, securities brokerage and investment services. Fubon Bank holds an A-2 shortterm, BBB+ long-term rating from Standard & Poor's. The rating reflects Fubon Bank's strong capitalization, good liquidity and sound asset quality.

富邦銀行(香港)有限公司(「富邦銀行」)是台灣富邦金融控股股份有限公司(「富邦金控」)的全資附屬公司。富邦金控是台灣一所具領導地位的金融控股公司,提供完整多元的金融服務,包括法人金融、消費金融、財富管理、投資管理及保險服務。富邦金控是唯一在兩岸三地均擁有銀行子行的台資金融機構。富邦銀行於香港透過22間分行、3間證券投資服務中心及1間私人貸款中心為客戶提供全面的優質銀行服務,包括零售及商業銀行、財富管理、金融市場、證券及投資服務。富邦銀行獲標準普爾授予A-2短期及BBB+長期信貸評級。該評級反映富邦銀行資本雄厚,流動資金充裕及資產質素優良。







In 2014, Fubon Bank (Hong Kong) Limited and its subsidiaries ("The Group") achieved a net profit of HK\$481 million, with an increase of 27% over 2013. The return on average assets was 0.62% and return on average equity was 5.18%. During the year total customer deposits and medium term funding increased by 11% to HK\$56.3 billion. Advances to customers less impairment allowances increased by 16% to HK\$40.3 billion. Total assets increased by 17% to HK\$83.9 billion. The Group had total equity funds of HK\$10.4 billion, and a total capital ratio of 17.96%.

二零一四年,富邦銀行(香港)有限公司及其附屬公司 (「本集團」)錄得純利4.81億港元,較二零一三年增 加27%。平均資產回報率為0.62%,而平均股本回報 率則為5.18%。於本年度,客戶存款及中期資金總額 增加11%至563億港元,而客戶貸款減減值撥備則增 加16%至403億港元。總資產上升17%至839億港 元。本集團總股本資金為104億港元,總資本比率則達 17.96%。

# **Chairman's Statement**

# 主席匯報



The year 2014 was special for Fubon Bank (Hong Kong) Limited ("the Bank") as it marked the 10<sup>th</sup> anniversary of the Bank, a milestone in our history. We celebrated the anniversary last May by sharing our journey with our clients, business partners and stakeholders. It has been my honour to see the Bank grow in a steady and consistent manner in the last ten years and the anniversary was a stirring reminder of the determination and character of our management team whom I am privileged to lead.

I would like to highlight some of our 2014 achievements and, more importantly, to outline our agenda for 2015 and beyond.

Our 10th anniversary was a chance to showcase the Bank's past achievements, but 2014 proved to be a year of challenges and opportunities, from the "Occupy Central" movement to the longawaited Shanghai-Hong Kong Stock Connect. In between, we were confronted with a mixture of good news and sometimes less positive global developments. While the relaxation of the Renminbi conversion limit for Hong Kong citizens was welcomed by the local community, the slowdown in economic growth in Mainland China and a slump in global oil prices created some issues for both the local and global economies. Banks in Hong Kong faced headwinds from volatile financial markets, sluggish property transactions and intense competition. During this period, the Bank acted on business opportunities in a timely manner and optimized our assets and liabilities proactively. We continued to follow a steady approach to grow our business in 2014. Given our sound foundation and prudent risk management, we were well placed to further strengthen our business platform. Apart from that, we also benefited from increased business collaboration with other companies within the Fubon Group ("the Group"). As a result, the Bank recorded a net profit of HK\$481 million, up 27% compared with 2013. This was an encouraging performance that was attributable to our staff's strong and dedicated efforts.

While we made notable gains in our local corporate business, the unique infrastructure of the Group in Greater China provided us with even more opportunities. Looking ahead, we will be more focused on expanding our local corporate business and together with the Group's Greater China network, we are optimistic for our 2015 progress. We will continue to expand our network coverage and corporate customer base by fully leveraging on the intensive cross-selling activities within the Group.

對富邦銀行(香港)有限公司(「本行」)來說, 2014年別具意義。於這一年,本行踏入十周 年,標誌著我們歷史上的一個里程碑。去年5 月,我們與客戶、業務夥伴及持份者一同慶祝 我們的周年誌慶。我很榮幸能看到本行在過去 十年穩健有序地發展,並很高興我能領導一支 意志堅毅和充滿個性的管理團隊。

讓我在此與大家回顧本行於2014年的一些成就,更重要的是,概述2015年及以後的發展 大計。

本行的十周年誌慶是我們展現過去成就的良 機,但2014年無疑是充滿挑戰和機遇的一 年,包括「佔領中環」運動以至萬眾期待的滬 港通等。期間,我們面對環球市場上好淡互見 的情況,其中中國政府放寬人民幣兑換上限受 到香港市民歡迎,但中國內地經濟增長放緩、 全球油價暴跌等則為本地及環球經濟帶來影 響。香港銀行業受金融市場波動、物業交投低 迷和業內競爭激烈的衝擊。期內,本行及時把 握商機,並積極優化我們的資產及負債。2014 年,本行繼續貫徹我們穩中求進的增長方針。 憑著本行穩健的根基以及審慎的風險管理, 我們得以優越的條件進一步強化業務平台。此 外,我們亦受惠於與富邦集團其他成員加強業 務合作。因此,本行錄得凈溢利4.81億港元, 較2013年增長27%,此令人鼓舞的表現全賴 本行員工群策群力,辛勤拼搏。

在本行本地企業業務取得顯著進展的同時,富邦集團在大中華區的獨特基礎設施,亦為我們帶來更多發展機遇。展望未來,我們將更專注擴展本地的企業業務,配合富邦集團在大中華地區的網絡,我們對2015年的業務進展感到樂觀。我們將充分借助與其他富邦集團成員的協銷活動,繼續擴充本行的網絡規模及擴大企業客戶的基礎。

In our Retail Banking business, we integrated the Customer Services Team into our Retail Banking operation to optimize our retail service quality and combine the management of our different retail banking activities under one management. Under this new structure, we expect better synergy between different retail units. We also began a programme to revamp our internet and branch banking. We expect to introduce mobile banking sometime later in 2015. We believe that we will be able to enter into a paperless era in the not too distant future, where services and the sale of products will be conducted on electronic platforms. Moreover, we will look for ways to leverage on our well established infrastructure and facilities to develop more new business opportunities.

On Wealth Management, we are committed to provide a range of comprehensive investment products best suited to our customers' risk appetites and investment needs. Last year, we launched a variety of investment products, from "Income Approach" to currency-hedged funds. To sustain our growth, we will continue to expand our product offerings to help our customers diversify their investment portfolios. We are also excited to have re-activated the business of FB Investment Management Limited in 2014 and plan to launch new investment funds in 2015. For the sales of insurance products, we recorded impressive double-digit growth last year. The Bank will continue to widen its range of insurance products, especially in Renminbi-denominated ones, and work with other members of the Group in Taiwan and the Mainland to further strengthen our Greater China retail banking infrastructure.

The year 2014 also marked a major milestone for our Consumer Finance business. The overall credit card spending grew by 14%. We also reinforced our unique market positioning as the "Travel Companion" credit card. Our overseas spending recorded growth of 33% and 40% respectively over the past two years. In addition, we launched our Merchant Receivables Financing Services last year, the first of its kind offered by any bank in the local market. The launch of this new financing service aims to address the cash flow needs of our merchant customers, allowing them to enhance the effectiveness of their cash flow management. We will continue to use this product to strengthen our card merchant business in 2015. Last year, the card merchant business outperformed local competitors with a year-on-year growth of 9% and ranked ninth in terms of credit card sales volume in Hong Kong, according to VISA and MasterCard. For the personal loan business, the number of new loan booked in 2014 increased by 25% compared with 2013. This result is encouraging and to further develop this business, we opened our first Personal Loan Centre in Tsuen Wan in July 2014. We will look for opportunities to open more Personal Loan Centres in the next several years.

零售銀行業務方面,我們把客戶服務團隊併入 零售銀行部,以優化本行零售銀行的服務質 素,並集中管理不同的零售業務活動。透過全 新的業務架構,我們預期不同的零售業務部門 會產生更理想的協同效應。同時,我們亦已開 始推行網上理財及分行網點的重整計劃,我們 預期於2015年稍後時間引入流動理財服務, 相信我們會在不久的將來進入無紙化的時代, 以電子平台提供銀行服務及進行銷售。另一方 面,我們希望能夠利用本行穩健的基礎設施, 拓展更多的新商機。

在財富管理業務方面,本行一直致力提供一系列切合客戶風險承受能力及投資需要的產品。去年,我們推出多項投資產品,包括以「收益」為主以至對沖的基金投資產品。為維持業務的增長,本行將會繼續拓展不同類型的產品,以助客戶分散投資組合。與此同時,本行亦已於2014年重新啟動富銀投資管理有限公司的業務,並計劃於2015年推出全新的投資基金。去年,保險產品銷售錄得驕人的雙位數增長。本行將繼續擴展保險產品系列,特別是以人民幣計價的產品,並與其他的台灣及中國大陸的富邦成員合作,進一步強化我們在大中華地區的零售銀行基礎設施。

對消費金融業務來說,2014年亦標誌著一個重 要的里程碑。整體信用卡簽賬額增長14%。我 們強化本行作為「旅遊夥伴」信用卡的獨特市 場定位,過去兩年的海外簽賬額分別錄得33% 及40%的增長。此外,我們去年推出了商戶應 收款項融資服務,開創本地市場先河。這項新 的融資服務旨在配合商戶的需要,提高現金流 管理的效益。2015年,我們將繼續透過此產品 來加強本行的信用卡商戶業務。根據VISA及 萬事達卡的數字,本行的信用卡商戶業務去年 按年增長9%,表現優於本地競爭對手,信用 卡簽賬額在香港排名第九。至於個人貸款業務 方面,2014年入賬的新造貸款額較2013年上 升25%,成績令人鼓舞。為進一步發展這項業 務,我們於2014年7月在荃灣開設了首間私人 貸款中心。我們將在未來數年繼續物色機會開 設更多私人貸款中心。

Heading into 2015, prospects for the banking sector in Hong Kong will remain uncertain as the global economic environment stays volatile. However, we will seize the new business opportunities arising from the Renminbi's increasing role as an international currency as reforms in Mainland China and elsewhere in the region stay on course. As well, we will keep a close watch on liquidity movements resulting from the monetary policies of the U.S. and the Eurozone.

# Chief Executive's Report 行政總裁報告



By any measurement, 2014 was a year of unexpected market disruption and societal volatility. For this very reason, it was an extremely challenging year for banks in Hong Kong. The United States began tapering its quantitative easing monetary policy, whilst several nations took the opposite move or cut interest rates in response to weakening economies and deflationary pressure. Domestically, the Hong Kong economy posted moderate growth in 2014 despite social disturbance and market volatility. The launch of the Shanghai-Hong Kong Stock Connect in November 2014 further strengthened Hong Kong's position as a leading offshore Renminbi centre. On the other hand, the "Occupy Central" movement raised market concerns over political uncertainties. Property prices continued to stay at historically high levels although transaction volume remained low.

整體而言,受到許多突發性事件影響,2014年可算是動盪不安的一年。因此,對香港的銀行業而言,也是極具挑戰性的一年。美國已開始退出量化寬鬆貨幣政策,但多個國家卻反其道而行或調低利率,以應對經濟弱勢及通縮壓力。本地方面,儘管社會動盪及市況波動,香港經濟於2014年仍錄得溫和增長。於2014年11月推出的滬港通,進一步鞏固了香港作為領先離岸人民幣中心的地位。另一方面,「佔領中環」運動令市場對政局的不確定因素更感關注。雖然物業市場的交投持續偏低,但香港的物業價格仍然居高不下。

Notwithstanding this challenging environment, Fubon Bank (Hong Kong) Limited ("the Bank") and its subsidiaries ("the Group") registered a net profit of HK\$481 million for the year ended 31 December 2014, representing an increase of 27% compared with 2013. The Group's operating income rose by 11% year-on-year to HK\$1,306 million while operating expenses increased by only 7%.

面對具挑戰性的經營環境,富邦銀行(香港)有限公司(「本行」)及其附屬公司(「本集團」)截至2014年12月31日止的全年淨溢利為4.81億港元,較2013年的淨溢利增長27%。年內,本集團的營運收入按年上升11%至13.06億港元,營運支出則按年僅增加7%。

Net interest income amounted to HK\$842 million in 2014, an increase of 12% when compared with 2013. The improvement was driven by a 16% growth in average interest-earning assets coupled with a higher-yielding loan portfolio. We made good progress in optimizing the loan portfolio mix and delivered solid growth in our corporate and commercial lending businesses. In the process, we reduced our reliance on mortgage lending by lowering our mortgage loan from 51% of the total loans to 46%. However, keen competition for deposits during the first half of the year resulted in significantly higher deposit costs, outpacing the improvement in asset returns. The net interest margin narrowed by 4 basis points to 1.20%.

2014年的淨利息收入較2013年上升12%至8.42億港元,有關增幅是由於生息資產均額上升16%及較高回報的貸款組合所致。我們在優化貸款組合方面取得良好進展,企業及商業貸款業務亦穩健增長。我們降低樓宇按揭貸款在貸款組合中所佔的比例,由總貸款額的51%降至46%。然而,上半年同業之間激烈的存款業務競爭,導致存款成本大幅上升,高過資產回報的增幅,淨息差收窄4個基點至1.20%。

Non-interest income rose by 9% to HK\$465 million, underpinned by solid growth in fee and commission income across our core businesses. Credit related and trade finance fee income surged by 34% when compared with 2013, reflecting the solid expansion of our commercial lending business. Insurance and unit trust commission income together grew 13%, and credit card fee income continued its steady growth of the past few years. Other operating income decreased by 5%, attributed mainly to the increased revaluation loss on financial instruments. The unanticipated depreciation in Renminbi dampened customers' interest in Renminbi-denominated treasury marketing products, reducing our growth in treasury product fee income. The percentage of non-interest income to total operating income ratio was 35.56% for 2014, versus 36.16% a year ago.

Operating expenses increased by 7% to HK\$897 million and cost-to-income ratio declined by 2.93 percentage points to 68.70%. Despite the inflationary pressure over the year, we managed to cope with the needs of our growing business while keeping our operating expenses under tight control. Information technology continued to be a crucial investment area. In 2014, we completed several milestone projects including data centre relocation, disaster recovery site upgrade, and bank-wide operating system enhancement.

There was a net charge of HK\$16 million for impairment losses on advances to customers, compared with HK\$5 million in 2013. Other impairment charges remained low at HK\$10 million. The Group continued to exercise pragmatic and prudent controls on

asset quality through the adoption of sound credit risk management practices that resulted in a very low impaired loans ratio of 0.02% as of 31 December 2014.

Xiamen Bank Co., Ltd ("Xiamen Bank") continued to sustain its strong performance and delivered good results in 2014. The Group's share of profits from Xiamen Bank reached a record high of HK\$158 million, representing a 27% growth compared with 2013. The Bank's shareholding in Xiamen Bank was diluted from 19.99% to 17.29% after a private placement of additional share capital to a new strategic investor by Xiamen Bank on 5 June 2014. As a result of this dilution, the Bank recognized a deemed disposal gain of HK\$11 million. In July 2014, the Bank participated in Xiamen Bank's rights issue exercise and fully subscribed its allocated 57.63 million rights shares at a price of RMB3.50 per share. The Bank restored its original ownership percentage in January 2015 by acquiring additional existing shares.

After accounting for other gains, other impairment losses and income tax, the Group's profit after taxation stood at HK\$481 million, achieving the highest net profit since the financial turmoil of 2008.

Total assets rose by HK\$12 billion, or 17%, to HK\$84 billion as of 31 December 2014. We managed to achieve a 16% increase in the Group's loan portfolio in 2014 while maintaining a high quality loan book. The increase in lending was supported by an 8% year-on-year growth in customer deposits, which amounted to HK\$53 billion as of 31 December 2014. Loan to deposit ratio remained at a very comfortable level of 75.09%.

截至2014年12月31日止,總資產增加120億港元或17%至840億港元。在我們保持貸款質素良好的同時,本集團的貸款組合於2014年亦增長16%。截至2014年12月31日止,客戶存款按年上升8%至530億港元,以支持貸款的增長。貸存比率則維持在非常穩健的75.09%。

To further strengthen Tier 1 capital and to allow greater flexibility in business development within the region, the Bank issued 269,784,173 new Ordinary Shares which were fully allotted to Fubon Financial Holdings at the price of HK\$5.56 each. With the HK\$1.5 billion increase in share capital, the total capital ratio and Tier 1 capital ratio increased to 17.96% and 12.65% respectively as at 31 December 2014, compared with 16.33% and 10.44% respectively at end-December 2013. The Bank's liquidity position also remained strong, with the average liquidity ratio standing at a comfortable level of 48.56% in 2014 versus 48.06% in 2013.

While registering a solid expansion in assets in 2014, the Group continued to exercise prudent balance sheet management. Return on average assets edged up to 0.62%, compared with 0.56% in 2013. Return on average equity also rose by 0.37 percentage points to 5.18% in 2014, reflecting the Group's effective deployment of the additional capital from the parent company.

We will continue to carry out the revamp of our retail outlets in order to extend our banking services and improve the customer experience. We also made good progress in strengthening our banking operations by establishing a new functional unit to facilitate enterprise level project management and streamline operational workflow to improve operational efficiency. Certainly, we have laid a sound foundation for sustainable growth in this volatile business environment.

As a socially responsible institution, we remain supportive to our staff by providing them with career development programmes and education sponsorship. We also maintain our commitment to the local community by supporting a wide range of corporate social responsibility programmes.

# **CORPORATE BANKING**

The year 2014 was a defining one for our corporate banking teams as the global economic recovery was far from certain and the Hong Kong economy expanded only moderately. Despite such weak market sentiment, we were still able to achieve satisfactory growth in our corporate banking business. Loan assets grew by 25% with the spread widening compared to the previous year. While pursuing a sustainable growth in our lending business, we maintained a prudent lending approach placing more emphasis on fee generation. Loan quality was maintained at a sound level, with the impaired loan ratio declining further to a negligible 0.02%.

While we were successful in growing our corporate loan portfolio, more importantly we were able to complement our lending business with a satisfactory increase in treasury fee income. Our emphasis was on the provision of products to assist our corporate clients in hedging their foreign exchange and interest rate exposures resulting from their normal business operations. With the support of our treasury marketing team, we continued to expand our product offering and were able to maintain a strong momentum in the generation of treasury related fee income.

We achieved good results in our trade related services with the volume of commercial letter of credit transactions processed increased by 26% over the previous year. Our other well received trade related products included forfaiting and factoring with volumes increased by 29% and 129% respectively. Our finance lease product which was launched in 2013 achieved satisfactory results. Marketing of this product was in full swing during 2014.

# 企業金融

我們不但成功擴展企業貸款組合,更重要的 是,本行的財資費用收入亦錄得滿意的增幅。 我們著重提供產品協助企業客戶對沖正常業務 營運帶來的外匯及利率風險。在金融行銷團隊 支援下,我們不斷擴大本行的產品種類,而財 資相關費用收入維持強勁勢頭。

本行的貿易相關服務錄得理想的業績,所處理的商業信用證交易量較去年增加26%。其他受歡迎的貿易相關產品,包括信用證買賣斷業務及應收賬款承購服務,交易量亦分別增長29%及129%。我們於2013年推出的租賃貸款在2014年全力進行營銷活動,並獲得令人滿意的成績。

Our mission in 2015 is to solidify our position as a quality financial services provider in our targeted market segment. We will continue to improve on our corporate banking products such as trade finance and finance lease. At the same time, we will also further refine some of our core product offerings such as corporate e-banking and cash management. We wish to become our clients' value adding partner to serve and grow alongside them. As we have a full range of product offerings specifically designed for our targeted market segment, we will seek out customers who can benefit from our expertise. With the distinguished infrastructure of the Fubon Group in Greater China and our professional marketing team, we are well positioned to grow our market share and increase our earnings in the corporate banking market.

The team actively participated in FI trade business in 2014 and achieved a record turnover in risk participated deals. Going forward, we will strive to build more strategic relationships with key banks, and explore the business potential with non-bank financial institutions ("NBFI"), especially with local security firms and asset management houses. We believe our plan to expand our business in these markets will provide us with additional sources of meaningful revenue.

# **CONSUMER FINANCE**

The year 2014 marked a major milestone for the consumer finance business. Several ground-breaking initiatives were launched during the year to satisfy the financial needs of our customers as well as to enhance the customer experience with the Bank.

The popular "Travel Companion" credit card stayed strong in 2014 with overseas spending growing by 40% year-on-year. The promotion of 20-times bonus points for Taiwan spending and 8-times bonus points for Japan and Korea spending was one of the most attractive spending offers in the market, especially for the well-travelled Hong Kong people. Our Yata VISA Card, a co-branded credit card issued jointly with Yata Department Store, also achieved good results with the customer base and card spending growing by 9% and 10% respectively. In 2015, we will continue to enrich the card spending benefits through different forms of collaboration with merchant partners. Overall, our total credit card base grew by 5% while card spending boosted by a significant 14% growth.

To broaden the spectrum of our credit card merchant service, we provided market leading financial tools in 2014 to facilitate merchants' cash flow management, including Hire Purchase Programme and Merchant Receivable Financing, the first of its kind offered by a bank in Hong Kong. While the former focused on professional industries that involved the acquisition of business installations and equipment,

為擴大信用卡商戶服務的範疇,我們於2014年 推出了領先市場的金融工具,方便商戶管理現 金流,其中包括「商戶租賃計劃」及開創本地 銀行先河的「應收卡賬融資」服務。「商戶租賃 計劃」的對象主要是需要添置營運裝置和設備 的專業服務機構,而「應收卡賬融資」服務則 the latter offered a quick and simple channel for small to medium size merchants to gain extra cash flow flexibility. This direction will be sustained in 2015 to fulfill the target of delivering all-rounded credit card merchant services. Our card merchant business constantly outperformed local competitors with year-on-year growth of 9% in total sales volume while the market grew by around 6%. We also ranked ninth in terms of credit card sales volume in the local market, according to VISA and MasterCard.

The establishment of the Bank's first Personal Loan Centre in Tsuen Wan in July 2014 signified a major step forward for our personal loan business. With an extra sales force and extended geographic presence, our personal loan business achieved a staggering growth of 25% in new loan booked year-on-year. Aside from business growth, we also constantly fine-tuned our risk acceptance criteria and service standards to achieve a high level of customer satisfaction. With the gearing up of additional sales force, we foresee another strong performing year in 2015.

Residential property prices stayed strong in 2014 with over 10% growth throughout the year. The volume of residential property transactions, on the other hand, remained stagnant at around 5,300 transactions per month, a relatively low level in recent years. As the financial burden of making mortgage down payments increased, our "Fubon 90% Mortgage Plan" (under the mortgage insurance programme), served as a viable solution for many genuine homebuyers who could purchase their dream home with just a 10% mortgage down payment using the subscription of a mortgage insurance programme through our insurance partners. For other segments of the mortgage market, we focused not only on pricing flexibility, but also on how to fulfill the financial needs of potential property buyers. As always, our dedicated team of mortgage consultants was standing by to provide one-stop mortgage consulting services. The team brought in a moderate 3% growth in total new loan booked, a good achievement under very difficult market conditions.

Over the past decade, we have maintained a customer-centric focus with products and services developed to serve the many needs of our targeted customers. From the most basic credit card services for individuals to innovative Merchant Receivable Financing for SME merchants, we remain dedicated with a core objective of "Growing With Our Customers".

2014年7月,本行於荃灣開設私人貸款中心,標誌著本行私人貸款業務邁進一大步。透過擴展銷售團隊和服務地區,本行私人貸款業務的新造貸款額按年大增25%。除拓展業務外,我們還不斷調整風險承受程度及服務標準,以提升客戶的滿意度。在更強大的銷售團隊支援下,我們預期2015年可繼續締造佳績。

2014年,住宅物業價格保持強勁,全年上升逾10%,但住宅物業交投量停滯不前,每月約為5,300宗,屬近年較低的水平。有見樓宇按揭育期上調導致置業人士的財政負擔增加,「富邦9成按揭計劃」(須配合樓宇按揭保險計劃)為置業人士提供切實可行的置業方案。透過本行保險夥伴提供的按揭保險計劃,置業人士提供切實可行的置業方案。透過本行不成首期便可實現置業夢想。至於按揭市場的其他方面,我們不但著眼於定價的靈活性,認可不但著眼於定價的靈活性,與此方面,我們專責按揭的團隊,隨時為客戶提供一站式的按揭諮詢服務。新造貸款總額錄得3%的溫和增長,在艱難的市況下獲得不俗的成績。

# **INVESTMENT & INSURANCE**

Investment funds income rose year-on-year by 5%. "Income Approach" was our major investment theme in 2014 and a number of currency-hedged funds such as Renminbi ("RMB") were introduced to satisfy our customers' needs. Meanwhile, various promotion programmes were launched to acquire new customers and broaden our base assets under management ("AUM").

We expect the global economy will remain volatile due to the uncertainty over the monetary policy of major economies. To sustain our growth, the Bank will continue to offer a broad selection of products to help customers further diversify their investment portfolios.

Our insurance business continued to grow in 2014 with fee earning increased by 17%. We take pride in the several new initiatives to satisfy our customers' needs to maximize their return on investment within their risk tolerance. In terms of product choices and services, we worked with our insurance partners to extend our product range to RMB annuity products and online travel insurance products. Looking forward, we will continue to co-operate with our insurance partners to explore more new products to cater to our customers' needs and to enhance their overall banking experience with us.

# **DEPOSITS**

We are committed to grow a healthy and steady retail deposit base. Despite fierce market competition, our retail deposits still reached a new milestone of HK\$38 billion at the end of December 2014,

# 投資及保險產品

投資基金收入按年上升5%。本行於2014年以「收益」為主要投資主題,並因應客戶的需要推出如人民幣等多種貨幣對沖基金。另外,本行推出多項推廣計劃,以吸納新客戶和擴大資產管理的規模。

由於主要經濟體系的貨幣政策前景不明朗,我們預期環球經濟將持續波動。為保持增長,本行將繼續提供廣泛的產品種類,協助客戶進一步分散投資組合。

2014年,本行的保險業務持續增長,費用收入增加17%。我們採取多項新措施,讓客戶得以在可承受的風險程度內取得最高的投資回報。在產品選擇和服務方面,我們與保險夥伴合作,把產品範圍擴展至人民幣年金產品和網上旅遊保險產品。展望未來,我們將繼續與保險夥伴共同努力,研究更多新產品,以滿足客戶的需要及提升整體的銀行服務體驗。

# 存款

我們致力開拓穩健的零售存款基礎。儘管市場競爭激烈,本行的零售存款於2014年12月底仍達致380億港元的新里程碑,按年增長

representing a year-on-year increase of 3%. A series of promotion programmes in fixed deposits and demand deposits was launched to strengthen our overall deposit.

Looking forward to 2015, we will continue to offer a diversified range of innovative deposit products, including demand deposit and payroll service to solidify the relationship with our customers. Promotional activities will be carried out throughout the year to increase market awareness.

# **SECURITIES SERVICES**

Despite the strong rallies in the U.S. and Mainland markets in 2014, concerns over the Fed's tapering and the uncertain outlook of Mainland China's economy weighed on the Hong Kong market as the Hang Seng Index only rose by 1%. The Mainland stock market became one of the best performing markets worldwide in 2014 with the Shanghai Composite Index rising by 53%. Our brokerage business was able to perform well in 2014 with substantial progress in customer acquisition.

Since opening in July 2014, our new Tsuen Wan Securities Services Centre has made a significant contribution to the brokerage income and achieved a satisfactory new account activation rate. To celebrate the 10<sup>th</sup> anniversary of the Bank, we launched a "HK\$10 Brokerage Commission" promotional campaign for transactions made via our Internet Stock Trading ("IST") platform. In addition, a series of quarterly promotions was also launched to attract new customers while boosting the usage of our IST service. During the year, over 5,000 new customers opened a securities account with the Bank. Our efforts to expand the securities customer base have generated great opportunities for us to capture a larger market share. As well, our enhanced IPO financing services enabled us to better serve our customers with a broadened selection of securities-related products.

Looking ahead, we will further enhance our services with the introduction of securities services centres into our flagship branches and to integrate our securities services into the Bank's mobile banking platform. We are confident that the enhancement of trading channels and customer services will pave the way to sustainable growth in our business.

自2014年7月開幕以來,本行的荃灣證券投資服務中心對經紀佣金收入作出重大貢獻,並達致令人滿意的新賬戶啓用率。為慶祝本行用年紀念,我們推出了「HK\$10經紀佣金」推廣活動,優惠適用於透過本行網上證券交易服务的使用量。年內共有5,000多紙實行的交易。此外,本行更推出一系列季度推廣活動,以吸納新客戶,從而提高本行網之證券交易服務的使用量。年內共有5,000多經數客戶在本行開立證券戶口。我們致力拓展查於服務的客戶群,為擴大市場佔有率提供重人機遇。同時,我們加強首次公開招股融資服務,為客戶提供更多證券相關產品。

展望未來,我們將進一步提升服務質素,在旗艦分行開設證券投資服務中心,並在流動理財服務平台提供證券投資服務。我們相信,透過優化交易渠道和客戶服務,將有助本行業務持續場長。

# CHANNEL MANAGEMENT

Leveraging on our existing infrastructure and well-established branding, we strategically deployed resources and implemented customer-focused initiatives to support our efforts to further improve our service delivery and sales. We enhanced our branch network and upgraded the e-banking platform to build a customer-oriented banking environment to better serve the needs of our targeted customers. Our customers can now conduct general banking and investment transactions at branches and enjoy a one-stop banking experience through our e-banking platform. We have embarked on a programme to build an automated and paperless banking environment that meets the expectation of our customers.

# TREASURY MARKETING

We continued to expand our product team to develop new products to satisfy our customers' needs in 2014. To better serve our customers, we launched six new products during the year including the Currency Linked Digital Structured Deposit. We were able to expand our customer base and improve sales revenue from these new products.

In 2014, the Renminbi ("RMB") conversion limit of RMB20,000 per day for Hong Kong residents was removed and we successfully delivered various RMB-based products and services to both corporate and retail clients. RMB-related transactions remained a main contributor of our total Treasury Marketing Unit ("TMU") fee income in 2014.

Our Treasury Marketing Unit will continue to co-operate with other business units to explore more opportunities to work with our retail and corporate clients to satisfy their investment and foreign exchange needs.

In 2015, we will continue to co-operate with other members of the Fubon Group, including Xiamen Bank and Fubon Bank (China), for cross-selling of financial products. We have also re-activated the business of FB Investment Management Limited and plan to launch two funds in 2015.

We will also continue to capture the business opportunities generated by the continuous economic growth of Mainland China and to act as an offshore financial platform by providing financial products and professional services to Greater China corporates and financial institutions.

# 財資市場

2014年,本行繼續增加產品開發部的人手,以 推出新產品來滿足客戶的需要。為提供更優質 的服務,本行於年內推出了六款新產品,其中 包括「外幣定點結構存款」。透過推出這些新產 品,我們得以擴大客戶基礎,並提高銷售收入。

2014年,當局取消了香港居民每日兑換2萬元 人民幣的限額,我們亦成功為企業和零售客戶 提供多種人民幣產品及服務。人民幣相關交易 仍然是金融行銷部2014年費用收入的主要來 源。

金融行銷部將繼續與其他業務部門合作,發掘 更多與零售和企業客戶合作的機會,滿足他們 的投資和外幣兑換需要。

2015年,我們將繼續與其他富邦集團成員(包括廈門銀行和富邦華一銀行)合作,進行金融產品的交叉銷售。我們亦已重啓富銀投資管理有限公司的業務,並計劃於2015年推出兩隻基金。

我們亦將繼續把握中國經濟持續增長所帶來的 商機,並透過離岸金融平台提供金融產品和專 業服務,為大中華區的企業及金融機構服務。 The sustained strength of the U.S. Dollar and the current situation in Europe will give rise to many uncertainties in the emerging markets. As always, we will continue to focus on providing investment and risk mitigating products to our customers in a disciplined manner.

# **INVESTMENT PORTFOLIO**

As our balance sheet grew in 2014, our total investment portfolio size also increased by 25%. The Fed ended the Quantitative Easing while European Central Bank introduced negative deposit rates and injected liquidity via Targeted Longer-Term Refinancing Operation in an attempt to encourage more banks to lend in 2014.

Despite the tightening of the credit spread, our investment portfolio's overall returns increased significantly in this difficult year. Our investment strategy, which mainly focused on credit quality and diversification proved to be successful. More significantly, the result was achieved with an increase in our interest rate risk, which was perceived low as evidenced by the relatively short duration.

Looking forward, due to investors' increasing demand for defensive instruments in a currency that is gradually being internationalized, we remain optimistic about the offshore RMB bond market. To support the Bank's RMB balance sheet, our RMB fixed income investments tripled in 2014. Despite the current challenging credit market environment, we believe that our investment strategy will continue to improve the performance of our portfolio.

# 投資組合

本行的資產負債規模於2014年有所擴大,投資組合總值亦增長約25%。2014年,聯儲局結束量化寬鬆政策,歐洲央行則推出負存款利率,並透過定向長期再融資操作,向市場注入更多資金,以鼓勵銀行批出更多貸款。

儘管信貸息差收窄,本行投資組合的整體回報 在困難的市況中,仍錄得顯著升幅,證明本行 以監控信貸質素和分散風險為重心的投資策 略,行之有效。更重要的是,上述回報是在利 率風險提高的情況下達致的。由於存續期相對 較短,利率的波動風險尚屬低水平。

展望未來,由於人民幣日益國際化令投資者對防守性的人民幣投資工具需求上升,我們對離岸人民幣債券市場保持樂觀。2014年本行的人民幣固定收益投資增加兩倍,以擴大人民幣資產負債規模。雖然目前的信貸市場環境充滿挑戰,但我們相信,本行的投資策略將能繼續提升投資組合的表現。

# **FUNDING**

In November 2014, the Chinese authorities relaxed monetary conditions to support economic growth. The continued liquidity injection by the People's Bank of China relieved market concerns on the onshore funding rate in Mainland China's interbank markets and there was no material slippage in the growth of Mainland China's economy in 2014.

Our Hong Kong Dollar deposits increased by 3%, while our Bank's offshore RMB ("CNH") deposits maintained at a high level in 2014. With a sound RMB balance sheet, our overall funding position was stable. With the Hong Kong Monetary Authority recording close to HK\$239 billion in its aggregate balance as of 31 December 2014, we expect the Hong Kong market's liquidity to remain strong in 2015. Funding cost gradually stabilized towards the end of 2014 and our net interest income increased by 12%. Our liquidity ratio maintained at a healthy level of 46% by the end of 2014.

# 資金

2014年11月,中國政府以放寬貨幣政策來支持經濟增長。中國人民銀行繼續向市場注資, 舒緩了市場對中國內地銀行同業市場境內融資 利率的關注。2014年,中國內地的經濟增長 並沒有大幅下滑。

本行的港元存款於2014年增加3%,而離岸人民幣存款則維持在高水平。在穩健的人民幣資產負債表支持下,本行的整體資金狀況保持穩定。香港金融管理局於截至2014年12月31日止錄得接近2,390億港元的總結餘,我們預期香港市場的流動資金於2015年繼續保持強勁。資金成本於2014年下半年漸趨穩定,本行淨利息收入上升12%。截至2014年底,我們的流動資金比率維持在46%的健康水平。

# **CONSUMER CREDIT RISK MANAGEMENT**

After four consecutive years of property price increases in Hong Kong together with the rebound of property sales volume in 2014, we foresee a mild correction in 2015 as a result of rising property supply and the widely anticipated interest rate hike. The volume of personal bankruptcy increased by 6% in 2014 to 10,035 cases, suggesting a worsening consumer market situation. In the face of such uncertainties, we will continue to conduct periodic stress testing and robust review of the Bank's consumer finance portfolios to ensure that the Bank is able to withstand any unanticipated financial market turmoil. Our consumer finance portfolio remained healthy in 2014 with a relatively low charge-off rate. In 2015, we will continue to upgrade our credit risk management tools such as developing application scorecards in the first quarter of 2015 with the objective of improving asset quality and enhancing credit process efficiencies.

# **ENTERPRISE CREDIT RISK MANAGEMENT**

In 2014, we continued to conduct periodic reviews on the quality of the Bank's corporate lending portfolios. Regular updates to our credit risk management policies and guidelines to reflect the changing regulatory and market environment were made on a timely basis, enabling us to comply with new regulatory requirements and align with the Bank's overall business strategy.

Against the unstable global economy and the slowdown of Mainland China's economic growth, the major challenge for 2015 is to maintain a high quality loan volume while we grow our portfolio. We will continue to take a prudent approach to credit risk management, supported by rigorous post-lending credit monitoring and reviews of the market environment.

# **MARKET RISK MANAGEMENT**

We have seen a more volatile financial market in 2014, with the Renminbi depreciating in the first quarter after years of appreciation, the ending of U.S. quantitative easing in the third quarter, and the central banks

# 消費信貸風險管理

香港物業價格經過連續四年的上漲,加上物業成交量於2014年反彈,我們預期隨著物業供應增加以及加息預期升溫,香港物業市場將於2015年出現溫和調整。個人破產宗數於2014年增加6%至10,035宗,反映消費市道不斷轉差。面對上述不明朗因素,我們將繼續定期,行壓力測試和嚴格檢視本行的消費金融組合於2014年保持穩健,撇賬本行的消費金融組合於2014年保持穩健,撇賬率處於相對較低水平。我們將繼續於2015年第一季開發申請評分卡,以提升資產質素及信貸審批流程的效率。

# 企業信貸風險管理

2014年,我們繼續定期檢討本行企業貸款組合的質素。因應監管及市場環境的變化,我們適時定期更新信貸風險管理政策和指引,以符合新的監管規定及貫徹本行的整體業務策略。

面對全球經濟的不穩局面和中國內地經濟增長 放緩,我們於2015年的主要挑戰,是在保持貸 款質素的同時,擴展貸款組合。我們將繼續審 慎管理信貸風險,在批出貸款後進行嚴謹的信 貸監察及不斷檢視市場環境。

# 市場風險管理

2014年,金融市場波動加劇,人民幣升值多年 後於第一季貶值,美國於第三季結束量化寬鬆 政策,歐洲及日本央行則於2014年下半年向金 in Europe and Japan injecting liquidity into the financial markets in the second half of 2014 to lift up their fragile economies.

To cope with the volatile market, we closely monitored the Bank's market risk to ensure that its financial market activities were conducted within the pre-set appetite. The Board was provided with timely market risk disclosure from different perspectives and comprehensive stress test results on the Bank's market risk position to ensure that the Board was fully apprised of the Bank's risk portfolio.

The Bank has invested heavily in upgrading its market risk management system, and will introduce a new treasury management system in the first quarter of 2015. The new system will enable the Bank to monitor its market risk in a more timely manner so that it can be more responsive to changing market conditions.

融市場注資,以提振脆弱的經濟。

面對市況波動,我們密切監察本行的市場風險,確保在設定的風險承受能力範圍內進行金融市場活動。我們適時向董事會披露從不同角度編製而成的市場風險資料,以及有關本行市場風險狀況的綜合壓力測試結果,確保董事會充分了解本行的風險組合。

本行已作出重大投資進行市場風險管理系統升級項目,並於2015年第一季引進新的財資管理系統,使本行能適時監察市場風險,並更加靈敏地回應市況變化。

# **OPERATIONAL RISK MANAGEMENT**

The Bank has established a robust operational risk management framework to identify, assess, monitor and report operational risks. In 2014, a revamped Control Self Assessment process was implemented, enabling every unit of the Bank to effectively monitor its compliance with regulatory requirements and adherence to the control standards. Results of the quality check and relevant suggestions were reported to management on a timely basis.

The Bank utilizes an independent risk management unit to evaluate the effectiveness of the Bank's operational and system controls. It also conducts review of the Bank's business continuity plans and evaluates the results of regular testing of contingency facilities. All new products are subjected to a rigorous review to ensure compliance of all regulatory requirements.

In 2015, we will focus on awareness and training programmes to promote a better control culture and understanding of the Bank's policies and guidelines. We will further enhance our risk management tools and reporting systems to facilitate effective assessment of the Bank's operational risk.

# 營運風險管理

本行已建立完善的營運風險管理架構,以辨識、評估、監察及匯報營運風險。2014年,本行改革及推出新的自我監控評估流程,讓每個部門可有效地監察其有否遵守監管要求和符合監控標準。我們還適時向管理層匯報質素檢查的結果及提供有關建議。

此外,我們透過獨立的風險管理部門,評估本 行營運和系統監控的有效性。該風險管理部門 亦負責檢討本行的持續業務運作計劃,並評估 應變措施的定期測試結果。所有新產品均須接 受嚴格的審核,確保符合所有監管規定。

於2015年,我們會加強推行培訓計劃,以提升 本行的監控文化,讓員工加深了解本行的政策 和指引。我們將進一步強化風險管理工具和匯 報系統,確保本行對營運風險能作出有效的評 估。

# **COMPLIANCE**

The entire organization of the Bank is committed to meeting all regulatory compliance. This culture emanates from our Board and cascades down to the entire staff. The cultivation of a bank-wide compliance culture lies at the heart of the Bank's business.

Our Bank management has also taken a proactive approach to setting forth a set of principles to enhance the ongoing cultivation of this strong compliance culture through leadership, communication and training. This culture works hand in hand with a strong compliance framework archived by well-established policies and guidelines.

A robust compliance framework has been developed to provide guidance for each functional unit how they interface with each other and with the Bank's leadership. The compliance framework is comprised of seven elements with the first element, "commitment and accountability" constitutes the foundation of the framework supported by the following six pillars.

- Policies and procedures
- Controls and supervision
- Management oversight
- Monitoring
- Training and awareness
- Reporting

# **INFORMATION TECHNOLOGY**

After insourcing the information technology ("IT") functions in 2011, the Bank defined a five-year IT roadmap to refresh all major IT systems. This will upgrade the Bank's services to customers and enhance the internal controls and overall productivity of the Bank. The five-year IT plan includes an electronic banking revamp, core banking system replacement, introduction of an enterprise workflow system, accounting and financial reporting upgrade, and trade finance system replacement.

We recognize there is a rapid increase in demand for mobile banking services. As such, we will launch a new generation of mobile banking and stock trading app in the third quarter of 2015. This mobile banking app will give our customers more control over their financial transactions conducted through our Bank.

The replacement of the core banking system will begin by mid-2015 and will be one of our strategic IT projects which will enable the Bank to be a more agile player in the market, capable of creating and delivering innovative products and services in an efficient manner. As the core system is centralized and integrated, the Bank will achieve products and services enhancement while also significantly improving operational efficiency, risk management, compliance, and the management information system.

# 資訊科技

本行於2011年建立自主的資訊科技運作後,制定了為期五年的資訊科技路線圖,以更新各主要的資訊科技系統,提升客戶服務水平,並加強內部監控及整體生產力。這項五年期資訊科技計劃包括更新電子銀行服務、更換核心銀行系統、推出企業工作流程系統、提升會計及財務報告流程,以及更換貿易融資系統。

我們深明市場對流動理財服務的需求激增。因此,本行將於2015年第三季推出新一代的流動理財及股票交易應用程式。客戶利用新的流動理財應用程式,將可加強控制透過本行進行的金融交易。

本行將於2015年中開始更換核心銀行系統。這項策略性的資訊科技項目將提高本行營運上的靈活性,令我們能更有效率地創造和提供創新的產品及服務。核心銀行系統是統一及綜合的系統,有助我們提升產品和服務質素,同時大幅提升營運效率、風險管理、合規及資訊管理系統。

The enterprise work flow solution is another strategic IT project of the Bank in 2015. The solution will integrate the existing Document Managing System to provide a comprehensive platform for managing information by using automated processes for storing, processing and retrieving data. This is also expected to improve data security.

企業工作流程方案是本行於2015年的另一項策略性資訊科技項目。新的方案將與現有的文件管理系統整合,透過自動化的數據儲存、處理及檢索流程,提供一個綜合的資訊管理平台,我們預期數據安全性亦會有所提升。

# **OPERATIONS**

In 2014, we continued to enhance the efficiency and effectiveness of our operational activities to better support the growing business and provide quality service to customers. Throughout the year, a series of initiatives was implemented successfully with satisfactory results achieving both operational synergies and a reduction in operating costs.

A number of existing banking operation processes have been simplified and streamlined, leveraging on both human and financial resources as well as enhancing operations risk management. An improved Straight Through Processing System for Inward Remittance was introduced in 2014 so that the funds can be credited to a customer's account more effectively. The shortened processing time of inward funds improves our services to the Bank's customers. A new Document Management System was implemented in branches and general banking operations to move us one step closer to a paperless environment. As well, document can now be kept in a more systematic and secure manner with reduced storage space and cost.

The Bank was again ranked as one of the top performing banks among 500 banks in the Asian region and won the Straight Through Processing Award in 2014 for the eighth time in the past nine years. This award was presented by our USD clearing bank, the Bank of New York Mellon, in recognition of our excellent quality fund transfer operations.

In 2015, we will continue our efforts to improve our funds transfer system and will begin work on the second phase of our new Treasury System. The Document Management System will also be extended to other areas of the Bank. We also expect further cost savings from the optimization of the utilization of existing bank premises.

# 營運

2014年,我們繼續加強本行營運上的效率及效益,以配合業務增長,並為客戶提供優質的服務。年內,我們成功推行一系列措施,在達致營運上的協同效應及節省營運成本方面取得令人滿意的成績。

透過本行的人力及財務資源以及強化營運風險管理,我們將多項現有的業務流程加以簡化。本行於2014年改進了匯入匯款的直通式聯繫結算處理系統,以便更快捷地把匯款存入客戶賬戶,縮短匯入資金的處理時間,進一步提升客戶服務質素。本行在分行及一般銀行運作上推行新的文件管理系統,向無紙化的營運環境邁進一步。我們現在可以更有系統、更安全地儲存文件,並減少儲存空間和成本。

本行再次獲選為亞洲區 500 間銀行中表現最優秀的銀行之一,並於過去九年內第八度榮獲美元結算銀行一紐約梅隆銀行頒發「直通式聯繫結算處理獎」,表揚本行質素超卓的資金轉賬服務。

我們將於2015年繼續致力改善資金轉賬系統,並開展新財資系統的第二期工作。我們亦會把文件管理系統擴展至本行的其他運作,並預期可優化現有的銀行物業使用率,進一步節省成本。

During 2014, several structural changes were made to align with our business strategies and enhance the effectiveness of the Bank's operations. The Enterprise Project & Process Management Office was established to oversee the implementation of planned IT projects as well as other multi-discipline and cross-divisional projects. Also, several business units were renamed and restructured to increase efficiency. The Customer Service Department under the Operations Division was renamed as the Customer Service / Call Centre and incorporated into the Retail Banking Division. The Corporate Banking Division was renamed as the China Coverage, Syndicated Finance & Financial Institutions Division focusing mainly on cross border and financial institutions business. The Corporate Product Management Division was also renamed as the Large Local Corporate & Product Management Division to take on the additional role of relationship management for our local corporate clients.

2014年,本行曾進行多項架構重組,以配合業務策略的需要及提高本行的營運效益。本行並成立了企業項目及流程管理部,負責監督本行資訊科技及其他企業項目之推行。此外,多個業務部門亦已更名並進行重組,以提高營運效率。營運部屬下的客戶服務部已更名為客戶服務/熱線中心,並納入零售銀行部。企業金融部則更名為中國業務、銀團貸款及金融同業業務。企金商品發展部,主要負責跨境及金融同業業務。企金商品發展部亦更名為企業金融及產品發展部,負責本地企業客戶的客戶關係管理。

We continued to recruit top university graduates for our Management Associate Programme with the aim of developing high calibre management staff for the Bank. The Management Associates will undergo intensive classroom and on-the-job training before being assigned to business or support units.

我們繼續招募本地優秀的大學畢業生加入「見習管理人員計劃」,為本行培育卓越的管理人才。見習管理人員將首先接受緊密的課堂及在職培訓,然後被派到業務或後勤部門工作。

We continued to recruit suitable candidates in various functions through different channels to support the business growth of the Bank. As an ongoing process to attract talents and retain high calibre staff, we carried out a review of the Bank's remuneration packages to benchmark ourselves against the market. There was also an ongoing review of the Bank's remuneration policies, incentive schemes and related guidelines to comply with internal and external regulatory changes and to ensure we adopt the best practice in the industry. Staff benefits were enhanced to better fit staff needs while not losing sight of cost-effectiveness.

In 2014, we marked the Bank's 10<sup>th</sup> anniversary as a member of the Fubon Group. A special award was given to all staff as a token of appreciation for their contributions over the past decade.

The Hong Kong Monetary Authority ("HKMA") has issued a statutory guideline, last revised in August 2012, on Corporate Governance of Locally Incorporated Authorized Institutions ("CG") under section 7(3) of the Banking Ordinance applicable to all locally incorporated Authorized Institutions ("Als") which the HKMA expects the Als to adopt in respect of their corporate governance.

The Bank regards corporate governance as an essential discipline for its operations and business. Thus, the Bank had in place an effective framework which is consistent with the principles and best practices in corporate governance as set forth in the guidelines on CG. In this regard, the Bank has been reorganized as one of the market leaders in corporate governance.

From time to time, the Bank will review its corporate governance practices to ensure that they are consistent with the latest requirements of international and local corporate governance best practices.

#### **BOARD OF DIRECTORS**

#### **Board Composition**

The Board of Directors ("the Board") of the Bank currently comprises nine members: one Executive Director, five Non-Executive Directors and three Independent Non-Executive Directors. All Directors possess appropriate experience, competence and personal and professional integrity to discharge their responsibilities effectively. The Board as structured is sufficiently independent and the collective expertise ensures an effective and objective decision-making process. This enables the Board to execise proper oversight of the Bank in its pursuit of its business objectives and control of the associated risks.

Details of the members of the Board may be found in the Corporate Information section of this Annual Report.

#### **Board Practices**

Full Board meetings are held at least four times a year, with one in each quarter. Notice of each Board meeting is given to all Directors at least 14 days in advance and the agenda is sent to the Directors at least 7 days before the date of each Board meeting.

Pursuant to the Articles of Association of the Bank, a Director shall not be entitled to vote or be counted in the quorum in respect of any contract or arrangement in which he or any of his associates has a material interest.

Minutes of each Board meeting are circulated to all Directors for their comments prior to confirmation of the minutes at the following Board meeting. Minutes of Board meetings are kept by the Company Secretary and are available for inspection by Directors.

Directors may have access to the advice and services of the Company Secretary with a view to ensuring that Board procedures and all applicable rules and regulations are followed.

## 企業管治常規

香港金融管理局(「金管局」)已根據《銀行業條例》第7(3)條發出有關「本地註冊認可機構之企業管治」法定指引(上次修訂於二零一二年八月)(「企業管治指引」),該指引適用於所有本地註冊認可機構(「認可機構」),而金管局希望認可機構就彼等之企業管治予以採納。

本行視企業管治為其經營及業務不可或缺的原則。因此,本行已制定符合企業管治指引內所載的企業管治原則及最佳常規的有效架構。本行亦已重新制定為企業管治的其中一個市場領導者。

本行不時對所採用的企業管治常規作出檢討,並力求符 合國際和本地有關企業管治最佳常規的最新要求。

#### 董事會

#### 董事會成員

本行董事會(「董事會」)現有9名董事,包括1名執行董事、5名非執行董事及3名獨立非執行董事。所有董事均擁有適當的經驗、才能與個人及專業操守以充份及有效地履行其責任。董事會在架構上已具備足夠獨立性及整體專業知識,以確保有效及客觀的決策過程。這亦讓董事會對銀行在追求其業務目標及控管相關風險的同時施以適當的監管。

本年報「公司資料」一節載列董事會成員詳情。

## 董事會會議常規

本行每年至少舉行4次董事會會議,每季度一次。每次 董事會會議通知會於至少14天前發給全體董事,而會議 議程會於各董事會會議日期至少7天前發給全體董事。

本行之組織章程細則規定,就任何合約或安排而言,倘董事或董事之聯繫人士於其擁有重大權益,則該董事無權投票或計為法定人數。

每次董事會會議之記錄會於下次董事會會議確認前交由 全體董事傳閱及提出意見。董事會會議之記錄會交由公 司秘書保存並供董事查閱。

董事於確保遵守董事會程序及所有適用規則及條例上, 可取得公司秘書的意見及服務。

## **Board Responsibilities**

In meeting its overall responsibilities to the shareholders, depositors, creditors, employees and other stakeholders, the Board has to ensure that there is a competent executive management capable of running the Bank in a sound, efficient and profitable manner.

The responsibilities of the Board include:

- establishing the business objectives of the Bank and approving and reviewing the corresponding business strategies and plans;
- ensuring that the operations of the Bank are conducted prudently within the laws and regulations of the Hong Kong Special Administrative Region and in a manner consistent with the policies of its holding company;
- establishing, approving and reviewing risk management strategies and framework of the Bank to ensure that the various types of risk inherent with the Bank's operations and business are regularly identified, measured, monitored and controlled;
- ensuring that the Bank observes a high standard of integrity in the conduct of its business and adopts best industry practice; and
- overseeing the performance of management to ensure all the above are properly carried out and observed.

## Role of Chairman and Chief Executive Officer ("CEO")

Information on the Chairman, Ming-Hsing (Richard) Tsai, and the CEO, Raymond Wing Hung Lee, may be found in the Corporate Information section of this Annual Report.

There is a clear definition of responsibilities between the Chairman and the CEO with segregation of duties.

The Chairman is a Non-Executive Director and is responsible to lead and effectively run the Board, ensuring that all key and appropriate issues are discussed by the Board in a timely and constructive manner.

The CEO who is an Executive Director appointed by the Board under its authority, is responsible for the overall day to day general management and control of the business and operations of the Bank. The CEO may consult and/or seek guidance from other Directors of the Board when he considers it necessary.

#### 董事會責任

董事會有責任確保行政管理層有能力以合理、有效及可 盈利的方式經營本行,以履行其對股東、存戶、債權 人、僱員及其他相關人士之整體責任。

## 董事會之責任包括:

- 確定本行之業務目標,並批核及檢討相應之業務 策略及計劃(包括年度財政預算);
- 確保本行謹慎營運並以與本行控股公司政策一致 的方式遵守香港特別行政區之法例及法規;
- 制定、批准及審核本行之風險管理策略及架構, 確保定期識別、估量、監察及控制本行營運及業 務上各種內在的風險;
- 一確保本行於進行其業務時遵循高標準誠信準則, 及採用最佳的業界常規;
- 監察管理層的表現以確保上述各點得以正確地執 行及遵守。

## 主席及行政總裁的角色

本年報「公司資料」一節載有主席蔡明興與行政總裁李永 鴻之詳細資料。

主席與行政總裁之間的職能有明確的分工。

主席為非執行董事及負責領導及有效率地管理董事會, 並確保所有重大及需要處理的事務得以有效及有建設性 地進行商議。

行政總裁為執行董事由董事會在其權力下委任負責日常 管理及控制本行之業務營運。行政總裁可於必要時向其 他董事或董事會進行諮詢及/或尋求指引。

## **Appointment and Re-election of Directors**

The appointment of new Directors will be considered and approved by the full Board or Shareholder in accordance with the Articles of Association of the Bank. Approval from the HKMA will also be obtained in accordance with the Banking Ordinance.

All Directors are subject to retirement by rotation and re-election at the annual general meeting in accordance with the Articles of Association of the Bank.

The directors appointed by the Board during the year shall hold office only until the next annual general meeting and shall then be eligible for re-election.

#### **BOARD LEVEL COMMITTEES**

The Board has established five Board level committees to assist it in carrying out its responsibilities – Nomination and Remuneration Committee, Audit Committee, Risk Committee. Executive Committee and Executive Credit Committee.

## **Nomination and Remuneration Committee**

The Nomination and Remuneration Committee comprises the Non-Executive Chairman, Non-Executive Vice Chairman and three Independent Non-Executive Directors of the Bank. The Committee meets periodically and as necessary and provides oversight of the management of the Bank's human resources including the appointment of directors and the CEO. The Committee has to establish the Bank's overall human resources management framework to ensure that the Bank is in compliance with the applicable government regulations and follows the market best practice wherever feasible. The Committee is also responsible to ensure that directors and the CEO appointed possess the necessary and appropriate qualifications to perform and discharge their duties.

The Committee regularly reviews whether each existing Director continues to remain qualified for his post. It also reviews the structure, size and composition of the Board and makes recommendations on any proposed change to the Board.

The Committee reviews and approves the remuneration for Directors, members of board-level committees and Senior Management (as defined under the Remuneration Policy of the Bank).

## **Audit Committee**

The Audit Committee comprises three members including one Non-Executive Director and two Independent Non-Executive Directors. The Audit Committee is chaired by an Independent Non-Executive Director who has appropriate accounting professional qualifications. The committee meets at least four times a year and additionally when deemed necessary.

The Audit Committee is required to ensure that there is adequate supervision of the Bank's financial reporting processes and systems of internal control, and that the internal audit function is effective and backed by adequate resources and has appropriate standing within the Bank. It is also required to ensure that there is coordination between the internal and external auditors to monitor compliance with internal policies, statutory regulation, and to consider recommendations made by the internal and external auditors

#### 委任及重選董事

根據本行組織章程細則,新董事之委任將由全體董事會 成員或股東審核及批准。並根據《銀行業條例》,須獲得 金管局之審批。

根據本行之組織章程細則,所有董事均需於股東週年常 會上輪值告退及膺選連任。

董事會於年度內所委任之董事只任職至下屆股東週年常 會,並於其時有資格再度膺選連任。

#### 董事會轄下的委員會

董事會已成立了五個董事委員會以協助行使其職責一提 名及薪酬委員會、審核委員會、風險委員會、執行委員 會及執行信貸委員會。

#### 提名及薪酬委員會

提名及薪酬委員會由本行的非執行主席、非執行副主席 及3名獨立非執行董事組成。該委員會按需要定期舉行 會議,以及監查本行人力資源管理,包括委任董事及行 政總裁。該委員會亦設立本行的整體人力資源管理框架 以確保本行遵守政府相關規定及在任何可能情況下遵循 市場最佳慣例。該委員會亦負責確保獲委任董事及行政 總裁擁有必要及適當的資格以履行彼等的職責。

該委員會定期審查是否每位現任董事繼續符合資格擔任 其職務。其亦審查董事會結構、規模及組成並向董事會 推薦任何建議變動。

該委員會審閱及批准董事、董事會轄下的委員會及高級 管理層成員的薪酬(定義見本行薪酬政策)。

## 審核委員會

審核委員會由3名成員組成,包括1名非執行董事及2名 獨立非執行董事。審核委員會由擁有適當會計專業資格 之獨立非執行董事擔任主席。該委員會每年最少舉行四次會議,並在有需要時舉行特別會議。

審核委員會須確保對本行之財務申報程序及內部監控制度進行足夠之監管,使內部審核職能可在有效及充足資源下在本行內訂立適當地位。並確保內部及外聘核數師互相協調,以監控遵守內部政策、法規及考慮其提出之建議。

During the financial year, the Audit Committee has to review the Bank's financial reporting process, the systems of internal control, the internal audit function and the risk management process. In particular, the review undertaken by the Audit Committee on the internal audit function should include the Internal Audit Charter and its approval, the annual audit plan, internal audit reports and special investigation reports issued, and ensure that appropriate management actions are taken following the major audit findings.

The Audit Committee also has to review the appointment of external auditors and to discuss with them the nature and scope of their audits. The Audit Committee will also review the interim and annual financial statements before recommending them to the Board for approval.

#### **Risk Committee**

The Risk Committee comprises five members including two Non-Executive Directors, two Independent Non-Executive Directors and the CEO. The Committee meets at least four times a year and additionally when deemed necessary. Its mandate is to establish the Bank's overall risk appetite and risk management framework, and to oversee Senior Management's implementation of the Bank's risk policies.

The Risk Committee will review annually the Bank's risk appetite statement and risk management strategy. It will ensure that an appropriate infrastructure, adequate resources and systems are in place for risk identification, risk assessment, risk monitoring and overall risk management. It is also required to provide oversight of the Bank's risk activities and ensure it is in compliance with all relevant legal and regulatory requirements and that the best practices are adopted by the Bank wherever feasible.

The Risk Committee is required to ensure that the staff responsible for implementing risk management systems and controls perform their duties independent of those involved in the Bank's risk taking activities.

## **Executive Committee**

The Executive Committee comprises the Non-Executive Chairman, Non-Executive Vice Chairman and the CEO of the Bank. It will exercise the powers and authorities delegated by the Board from time to time concerning the management and day-to-day running of the Bank. The Executive Committee will meet periodically and as required and will oversee the general management function of the Bank under the auspices of the Board.

## **Executive Credit Committee**

The Executive Credit Committee comprises the Non-Executive Chairman, Non-Executive Vice Chairman and the CEO of the Bank. It has the delegated authority to approve credit proposals, credit policies, credit risk profile and other credit related matters which require the approval of the Board. The Executive Credit Committee will meet as required.

於本財政年度內,審核委員會須檢討本行之財務報告程序、內部監控系統、內部審核職能及風險管理程序。尤其是,在內部審核職能的檢討工作方面,該委員會的審核範圍包括內部審核規章及其批准、年度審核方案、已發佈之內部審核報告及特別調查報告,確保管理層對調查所發現之主要問題作出適當之補救行動。

審核委員會亦須對外聘核數師之委任進行檢討,並與其 就審計之性質及範圍進行討論。審核委員會亦將於向董 事會建議批准中期及年度財務報告之前審閱有關報告。

## 風險委員會

風險委員會由5名成員組成,包括2名非執行董事、兩名獨立非執行董事及行政總裁。該委員會每年舉行四次會議並於必要時舉行額外會議。其職能是建立本行的整體風險承受能力及風險管理框架,以及監管高級管理層實施本行的風險政策。

風險委員會將每年審查本行的風險承受能力聲明及風險 管理策略。其將確保針對風險識別、風險評估、風險監 管及整體風險管理的適當基礎設施、充足資源及系統均 就緒。其亦須監查本行的風險活動及確保遵守所有有關 法律及監管規定以及本行於可行情況下採納最佳慣例。

風險委員會須確保負責實施風險管理系統及控制的員工 於履行彼等的職責時獨立於涉及本行風險活動的員工。

## 執行委員會

執行委員會包括非執行主席、非執行副主席及本行行政 總裁,將行使由董事會不時委託的有關本行管理及日常 營運之權力及職權。執行委員會會定期及於有須要時舉 行會議,並於董事會的支持下監察本行的管理。

## 執行信貸委員會

執行信貸委員會由本行非執行主席、非執行副主席及行 政總裁組成。其獲授權批核須獲董事會批准的信貸建 議,信貸政策,信貸風險及其他信貸相關事項。執行信 貸委員會於需要時召開會議。

#### **KEY MANAGEMENT LEVEL COMMITTEES**

In addition to the Board level committees, five management level committees have been set up by the Board to oversee the effectiveness of the Bank's daily operations – Management Committee, Asset and Liability Committee, Internal Control and Compliance Committee, Credit Committee and Wholesale Credit Committee.

## **Management Committee**

The Management Committee is chaired by the Bank's CEO, and comprises senior management personnel as appointed by the CEO. The Management Committee is the key decision making body for the Bank and is responsible mainly for the running of the Bank's day to day business under the authority delegated by the Board and within the strategy and business plan as approved by the Board. This Committee is also responsible for the formulation of the Bank's business strategies and major bank-wide initiatives for the Board's approval. The Management Committee meets at least once a month to evaluate and approve new business proposals, coordinate among business and support units during the implementation process, monitor the implementation of the approved business strategies and bank-wide initiatives, review the achievement of business targets and objectives and the financial performance of the Bank.

#### **Asset and Liability Committee**

The Asset and Liability Committee ("ALCO") comprises the Bank's CEO, Chief Financial Officer and senior management personnel as appointed by the CEO. It is responsible for providing oversight of the Bank's operations relating to interest rate risk, market risk and liquidity risk (collectively known as "financial risks") as well as capital management. The ALCO initiates, reviews and endorses for the Risk Committee of the Board's approval the Bank's policies on financial risks and capital management. It reviews and approves guidelines relating to such policies and all major financial risk management reports. The ALCO also oversees the Bank's investment activities by establishing investment strategies within policies laid down by the Board and reviews actual performance.

## **Internal Control and Compliance Committee**

The Internal Control and Compliance Committee ("ICC") comprises the Bank's CEO, Chief Financial Officer, Head of Control and Risk Management and heads of different control, business and support functions. The responsibilities of the Committee include providing oversight of the Bank's exposure to operational and legal risks, overseeing the Bank's compliance and anti-money laundering ("AML") activities, ensuring the Bank has in place an effective internal control and compliance framework, assisting the Risk Committee in establishing a sound internal control and monitoring system to ensure overall compliance within the Bank.

## 主要管理層轄下的委員會

除董事會轄下的委員會外,董事會亦設立五個管理層委員會監控本行日常營運的效率一管理委員會、資產負債委員會、內部監控及合規委員會、信貸委員會及批發信貸委員會。

#### 管理委員會

管理委員會由本行的行政總裁擔任主席及由行政總裁所 委任的相關高級管理人員組成。管理委員會乃本行重要 的決策組織,主要在董事會授權下負責銀行的日常運 作,以確保切合董事會批核的策略和業務計劃。該委員 會亦負責制定本行的業務策略及主要本行措施以供董事 會批核。管理委員會至少每月舉行一次會議,評估及批 准新業務計劃並在業務策略的推行過程中協調業務及後 勤部門的工作,監察已批准業務策略及全銀行層面措施 的實施進度,檢討是否達到本行業務目標及宗旨及財務 表現。

#### 資產負債委員會

資產負債委員會由本行的行政總裁、財務總監及行政總裁所委任的高級管理人員組成。該委員會負責監查本行營運上有關利率風險、市場風險及流動資金風險(總稱為「財務風險」)以及資本管理。該委員會啓動、審閱及批准本行財務風險及資本管理政策,以供董事會風險委員會批准。其批准有關該等政策的指引,審閱及批准所有重大財務風險及管理報告。資產負債委員會亦透過在董事會規定的政策範圍內設立投資策略監查本行的投資活動以及檢討實際表現。

## 內部監控及合規委員會

內部監控及合規委員會包括本行的行政總裁、財務總 監、監控及風險管理部主管以及不同業務及後勤部門的 主管。委員會的職能包括監督本行面對之營運及法律風 險,審查本行合規及反洗錢活動,確保本行推行有效之 內部監控及合規架構,以及協助風險委員會建立一套完 善善的內部控管和監察制度,以確保銀行內全面的遵守。 To ensure an effective internal control and compliance framework is in place, the ICC reviews policies and approves guidelines relating to control and compliance risks, receives and discusses reports submitted by various risk management units and promotes internal control and compliance culture. To maintain the Bank's overall compliance standards, the ICC reviews and discusses major compliance or AML or operational risk events, latest developments in statutory or regulatory requirements applicable to bank, progress of implementation of new statutory or regulatory compliance requirements and progress of rectification of audit findings.

為確保推行有效的內部監控及合規架構,內部監控及合規委員會有責任審查與監控及合規風險有關的政策及指引,省覽及討論各風險管理單位提交的報告以及推動內部監控及合規文化。為了維持銀行整體合規標準,內部監控及合規委員會會審查及討論重大合規或反洗錢或操作風險事件、適用於本行之法定或監管規定之最新進展、實施遵從法定或監管規定要求及改正審計發現之進展進行。

## **Credit Committee**

The Credit Committee ("CC") meets weekly and as required, and its mandate is to provide oversight of the Bank's credit risk management. The CC is chaired by the Bank's CEO, and consists of senior executives of the Bank, all are members of the Management Committee.

The CC reviews and endorses credit policies and credit risk profile of the Bank for the Executive Credit Committee's approval, and reviews and approves credit related guidelines. The CC also reviews and approves requests for customer credit facilities that are within the CC's authority as delegated by the Board, and reviews and endorses requests for customer credit facilities before their submission to the Executive Credit Committee for approval.

The CC also conducts on-going reviews on the market environment and makes necessary policy recommendations to the Executive Credit Committee to ensure the credit risk profile of the Bank is within the established risk appetite. In this regard, the CC also provides periodic and timely credit related management and stress testing reports to the Executive Credit Committee.

## **Wholesale Credit Committee**

The Wholesale Credit Committee is chaired by the Head of Control and Risk Management Division of the Bank, and comprises senior officers of the Bank. It meets weekly to review and approve request for corporate and commercial credit facilities that are within its authority as delegated by the Board.

## **RISK MANAGEMENT**

The Risk Committee, a board level committee, establishes overall risk appetite and risk management strategy of the Bank, taking into account current and forward-looking aspects of risk exposure.

The Bank has established a set of risk management policies and guidelines to identify, measure and monitor various types of risks, including credit, market, interest rate, liquidity, operational, reputation, legal and strategic risk. Various risk limits are set in accordance with the defined risk appetite, and a proper risk management system is in place, so as to ensure the degree of risk that the Bank is exposed to is kept within an acceptable level. Risk management policies and major risk limits are approved by the Board as advised by the Risk Committee, and are reviewed regularly by the Risk Committee.

## 信貸委員會

信貸委員會每周及於有須要時會晤,其授權為監察本行的信貸風險管理。信貸委員會由本行行政總裁擔任主席,由本行高級行政人員組成,且均為管理委員會的成員。

信貸委員會審閱及批准本行信貸政策及信貸風險狀況, 以供執行信貸委員會批准,以及審閱及批准信貸相關指 引。信貸委員會亦在董事會授權內批核客戶信貸融資申 請,或審閱及提呈信貸執行委員會批核。

信貸委員會亦就市場環境作出持續審查及向執行信貸委員會提出所須政策建議,以確保本行信貸風險維持於既 定風險取向能力之內。信貸委員會亦定期及適時地向執 行信貸委員會提供信貸相關管理及壓力測試報告。

## 批發信貸委員會

批發信貸委員會由本行監控及風險管理部門主管任主席,由本行的高級行政人員組成。該委員會每週舉行會 議以在董事會授予之授權範圍內審閱及批核企業及商業 金融客戶信貸融資申請。

## 風險管理

風險委員會為董事會轄下委員會·經考慮風險的當期及 前瞻方面·設定本行全面風險承受能力及風險管理策略。

本行已制定一系列風險管理政策及指引以識別、計量及 監管各類風險,包括信貸、市場、利率、流動資金、經 營、聲譽、法律及策略風險。各類風險根據界定風險承 受能力而設立限制,且合適風險管理系統已予制定,以 保證本行面臨的風險等級控制在可接受水平。風險管理 政策及主要風險限制經風險委員會建議並由董事會批 准,並由風險委員會定期檢討。 Regular risk management reports are submitted to the Risk Committee for assessing the level of risk involved in the Bank's business, and how they are controlled and managed. The Risk Committee monitors the risk profile of the Bank against the approved risk limits, and determines appropriate management action if material deviations from approved limits occur. Risk Committee also assesses the effectiveness of the risk management function of the Bank and ensures that it has the necessary resources and expertise to carry out its duties.

Specific product committee comprising senior executives from risk management, legal, compliance and financial control is responsible for risk assessment for new products and services, from both the Bank's and customer's perspective, as well as compliance with regulatory requirements before launch.

## **CODE OF CONDUCT**

Consistent with the policies and practices of its parent company, the Bank adopts a high standard of ethical conduct and professional competence and has set up a Code of Conduct guideline ("Code") which all levels of staff are required to observe in the discharge of their duties. The Board will review the Code annually and will ensure that the Bank has adequate systems to enforce it.

The Code is structured in line with applicable regulatory guidelines and other industry best practices, setting out professional standards and corporate values to promote ethical, professional and responsible behavior among the Bank's staff. It also articulates unacceptable behaviour and unethical or illegal activities that could result in the Bank infringing guidelines, regulations or laws which the Bank is required to observe and comply with in conducting its business. Contents of the Code include but are not limited to the prevention of bribery, use of information, insider dealing and personal investment dealing, personal benefits, and outside directorship and employment.

Among other things, procedures are set up for staff to communicate, in confidence, material and bona fide concerns or observations of any violations. Communication is also allowed to be channelled to the Board through a "CEO Channel" which is independent of internal chain of command.

## **ANTI-MONEY LAUNDERING**

The Bank has in place stringent internal guidelines and procedures in combating money laundering and drug trafficking, and fighting against terrorist financing. All staff members are required to comply with such guidelines and procedures in the process of conducting customer due diligence and to ensure that prevention of money laundering policies, procedures, and controls are properly and diligently implemented. With the support of the Board, management actively promotes a strong anti-money laundering culture to ensure proper compliance with all necessary laws and regulations.

## **INTERNAL CONTROLS**

The Board is responsible for the Bank's system of internal control and for reviewing its effectiveness.

The Bank's internal control systems comprise a number of measures designed to provide effective governance and risk management, reliable and timely reporting of financial and management information, and compliance with relevant laws and regulations, supervisory guidelines, market codes and standards, as well as internal policies and procedures.

  procedures provides specific operational, financial and compliance controls
  which will facilitate segregation of duties, accuracy of reporting and proper
  control over assets and risk exposure.
- Risk management policies and procedures in place to identify and manage risks associated with the Bank's business and operations.
- Risk management reports being submitted regularly to the respective committees assigned for monitoring and assessment of risks associated with the Bank's business and operations.
- 6. Compliance Department of the Bank monitoring changes and developments of relevant laws, regulations and standards applicable to the Bank's activities and ensuring that senior management and relevant units are duly aware of the changes and in a position to take appropriate measures to ensure continued compliance.
- 7. Compliance reviews being conducted by business and functional units on an on-going basis to ensure compliance with applicable laws and regulations, standards, guidelines and codes of practices.

The internal audit function of the Bank is an independent appraisal function set up with the primary objective of evaluating the internal control system and compliance to laws, regulatory guidelines and internal control policies, and to report major findings to the Board's Audit Committee for action. The Chief Internal Auditor is appointed by the Audit Committee. The Internal Audit Division is also responsible for assisting senior management in the effective discharge of their responsibilities as managers of the Bank.. It will conduct a risk-based independent review on the effectiveness of the Bank's internal control system and provide recommendations, if appropriate, to improve the control environment.

## Notes to the Financial Statements 財務報告附註

## 1. ACTIVITIES

Fubon Bank (Hong Kong) Limited ("The Bank") is a licensed bank incorporated and domiciled in Hong Kong and has its registered office at 38 Des Voeux Road Central, Hong Kong.

The Bank, through its branches and subsidiaries, provides a range of banking, financial and related services.

## 2. SIGNIFICANT ACCOUNTING POLICIES

The consolidated financial statements for the year ended 31 December 2014 comprise the Bank and its subsidiaries (together referred to as the "Group") and the Group's interests in associates.

## (a) Statement of compliance

These financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("HKFRSs"), which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretations issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and accounting principles generally accepted in Hong Kong. These financial statements also comply with the applicable requirements of the Hong Kong Companies Ordinance, which for this financial year and the comparative period continue to be those of the predecessor Hong Kong Companies Ordinance (Cap. 32), in accordance with transitional and saving arrangements for Part 9 of the new Hong Kong Companies Ordinance (Cap. 622), "Accounts and Audit", which are set out in sections 76 to 87 of Schedule 11 to that Ordinance. A summary of the significant accounting policies adopted by the Group is set out below.

#### (b) New and revised HKFRSs

The HKICPA has issued several amendments to HKFRSs that are first effective for the current accounting period or available for early adoption of the Group and the Bank. Of these, the following developments are relevant to the Group's financial statements:

- Amendments to HKFRS 10, HKFRS 12 and HKAS 27, Investment entities
- Amendments to HKAS 32, Offsetting financial assets and financial liabilities
- Amendments to HKAS 36, Recoverable amount disclosures for non-financial assets
- Amendments to HKAS 39, Novation of derivatives and continuation of hedge accounting
- HK(IFRIC) 21, Levies

The Group has not applied any new standard or interpretation that is not yet effective for the current accounting period. Impacts of the adoption of other new or amended HKFRSs are discussed below:

## 1. 業務

富邦銀行(香港)有限公司(「本行」)為一間於香港註冊成立並以香港為本籍的持牌銀行,其註冊辦事處位於香港中環德輔道中三十八號。

本行透過其分行及附屬公司提供一系列銀行、 金融及相關服務。

## 2. 主要會計政策

截至二零一四年十二月三十一日止年度之綜合財務報告,包括本行及其附屬公司(合稱為「本集團」)及本集團於聯營公司之權益之財務報告。

#### (a) 遵守聲明

此等財務報告乃根據香港會計師公會頒佈的一切適用《香港財務報告準則》,該統稱包括一切適用的個別香港財務報告準則、《香港會計準則》及詮譯、香港報報與。此等財務報告與所符合香港《公司條例》的適用規定。於新香港《公司條例》(第622章)附表11第76至87條有關條例第9部「賬日度」及其比較期間適用的規定仍為第32章前身香港《公司條例》之規定。本集團所採納的主要會計政策概要載於下文。

#### (b) 新訂及經修訂香港財務報告準則

香港會計師公會已頒佈若干香港財務 報告準則之修訂,於本期會計期間首次 生效或可供本集團及本行提早採納。當 中,以下變動與本集團財務報告有關:

- 香港財務報告準則第10號、香港財務報告準則第12號及香港會計準則第27號,投資實體之修訂
- 一 香港會計準則第32號,抵銷金融資 產與金融負債之修訂
- 一 香港會計準則第36號,非金融資產 可收回金額之披露之修訂
- 一 香港會計準則第39號,衍生工具之 更替及對沖會計法之延續之修訂
- 一 香港(國際財務報告詮釋委員會)第 21號,徵費

本集團並無應用任何於本會計期間尚未 生效之新訂準則或詮釋。採納其他新訂 或經修訂財務報告準則的影響討論如下:

#### (b) New and revised HKFRSs (continued)

Amendments to HKFRS 10, HKFRS 12 and HKAS 27, Investment entities

The amendments provide consolidation relief to those parents which qualify to be an investment entity as defined in the amended HKFRS 10. Investment entities are required to measure their subsidiaries at fair value through profit or loss. These amendments do not have an impact on these financial statements as the Bank is not an investment entity.

Amendments to HKAS 32, Offsetting financial assets and financial liabilities

The amendments to HKAS 32 clarify the offsetting criteria in HKAS 32. The amendments do not have an impact on these financial statements as they are consistent with the policies already adopted by the Group.

Amendments to HKAS 36, Recoverable amount disclosures for nonfinancial assets

The amendments to HKAS 36 modify the disclosure requirements for impaired non-financial assets. Among them, the amendments expand the disclosures required for an impaired asset or CGU whose recoverable amount is based on fair value less costs of disposal. These amendments do not have an impact on these financial statements.

Amendments to HKAS 39, Novation of derivatives and continuation of hedge accounting

The amendments to HKAS 39 provide relief from discontinuing hedge accounting when novation of a derivative designated as a hedging instrument meets certain criteria. The amendments do not have an impact on these financial statements as the Group has not novated any of its derivatives.

## HK(IFRIC) 21, Levies

The Interpretation provides guidance on when a liability to pay a levy imposed by a government should be recognised. The amendments do not have an impact on these financial statements as the guidance is consistent with the Group's existing accounting policies.

## (c) Basis of preparation of the financial statements

The measurement basis used in the preparation of the financial statements is the historical cost basis except that the following assets and liabilities are stated at their fair value as explained in the accounting policies set out below:

- financial instruments classified as trading, designated at fair value through profit or loss and available-for-sale (see Note 2(g));
- derivative financial instruments (see Note 2(g)); and
- owned properties (see Note 2(j)).

## 2. 主要會計政策(續)

## (b) 新訂及經修訂香港財務報告準則(續)

香港財務報告準則第10號、香港財務報告準則第12號及香港會計準則第27號,投資實體之修訂

有關修訂對符合資格為經修訂香港財務報告準則第10號所定義的投資實體的母公司,免除其綜合入賬的要求。投資實體須透過損益按公平價值計量其附屬公司。由於本行並非投資實體,故有關修訂對此等財務報告並無影響。

香港會計準則第32號,抵銷金融資產與 金融負債之修訂

香港會計準則第32號之修訂釐清香港會計準則第32號的抵銷標準。由於有關修訂與本集團已採用的政策一致,故其對此等財務報告並無影響。

香港會計準則第36號,非金融資產可收回金額之披露之修訂

香港會計準則第36號之修訂更改了非金融資產減值的披露規定。其中,有關修訂擴大對根據公平價值減出售成本計算可收回金額的減值資產或現金產生單元的披露規定。有關修訂對此等財務報告並無影響。

香港會計準則第39號,衍生工具之更替 及對沖會計法之延續之修訂

於一項指定為對沖工具的衍生工具的更替達到若干標準時,香港會計準則第39號之修訂為終止使用對沖會計法提供緩衝。由於本集團並無更替其任何衍生工具,故有關修訂對此等財務報告並無影響。

香港(國際財務報告詮釋委員會)第21號, 微毒

該詮釋就支付政府徵費的負債的確認時間作出指引。由於指引與本集團現有的會計政策一致,故有關修訂對此等財務報告並無影響。

## (c) 財務報告的編製基準

編製財務報告所採用的計算基準為歷史 成本法,但下列以公平價值列賬的資產 及負債(如下文的會計政策所闡釋)除外:

- 一 分類為交易用途、指定通過損益以 反映公平價值及可供出售之金融工 具(見附註2(g)):
- 一 衍生金融工具(見附註2(g));及
- 若干本集團擁有之物業(見附註 2(j))。

## (c) Basis of preparation of the financial statements (continued)

In addition, the carrying amounts of assets and liabilities carried at amortised cost that are designated as hedged items in a fair value hedge are adjusted for fair value changes attributable to the hedged risk.

Non-current assets and disposal groups held for sale are stated at the lower of carrying amount and fair value less costs to sell (see Note 2(k)).

The preparation of financial statements in conformity with HKFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets and liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Judgments made by management in the application of HKFRSs that have a significant effect on the financial statements and major sources of estimation uncertainty are discussed in Note 51.

## (d) Investments in subsidiaries and non-controlling interests

Subsidiaries are entities controlled by the Group. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power, only substantive rights (held by the Group and other parties) are considered.

An investment in a subsidiary is consolidated into the consolidated financial statements from the date that control commences until the date that control ceases.

Intra-group balances and transactions, and any unrealised profits arising from intra-group transactions, are eliminated in full in preparing the consolidated financial statements. Unrealised losses resulting from intra-group transactions are eliminated in the same way as unrealised gains, but only to the extent that there is no evidence of impairment.

非流動資產及持作出售的出售組別按賬面價值與公平價值之較低者減出售成本列賬(附註2(k))。

編製此等符合香港財務報告準則之財務報告需要管理層作出判斷、估計及假設會情、估計及假設會情、協立應用及所申報之資產及負債假政入及開支等數額。該等估計及存關假假政入及開支等數額及管理層相信於該等情况,所得過合理之各項其他因素為從其出的資產及負債賬面值所作估計數等。實際數字或會有別於此等估計數字。

本集團持續就所作估計及相關假設作出 評估。會計估計之變動如只影響當期, 則有關影響於估計變動之當期確認。如 該項會計估計之變動影響當期及以後期 間,則有關影響於當期及以後期間確認。

管理層應用對財務報告及估計不確定因素之主要來源構成重大影響的香港財務報告準則所作出之判斷於附註51中詳述。

## (d) 附屬公司投資及非控股權益

附屬公司為本集團控制之實體。當本集團因參與實體業務而對浮動回報承擔風險或享有權利,以及能運用權力影響該等回報金額時,本集團即具有該實體之控制權。在評估本集團是否擁有權力時,只會考慮實質權利(由本集團及其他人士持有者)。

自控制開始日期直至控制結束日期,於 附屬公司之投資會併入綜合財務報告內。

集團公司內部間的結餘及交易,以及集團公司內部間交易所產生的任何未變現溢利,均於編製綜合財務報告時悉數抵銷。集團公司內部間交易所產生的未變現虧損與未變現溢利以相同方式抵銷,惟僅限於無證據顯示已出現減值的情況。

## (d) Investments in subsidiaries and non-controlling interests (continued)

Non-controlling interests represent the equity in a subsidiary not attributable directly or indirectly to the Bank, and in respect of which the Group has not agreed any additional terms with the holders of those interests which would result in the Group as a whole having a contractual obligation in respect of those interests that meets the definition of a financial liability. The Group measures non-controlling interests at their proportionate share of the subsidiary's net identifiable assets. Non-controlling interests are presented in the consolidated balance sheet separately from equity attributable to the equity shareholders of the Bank. Non-controlling interests in the results of the Group are presented on the face of the consolidated statement of comprehensive income as an allocation of the total profit or loss and total comprehensive income for the year between non-controlling interests and the equity shareholders of the Bank.

In the Bank's balance sheet, its investments in subsidiaries are stated at cost less impairment losses, if any (see Note 2(n)).

#### (e) Interests in associates

An associate is an entity in which the Group or the Bank has significant influence, but not control or joint control, over its management, including participation in the financial and operating policy decisions.

The investment in an associate in the Philippines is not equity accounted for in the consolidated financial statements as it is considered by the directors to be immaterial to the Group. It is stated at cost less impairment losses in the Group's and the Bank's balance sheet. The result of this associated company is included in the Group's and the Bank's profit or loss to the extent of dividends receivable.

The investment in an associate in the People's Republic of China ("PRC") is accounted for in the consolidated financial statements under the equity method. It is initially recorded at cost, adjusted for any excess of the Group's share of the acquisition-date fair values of the investee's net identifiable assets over the cost of the investment (if any). Thereafter, the investment is adjusted for the post-acquisition change in the Group's share of the associate's net assets and any impairment loss relating to the investment, if any (see Notes 2(n)). The Group's share of the post-acquisition, post-tax results of the associate and any impairment losses for the year are recognised in profit or loss. The Group's share of the post-acquisition, post tax items of the associate's other comprehensive income is recognised in the Group's other comprehensive income.

If the Group's share of losses exceeds its interest in the associate, the Group's interest would be reduced to nil and recognition of further losses is discontinued except to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the associate. The Group's interest in the associate is the carrying amount of the investment under the equity method.

非控股權益指非由本行(不論是直接間接)應佔附屬公司的權益,而本集團未集團未達成任何附加條款,合金達之業的養務。本集團整體上對該等權益產生與以金等體上對該等權益產與與一個人。 在於國公司可識別資產淨值的資產一個人。 對於國公司可識別資產淨值的資產,但與本行股東企份權益。 對於國公司可說別資產淨值的資產,但與本行股東之份權益與 是列。本集團業績內呈列的非控股權益與 是列。本集團業績內到作非控股權益與 在綜合全面收益表內列作非控額及 本行股東之間就本年度損益總額及分配。

於本行之資產負債表中,其於附屬公司 的投資乃按成本值減去減值虧損(如有) 列賬(見附註2(n))。

#### (e) 於聯營公司之權益

聯營公司為本集團或本行可對其管理(包括參與其財政及營運政策的決定)有重大 影響力(惟並非控制或聯合控制)之實體。

由於董事認為於菲律賓之聯營公司的投 資對本集團的影響並不重大,故並無以 權益法計入綜合財務報告,而於本集團 及本行之資產負債表中按成本值扣除減 值虧損列賬。該聯營公司之業績以應收 的股息於本集團及本行的損益賬中列賬。

若本集團應佔的虧損超過其於該聯營公司的權益,則本集團的權益會撇減至零;除非本集團已產生法定或推定責任或代該聯營公司作出付款,否則不會繼續確認進一步虧損。本集團於聯營公司的權益,是按照權益法計算投資的賬面值。

#### (e) Interests in associates (continued)

Unrealised profits and losses resulting from transactions between the Group and its associates are eliminated to the extent of the Group's interest in the associate, except where unrealised losses provide evidence of an impairment of the asset transferred, in which case they are recognised immediately in profit or loss.

In the Bank's balance sheet, its investments in both associates are stated at cost less impairment losses, if any (see Note 2(n)).

## (f) Goodwill

Goodwill represents the excess of

- the aggregate of the fair value of the consideration transferred, the amount of any non-controlling interest in the acquiree and the fair value of the Group's previously held equity interest in the acquiree; over
- (ii) the net fair value of the acquiree's identifiable assets and liabilities measured as at the acquisition date.

When (ii) is greater than (i), then this excess is recognised immediately in profit or loss as a gain on a bargain purchase.

Goodwill is stated at cost less accumulated impairment losses. Goodwill arising on a business combination is allocated to each cash-generating unit, or groups of cash generating units, that is expected to benefit from the synergies of the combination and is tested annually for impairment (see Note 2(n)). In respect of associates, the carrying amount of goodwill is included in the carrying amount of the interest in associates and the investment as a whole is tested for impairment whenever there is objective evidence of impairment (see Note 2(n)).

On disposal of a cash generating unit during the year, any attributable amount of purchased goodwill is included in the calculation of the profit or loss on disposal.

## (g) Financial instruments

## (i) Initial recognition

The Group classifies its financial instruments into different categories at inception, depending on the purpose for which the assets were acquired or the liabilities were incurred. The categories are: fair value through profit or loss, loans and receivables, held-to-maturity investments, available-for-sale financial assets and other financial liabilities.

Financial instruments are measured initially at fair value, which normally will be equal to the transaction price, plus in case of a financial asset or financial liability not held at fair value through profit or loss, transaction costs that are directly attributable to the acquisition of the financial asset or issue of financial liability. Transaction costs on financial assets and financial liabilities designated at fair value through profit or loss are expensed immediately.

本行資產負債表所表示於兩間聯營公司 的投資,是按成本減去減值虧損(倘有) 後入賬(見附註2(n))。

#### (f) 商譽

商譽指:

- (i) 已轉移代價之公平價值、佔被收購 方之非控股權益金額及本集團早前 所持被收購方股權之公平價值三者 之總金額:超出
- (ii) 於收購日期計算所得被收購方之可 辨別資產及負債之公平淨值。

如(ii)大於(i),則超出之數即時在損益表確認入賬,作為議價購買之收益。

商譽是按成本減去累計減值虧損後列 賬。因業務合併而產生之商譽,會分配 至預期可受惠於合併協同效應之各個現 金產生單位或各組現金產生單位,並且 每年接受減值測試(見附註2(n))。就聯營 公司而言,商譽之賬面值乃計入聯營公 司權益之賬面值,而投資則於有減值之 客觀證據顯示減值時,接受整體減值測 試(見附註2(n))。

於本年度出售現金產生單位時,所購入商譽應佔的金額均列入出售盈虧計算中。

## (g) 金融工具

## (i) 初始確認

本集團視乎購入資產或產生負債之 目的,最初將金融工具分為以下類 別:通過損益以反映公平價值、貸 款及應收款項、持至到期投資、可 供出售金融資產和其他金融負債。

金融工具最初按公平價值計量,而工具最初按公平價值計量,不可值一般將與交易價相同。於外,如金融資產或金融負債不屬所,如此與損益以反映公平價值的,需再加上購入金融資產或之交易成本。指定為通過損益以反映公平價值的金融資產及金融負債的交易成本,會即時認列費用。

## (i) Initial recognition (continued)

The Group recognises financial assets and financial liabilities on the date it becomes a party to the contractual provisions of the instrument. A regular way purchase or sale of financial assets and financial liabilities at fair value through profit or loss, loans and receivables, held-to-maturity investments or available-for-sale financial assets is recognised using trade date accounting. From these dates, any gains and losses arising from changes in fair value of the financial assets or financial liabilities are recorded.

## (ii) Categorisation

Fair value through profit or loss

This category comprises financial assets and financial liabilities held for trading, and those designated at fair value through profit or loss upon initial recognition.

Trading financial instruments are financial assets or financial liabilities which are acquired or incurred principally for the purpose of trading, or are part of a portfolio of identified financial instruments that are managed together and for which there is evidence of a recent actual pattern of short-term profit-taking. Derivatives that do not qualify for hedge accounting (Note 2(i)) are accounted for as trading instruments.

Financial instruments are designated at fair value through profit or loss upon initial recognition when:

- the assets or liabilities are managed, evaluated and reported internally on a fair value basis;
- the designation eliminates or significantly reduces an accounting mismatch which would otherwise arise;
- the asset or liability contains an embedded derivative that significantly modifies the cash flows that would otherwise be required under the contract; or
- the asset or liability contains an embedded derivative the separation of which from the financial instrument is clearly not prohibited.

Financial assets and liabilities under this category are carried at fair value. Changes in the fair value are included in profit or loss in the period in which they arise. Interest income, interest expense and dividends from instruments in this category are recorded in interest income, interest expense and other operating income respectively. Upon disposal or repurchase, the difference between the net sale proceeds or the net payment and the carrying value is included in profit or loss.

本集團在成為金融工具合約條文部, 約方當日會確認金融資產生生 資。以以反映公平價值度之金融, 資本融負債、資本股份。 金融負債或可供出售之金融, 資本。因期投資會計法予債的。 因期投資會計法予債的的 大產等 金融所產生的任何盈利和虧損由該 起計算。

#### (ii) 分類

通過損益以反映公平價值 此類別包括持作交易用途和初始確 認時被指定為通過損益以反映公平 價值的金融資產及金融負債。

持作交易用途之金融工具是收購金融資產或產生金融負債之主要目的為用作交易用途,或屬於一個整體管理的可識別金融工具組合的一部分,並且有證據顯示有短期內出售以賺取利潤的交易模式意圖。不符合對沖會計法(附註2(i))之衍生工具,亦分類為持作交易用途之工具入賬。

於下列情況下,金融工具於初始確認時被指定為通過損益以反映公平價值:

- 資產或負債以公平價值為基準作為內部管理、評估及匯報;
- 一 有關的指定可消除或大幅減少會計錯配的發生;
- 一資產或負債包含一項嵌入衍生工具,且該衍生工具可大幅改變合約規定的現金流量;或
- 一 資產或負債包含一項嵌入衍生工具,該嵌入衍生工具可以從金融工具分離。

屬於此類別的金融資產和負債按公平價值入賬。公平價值變動計入在發生期內的損益賬。此類別的金融工具所產生的利息收入、利息支出及別別賬於利息收入、利息支出及其他營運收入。於出售或購回時,出售所得淨款項或償付淨額與賬面值的差額計入損益賬。

#### (ii) Categorisation (continued)

#### Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market, other than (a) those that the Group intends to sell immediately or in the near term, which will be classified as held for trading; (b) those that the Group, upon initial recognition, designates at fair value through profit or loss or as available-for-sale; or (c) those where the Group may not recover substantially all of its initial investment, other than because of credit deterioration, which will be classified as available-for-sale. Loans and receivables mainly comprise advances to customers, placements with banks and other financial institutions, and certain debt securities.

Debt securities classified as loans and receivables are not quoted in an active market. Investment decisions for such debt securities are subject to the same credit approval processes as loans, and the Group bears the same customer risk as it does for loans extended to those customers. These debt securities include subordinated debt instruments and senior debt instruments issued by borrowers.

Loans and receivables are carried at amortised cost using the effective interest rate method less impairment losses, if any (see Note 2(n)).

### Held-to-maturity investments

Held-to-maturity investments are non-derivative financial assets with fixed or determinable payments and fixed maturity which the Group has the positive intention and ability to hold to maturity, other than (a) those that the Group, upon initial recognition, designates at fair value through profit or loss or as available-for-sale; and (b) those that meet the definition of loans and receivables.

Held-to-maturity investments are carried at amortised cost using the effective interest rate method less impairment losses, if any (see Note 2(n)).

If, as a result of a change in intention or ability, it is no longer appropriate to classify an investment as held-to-maturity, it is reclassified as available-for-sale and remeasured at fair value.

#### Available-for-sale financial assets

Available-for-sale financial assets are non-derivative financial assets that are either designated as available-for-sale or are not classified in any of the other three categories above. They include financial assets intended to be held for an indefinite period of time, but which may be sold in response to needs for liquidity or changes in the market environment.

#### 貸款及應收款項

分類為貸款及應收款項的債務證券 並無於活躍市場報價。該等債務證券 有關的投資決定與作出貸款的信 貸審批程序相同,本集團須承擔等 同向該等客戶授出貸款的相同款等 同向該等客戶授出貸款的相目款 極。此類債務證券包括由借款 發行的後償債務工具及優先債務工具 目。。

貸款及應收款項採用實際利率方法 減去減值虧損(如有)後按攤餘成本 列賬(見附註2(n))。

### 持至到期投資

持至到期投資包括有固定或可確定付款金額及有固定到期日,且本集團有明確意向和能力持至到期的非衍生金融資產,但不包括(a)本集團於初始確認時指定為通過損益以反映公平價值或可供出售,及(b)符合貸款和應收款項定義之項目。

持至到期投資採用實際利率方法減去減值虧損(如有)後按攤餘成本列 賬(見附註2(n))。

倘因意向或能力改變而不再適宜將 投資分類為持至到期,則須重分類 為可供出售並按公平價值重新計 量。

#### 可供出售金融資產

可供出售金融資產為指定為可供出售,或未分類為上述任何其他三個類別之非衍生金融資產。彼等包括無固定持有限期之金融資產,但亦可因應流動資金之需要或市場環境變化而出售。

Available-for-sale financial assets (continued)

Available-for-sale financial assets are carried at fair value. Unrealised gains and losses arising from changes in the fair value are recognised in other comprehensive income and accumulated separately in equity, except for interest income, impairment losses and foreign exchange gains and losses on monetary items such as debt securities which are recognised in profit or loss. Interest income is recognised using the effective interest rate method.

Investments in equity instruments that do not have a quoted market price in an active market and whose fair value cannot be reliably measured, and derivatives that are linked to and must be settled by delivery of such equity instruments are carried at cost less impairment losses, if any (see Note 2(n)).

When available-for-sale financial assets are sold, gains or losses on disposal comprise the difference between the net sale proceeds and the carrying value, and the accumulated fair value adjustments previously recognised in other comprehensive income.

#### Other financial liabilities

Financial liabilities, other than trading liabilities and those designated at fair value through profit or loss, are measured at amortised cost using the effective interest rate method.

### (iii) Fair value measurement principles

The fair value of financial instruments is ideally based on their quoted market prices at the balance sheet date without any deduction for estimated future selling costs. Financial assets are priced at current bid prices, while financial liabilities are priced at current asking prices.

If there is no publicly available latest traded price nor a quoted market price on a recognised stock exchange, a price from a broker/dealer for non-exchange-traded financial instruments is used. If the market for a financial instrument is not active, the fair value of the instrument is estimated using a valuation technique that provides a reliable estimate of the price which could be obtained in an actual market transaction.

Where discounted cash flow techniques are used, estimated future cash flows are based on management's best estimates and the discount rate used is a market rate at the balance sheet date applicable for an instrument with similar terms and conditions. Where other pricing models are used, inputs are based on market data at the balance sheet date.

#### (iv) Derecognition

A financial asset is derecognised when the contractual rights to receive the cash flows from the financial asset expire, or where the financial asset together with substantially all the risks and rewards of ownership, have been transferred.

可供出售金融資產以公平價值列 賬。因公平價值變動引致之未實現 盈利和虧損確認為其他全面收益 並於權益內單獨累計,惟債務證券 等貨幣項目之利息收入、減值虧損 及外匯盈利和虧損須於損益賬內確 認。利息收入依實際利率法確認。

於活躍市場並無市場報價且公平價值無法可靠計算的股本投資工具, 及與該等股本工具掛鈎以及必須透過交付該等工具進行交付之衍生工具,均按成本減去減值虧損(如有)列賬(見附註2(n))。

當出售可供出售金融資產時,出售 盈利或虧損包括出售所得淨款項與 賬面值的差額,及先前確認於其他 全面收益之累計公平價值調整。

#### 其他金融負債

除交易賬項下負債及該等被指定為 通過損益以反映公平價值之負債 外,其他金融負債採用實際利率方 法計算攤餘成本入賬。

### (iii) 計量公平價值之原則

金融工具的公平價值是於結算日根 據其市場報價但未減除將來的估 計出售成本。金融資產按買入現價 作價,而金融負債則按賣出現價作 價。

如並沒有認可交易所的最新公開成 交價或市場報價,經紀/交易商的 報價會被用作非交易所買賣金融工 具的報價。若金融工具的市場並不 流通,此工具的公平價值按估值模 式計算,而該估值模式可根據市。 實際交易而提供可靠的估計價格。

當採用現金流折算計價模式,需依據管理層對日後現金流量之估計,並採用在結算日具相近條款及條件的工具所適用之市場利率作為折算率。當採用其他計價模式時,輸入資料是依據結算日的市場數據。

## (iv) 終止確認

當收取金融資產現金流量之合約權 利到期時或者該金融資產連同擁有 權之絕大部分風險及回報已被轉移 時,金融資產將被終止確認。

A financial liability is derecognised when the obligation specified in the contract is discharged, cancelled or expires.

#### (v) Offsetting

Financial assets and financial liabilities are offset and the net amount is reported in the balance sheet where there is a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis, or realise the asset and settle the liability simultaneously.

#### (vi) Embedded derivatives

An embedded derivative is a component of a hybrid (combined) instrument that includes both a derivative and a host contract with the effect that some of the cash flows of the combined instrument vary in a way similar to a stand-alone derivative. Embedded derivatives are separated from the host contract and accounted for as a derivative when (i) the economic characteristics and risks of the embedded derivative are not closely related to the economic characteristics and risks of the host contract; and (ii) the hybrid (combined) instrument is not held at fair value through profit or loss.

When the embedded derivative is separated, the host contract is accounted for in accordance with the accounting policies for the relevant financial instrument. The embedded derivative is classified as a derivative financial instrument in the financial statements.

#### (h) Repurchase and reverse repurchase transactions

Securities sold subject to a simultaneous agreement to repurchase these securities at a certain later date at a fixed price (repurchase agreement) are retained in the financial statements and measured in accordance with their original measurement principles. The proceeds from the sale are reported as liabilities and are carried at amortised cost.

Securities purchased under agreements to resell (reverse repurchase agreements) are reported as receivables and are carried at amortised cost.

Interest earned on reverse repurchase agreements and interest incurred on repurchase agreements is recognised as interest income and interest expense respectively, over the life of each agreement using the effective interest rate method.

若存在一項可依法強制執行的權利 可對銷列賬金額,且亦有意以淨額 結算或同時變現資產及償付債務, 則金融資產及金融負債均予對銷, 並把淨金額列入資產負債表內。

#### (vi) 嵌入式衍生工具

當嵌入式衍生工具被分開時,主合約根據相關金融工具之會計政策入賬。嵌入式衍生工具分類為衍生金融工具列入財務報告。

#### (h) 回購交易和反向回購交易

根據同步協議(回購協議)售出以在之後 某特定時間以固定價格回購的證券會保 留在財務報告內並根據該等證券之原來 計量原則計量。出售所得款項乃列作負 債並列入報告及以攤餘成本列賬。

根據轉售協議(反向回購協議)購買之證券乃呈報為應收款項,並按攤銷成本列 賑。

向回購協議所賺取之利息與回購協議產生之利息,分別於各個協議有效期間採用實際利率法確認為利息收入及利息支出。

#### (i) Hedging

Hedge accounting recognises the offsetting effects on profit or loss of changes in the fair values of the hedging instruments and the hedged items. The Group assesses and documents whether the financial instruments that are used in hedging transactions are highly effective in offsetting changes in fair values of hedged items attributable to the hedged risks both at hedge inception and on an ongoing basis. Under HKAS 39 hedge accounting is classified into three categories: (a) fair value hedges; (b) cash flow hedges and (c) net investment hedges. The Group only applies hedge accounting for fair value hedging of certain fixed rate available-for-sale investments.

The Group discontinues prospectively hedge accounting when (a) the hedging instrument expires or is sold, terminated or exercised; (b) the hedge no longer meets the criteria for hedge accounting; or (c) the Group revokes the designation.

## (i) Fair value hedge

A fair value hedge seeks to offset risks of changes in the fair value of recognised assets and liabilities that will give rise to a gain or loss being recognised in profit or loss.

The hedging instruments are measured at fair value, with fair value changes recognised in profit or loss. The carrying amounts of the hedged items are adjusted by the changes in fair value attributable to the risk being hedged. These adjustments are recognised in profit or loss to offset the effect of gains or losses on the hedging instruments.

When a hedging instrument expires or is sold, terminated or exercised, the hedge no longer meets the criteria for hedge accounting or the Group revokes designation of the hedge relationship any adjustment up to that point, to a hedged item for which the effective interest rate method is used, is amortised to profit or loss as part of the recalculated effective interest rate of the item over its remaining life.

## (ii) Hedge effectiveness testing

In order to qualify for hedge accounting, the Group carries out prospective effectiveness testing to demonstrate that it expects the hedge to be highly effective at the inception of the hedge and throughout its life. Actual effectiveness (retrospective effectiveness) is also demonstrated on an ongoing basis.

The documentation of each hedging relationship sets out how the effectiveness of the hedge is assessed. The method which the Group adopts for assessing hedge effectiveness will depend on its risk management strategy.

#### (i) 對沖

倘(a)對沖工具到期或被出售、終止或行使:(b)對沖不再符合對沖會計處理的準則:或(c)本集團撤回指定,本集團便會分別終止對沖會計處理。

#### (i) 公平價值對沖

公平價值對沖目的是為抵銷已確認 資產及負債的公平價值變動之風險 (該等變動將導致須在損益賬內確 認損益)。

對沖工具按公平價值列賬,其公平 價值變動於損益賬內確認。對沖項 目之賬面數額按所對沖之風險所導 致之公平價值變動作出調整。此等 調整在損益賬內確認,以抵銷對沖 工具所產生之損益之影響。

當對沖工具到期或被出售、終止或被行使,對沖不再符合對沖會計法的標準,或本集團撤銷了指定的對沖關係時,截至當時為止對使用實際利率法計算的被對沖項目的任何調整,會在損益賬內攤銷,作為在該項目的剩餘期間重新計算其實際利率的一部分。

## (ii) 對沖有效性測試

為符合對沖會計法,本集團於初始訂立對沖時指定對沖工具,亦於初始訂立對沖時及於其整段年期內進行預計有效性評估測試,以證明該項對沖交易能高度有效地發揮預期對沖功能。本集團亦持續地為對沖之實際有效性進行追溯有效性測試。

每項對沖關係均備有詳細文件載列 該項對沖有效性之評估方法。本集 團就評估對沖的有效性而採用的方 法取決於其風險管理策略。

#### (i) Hedging (continued)

(ii) Hedge effectiveness testing (continued)

The Group utilises both cumulative dollar offset method and regression analysis as the effectiveness testing methodologies for retrospective testing. For prospective effectiveness, the hedging instruments must be expected to be highly effective in achieving offsetting changes in fair value attributable to the hedged risk during the period for which the hedge is designated and is typically demonstrated through matching of critical terms. For actual effectiveness, the hedging instrument should demonstrate that it is highly effective in offsetting changes in fair value attributable to the hedged risk. The Group considers that where changes in fair value offset each other in the range of 80 percent to 125 percent the hedge is highly effective.

## (j) Property and equipment

The Group's leasehold land and buildings are held under leasehold agreements and, in the absence of reliable information to allow separation of the land and buildings components under the leases the land and buildings are accounted for as properties.

These leasehold land and buildings are stated at their revalued amount, being their fair value at the date of the revaluation less any subsequent accumulated depreciation. Revaluations are performed with sufficient regularity to ensure that the carrying amount of these assets does not differ materially from that which would be determined using fair values at the end of reporting period.

Changes arising on the revaluation of properties are generally dealt with in other comprehensive income and are accumulated separately in equity in the premises revaluation reserve. The only exceptions are as follows:

- when a deficit arises on revaluation, it will be charged to profit or loss to the extent that it exceeds the amount held in the reserve in respect of that same asset immediately prior to the revaluation; and
- when a surplus arises on revaluation, it will be credited to profit or loss to the extent that a deficit on revaluation in respect of that same asset had previously been charged to profit or loss.

Subsequent expenditure relating to a fixed asset that has already been recognised is added to the carrying amount of the assets when it is probable that future economic benefits, in excess of the originally assessed standard of performance of the existing asset, will flow to the Group. All other subsequent expenditure is recognised as an expense in the period in which it is incurred.

Gains or losses arising from the retirement or disposal of fixed assets are determined as the difference between the net disposal proceeds and the carrying amount of the assets and are recognised in profit or loss on the date of retirement or disposal.

(ii) 對沖有效性測試(續)

#### (j) 物業及設備

本集團之租賃土地及樓宇根據租賃協議 持有,在無可靠資料以允許根據租約分 開土地和樓宇之組成部分情況下,土地 及樓宇列作物業入賬。

該等租賃土地及樓宇乃按其重估金額(即 其於重估日期的公平價值扣除其後任何 累計折舊)列賬。評估會定期進行以確保 於報告期末該等資產之賬面值與使用公 平價值釐定之價值沒有重大差異。

重估物業產生之變動一般認列於其他全面收益內,並於權益項下之物業重估儲備中獨立累計。惟下列情況除外:

- 當重估出現虧絀時,虧絀超出同一 資產於重估前之儲備款額會自損益 扣除;及
- 當因重估而出現盈餘時,倘同一資產以往曾有重估虧絀自損益扣除時,則本次重估盈餘將計入損益。

倘若該固定資產所發生的後續費用能產 生未來經濟收益(超出現有資產之初始評 定之表現標準)並流向本集團,該筆費用 會附加於相關資產之賬面值。其他所有 後續費用於其產生期間被確認為開支。

固定資產報廢或出售產生的盈虧乃根據 有關資產出售所得款項淨額與其賬面值 之差額而釐定,並於報廢或出售當日於 損益賬內確認。

#### (j) Property and equipment (continued)

Depreciation is calculated to write off the cost or valuation of items of property and equipment using the straight line method over the estimated useful lives as follows:

- Buildings situated on leasehold land are depreciated over the shorter of the unexpired term of the lease and their estimated useful lives, being no less than 2% per annum after the date of completion.
- Furniture and equipment is generally depreciated over periods of between three to ten years.

Where parts of an item of property and equipment have different useful lives each part is depreciated separately. Both the useful life of an asset and its residual value, if any, are reviewed annually.

## (k) Assets held for sale

An asset is classified as held for sale if it is highly probable that its carrying amount will be recovered through a sale transaction rather than through continuing use and the asset is available for sale in its present condition.

Immediately before classification as held for sale, the measurement of the assets is brought up-to-date in accordance with the accounting policies before the classification. Then, on initial classification as held for sale and until disposal, the assets (except for certain assets as explained below), are recognised at the lower of their carrying amount and fair value less costs to sell. The principal exceptions to this measurement policy so far as the financial statements of the Group are concerned are deferred tax assets, assets arising from employee benefits and financial assets (other than investments in subsidiaries, associates and joint ventures). These assets, even if held for sale, would continue to be measured in accordance with the policies set out elsewhere in Note 2.

Impairment losses on initial classification as held for sale, and on subsequent remeasurement while held for sale, are recognised in profit or loss. As long as an asset is classified as held for sale, the asset is not depreciated or amortised.

## (I) Leases and hire purchase contracts

An arrangement, comprising a transaction or a series of transactions, is or contains a lease if the Group determines that the arrangement conveys a right to use a specific asset or assets for an agreed period of time in return for a payment or a series of payments. Such a determination is made based on an evaluation of the substance of the arrangement and is regardless of whether the arrangement takes the legal form of a lease.

#### (j) 物業及設備(續)

物業和設備項目於預計可用期限內以直線法攤餘成本或估值以計算折舊如下:

- 一 於完成日期後,座落在租賃土地之樓宇於租約餘下期間或其預計可用期限之較短期間,每年以不低於2%折舊。
- 家俱和設備一般於三至十年之期間 折舊。

當物業和設備項目之部件有不同使用期限時,每個部件須分開折舊。資產之使用期限及其殘值(如有)均須每年進行覆核。

#### (k) 持作出售之資產

如資產賬面值極大可能透過出售交易而 收回,而並非透過持續使用,及其現時 狀況為可供出售,則此資產分類為持作 出售。

緊接分類為持作出售前,資產之計量根據分類前之會計政策計至截至當日止。 其後於初始分類為持作出售及直至出出售 之期間,資產(不包括下列所解釋之居之期間,資產(不包括下列所解釋之時之 資產)按其賬面值及公平價值減出售成 之較低者確認。就本集團之財務報告 完,此一計量政策之主要例外為遞延融 育資產、僱員福利產生之資產及司及稅資 產(不包括於附屬公司、聯營公司及稅資營 企業之投資)。該等資產(即使持作出售) 將持續根據附註2所載之政策計量。

於初始分類為持作出售以及於列作持作 出售之期間重新計量而產生之減值虧 損,在損益中確認。只要資產被分類為 持作出售,該資產即不予折舊及攤銷。

## (I) 租約及租購合約

倘本集團確定一項安排具有在協定期限 內通過支付一筆或一系列款項而使用某 一特定資產或多項資產之權利,則該安 排(由一宗交易或一系列交易組成)為租 賃或包括租賃。該釐定乃根据安排之內 容評估而作出,而非論安排是否具備租 賃之法律形式。

#### (I) Leases and hire purchase contracts (continued)

### (i) Classification of leased assets

Leases which transfer substantially all the risks and rewards of ownership to the lessee are classified as finance leases. Leases which do not transfer substantially all the risks and rewards of ownership to the lessee are classified as operating leases.

#### (ii) Finance leases

Where the Group is a lessor under finance leases, an amount representing the net investment in the lease is included in the balance sheet as advances to customers. Hire purchase contracts having the characteristics of finance leases are accounted for in the same manner as finance leases. Impairment losses are accounted for in accordance with the accounting policy for impairment (see Note 2(n)).

#### (iii) Operating leases

Where the Group has the use of assets held under operating leases, payments made under the leases are charged to profit or loss in equal instalments over the periods covered by the lease terms, except where an alternative basis is more representative of the pattern of benefits to be delivered from the leased asset. Lease incentives received are recognised in profit or loss as an integral part of the aggregated net lease payments made. Contingent rentals are charged to profit or loss in the period in which they are incurred.

## (m) Repossessed assets

During the recovery of impaired advances to customers, the Group may take repossession of assets held as collateral through court proceedings or voluntary delivery of possession by the borrowers. Where it is intended to achieve an orderly realisation of the impaired assets and the Group is no longer seeking repayment from the borrower, repossessed assets are reported in "Accrued interest and other assets" and the relevant loans and advances are derecognised. The Group does not hold repossessed assets for its own use.

Repossessed assets are initially recorded at the lower of the amount of the related loans and advances and fair value less costs to sell at the date of exchange. They are not depreciated or amortised.

Impairment losses on subsequent remeasurement are recognised in profit or loss. Any gains on subsequent remeasurement are recognised in profit or loss subject to a cap at the amount of related loans and advances at the date of exchange.

#### (1) 租約及租購合約(續)

#### (i) 租賃資產分類

凡將擁有權之絕大部分風險與所有權回報轉移至出租人之租約均列為融資租約。未將擁有權之絕大部分風險與所有權回報轉由承租人承擔之租約列為經營租約。

#### (ii) 融資租約

凡本集團根據融資租約為出租人時,相當於租約中投資淨額之款項作為客戶貸款包括於資產負債表內。具有融資租約特徵之租購合約以同樣方式列賬為融資租約。減值虧損根據減值之會計政策入賬(見附註2(n))。

#### (iii) 經營租約

## (m) 收回資產

於收回已減值客戶貸款期間,本集團可能透過法院訴訟或由借方自願交付財產收回持作抵押之資產。倘預期減值資產將有秩序地變現及本集團不再尋求借方還款時,收回資產在報告內呈列為「應計利息及其他資產」,而相關借款及貸款則撤銷確認。本集團並無收回資產作為自用。

收回資產最初按相關借款及貸款之款額 及公平價值減出售成本之較低者於交易 日期記錄,且不折舊或攤銷。

其後重新計量之減值虧損於損益賬內確 認。其後重新計量之收益於損益賬內確 認,惟上限為於交易日期相關借款及貸 款之金額。

#### (n) Impairment of assets

The carrying amount of the Group's assets are reviewed at each balance sheet date to determine whether there is objective evidence of impairment. Objective evidence that assets are impaired includes observable data that comes to the attention of the Group about one or more of the following loss events which has an impact on the future cash flows of assets:

#### Financial assets:

- Significant financial difficulty of the issuer or borrower;
- A breach of contract, such as a default or delinquency in interest or principal payments;
- It becoming probable that the borrower will enter bankruptcy or other financial reorganisation;
- Significant changes in the technological, market, economic or legal environment that have an adverse effect on the borrower;
- Disappearance of an active market for financial assets because of financial difficulties; and
- A significant or prolonged decline in the fair value of an investment in an equity instrument below its cost.

#### Non-financial assets:

- During the period, an asset's market value has declined significantly more than would be expected as a result of the passage of time or normal use;
- Significant changes with an adverse effect on the Group have taken place during the period, or will take place in the near future, in the technological, market, economic or legal environment in which the Group operates or in the market to which an asset is dedicated:
- Evidence is available of obsolescence or physical damage of an asset; or
- Significant changes with an adverse effect on the Group have taken place during the period, or are expected to take place in the near future, impacting how an asset is used or is expected to be used. These changes include the asset becoming idle, plans to discontinue or restructure the operation to which an asset belongs, plans to dispose of an asset before the previously expected date, and reassessing the useful life of an asset as finite rather than indefinite.

If any such evidence exists, the carrying amount is generally reduced to the estimated recoverable amount by means of a charge to profit or loss. For available-for-sale financial assets, the carrying amount is reduced to the fair value.

#### (n) 資產減值

本集團之資產賬面值於每個結算日進行 評估,以釐定是否有減值之客觀證據。 資產減值的客觀證據包括本集團注意到 以下一項或多項對資產的未來現金流量 有影響的虧損事項的可觀察數據:

#### 金融資產:

- 一 發行人或借款人有重大財務困難;
- 一 違反合約,如拖欠或無法償還利息 或本金;
- 借款人可能破產或進行其他財務重 組;
- 科技、市場、經濟或法律環境出現 重大的改變而對借款人有不利影響:
- 金融資產的活躍市場由於財務困難 而消失;及
- 一 於股本工具之投資之公平價值大幅 下跌或長時間下跌至低於其成本 值。

#### 非金融資產:

- 一 資產的市價當期大幅度下跌,其跌幅明顯高於因時間的推移或者正常 使用而預計的下跌;
- 一 本集團經營所處的技術、市場、經濟或者法律環境或資產所處的市場 在當期或者將在近期發生重大變 化,而對本集團產生不利影響;
- 有證據表明資產已經陳舊過時或者 其實體已經損壞;或
- 一 資產使用或預計擬使用的範圍或方 式在當期或者預計將在近期發生重 大變化,從而對本集團產生不影響。該等變動包括資產被閒置、計 劃終止或重組資產所屬業務、計劃 較先前預期日期提前出售資產及將 資產的使用年期重新評估為有限期 而非無限期。

倘顯示以上任何證據, 賬面值一般須透 過在損益賬扣除款項之方式減至估計可 收回數額。可供出售金融資產的賬面值 直接減至公平價值。

#### (n) Impairment of assets (continued)

Impairment losses are written off against the corresponding assets directly, except for impairment losses recognised in respect of advances to customers, which are measured at amortised cost, whose recovery is considered doubtful but not remote. In this case, the impairment losses are recorded using an allowance account. When the Group is satisfied that recovery is remote, the amount considered irrecoverable is written off against advances to customers directly and corresponding amounts held in the allowance account relating to that borrower are reversed. Subsequent recoveries of amounts previously charged to the allowance account are reversed against the allowance account. Other changes in the allowance account and subsequent recoveries of amounts previously written off directly are recognised in profit or loss.

#### (i) Loans and receivables

Impairment losses on loans and receivables are measured as the difference between the asset's carrying amount and the present value of estimated future cash flows discounted at the asset's original effective interest rate (i.e. the effective interest rate computed at initial recognition of these assets). Receivables with a short duration are not discounted if the effect of discounting is immaterial.

The total allowance for credit losses consists of two components: individual impairment allowances and an collective impairment allowance.

The Group first assesses whether any objective evidence of impairment exists for financial assets that are individually significant and collectively for financial assets that are not individually significant. If the Group determines that no objective evidence of impairment exists for an individually assessed financial asset, whether significant or not, it then includes the asset in a group of financial assets with similar credit risk characteristics and collectively assesses them for impairment. Assets that are individually assessed for impairment and for which an impairment loss is or continues to be recognised are not included in any collective assessment of impairment. Assets that are not individually significant are collectively assessed for impairment by grouping together financial assets with similar risk characteristics.

Individual impairment allowances are based upon management's best estimate of the cash flows which are expected to be received discounted at the original effective interest rate. In estimating these cash flows management makes judgments about the borrower's financial situation and the net realisable value of any underlying collateral or guarantees in favour of the Group. Each impaired asset is assessed on its merits.

#### (n) 資產減值(續)

#### (i) 貸款及應收款項

貸款及應收款項的減值虧損是資產 賬面值,與按其原本實際利率(即 初始確認該等資產所用之實際利 率)折算預計未來現金流量現值之 差額。倘折現之影響屬輕微,短期 之應收款項不予折現。

信貸損失撥備總額包括兩個組成部分:個別減值撥備,及綜合減值撥備。

個別減值撥備乃根據管理層對現金 流量之最佳估計,即按原實際利率 折現預期將獲得之款項。在估計該 等現金流量時,管理層須判斷借款 人的財政狀況及給予本集團的抵押 品或擔保之可變現淨值。每項減值 資產均按照其合理數據進行評估。

#### (n) Impairment of assets (continued)

#### (i) Loans and receivables (continued)

In assessing the need for a collective impairment allowance on individually significant loans which are not impaired and assets that are not individually significant, management considers factors such as credit quality, portfolio size, concentrations, and economic factors. In order to estimate the required allowance the Group makes assumptions both to define the way the Group models inherent losses and to determine the required input parameters based on historical experience and current economic conditions.

The accuracy of the impairment allowances the Group makes depends on how well the Group can estimate future cash flows for individually assessed impairment allowances and the model assumptions and parameters used in determining collective impairment allowance. While this necessarily involves judgment, the Group believes that the impairment allowances on advances to customers are reasonable and supportable.

Any subsequent changes to the amounts and timing of the expected future cash flows compared to the prior estimates that can be linked objectively to an event occurring after the write-down, will result in a change in the impairment allowances on loans and receivables and be charged or credited to profit or loss. A reversal of impairment losses is limited to the loans and receivables' carrying amount that would have been determined had no impairment loss been recognised in prior years.

When there is no reasonable prospect of recovery the loan and the related interest receivable are written off.

Loans and receivables with renegotiated terms are loans that have been restructured due to deterioration in the borrower's financial position and where the Group has made concessions that it would not otherwise consider. Renegotiated loans and receivables are subject to ongoing monitoring to determine whether they remain impaired or past due.

## (ii) Held-to-maturity investments

Impairment on held-to-maturity investments is considered at both an individual and collective level. If impairment is identified, the individual impairment allowance is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows, discounted at the asset's original effective interest rate, where the effect of discounting is material.

#### (n) 資產減值(續)

#### (i) 貸款及應收款項(續)

於評估並未減值之金額重大之個別貸款及金額並不重大之個別資產所需的綜合減值撥備時,管理層須考慮的因素包括信貸素質、組合規模、信貸集中、及經濟因素。為估計所需的撥備,本集團根據過往經驗和現時之經濟情況去釐定潛在風險及輸入變數。

減值撥備之準確性須視乎本集團能 否在評估個別減值撥備時準確估計 交易對手的未來現金流量及在釐定 綜合減值撥備時所採用的標準假設 及參數。雖然此須視乎判斷而定, 本集團相信客戶貸款之減值撥備是 合理和足夠的。

在之後期間,任何因估計未來現金 流量的金額及時間與先前估計的與 等,而該轉變是可專觀地 對於發生的事件有關連,從而轉變 資款和應收款項之減值撥備亦需改 變,該轉變會支銷或計入損益無 對,該轉變會支銷或計入損至若 等 所轉回的減值虧損而原應已整 有確認減值虧損而原應已整 款及應收款項賬面值為限。

於再無合理預期可收回貸款時,貸款及相關應收利息將會予以撇銷。

具有經重新磋商條件之貸款及應收 款項是指由於借款人的財務狀況惡 化而獲重新議定原來不會獲考慮的 特別寬鬆償還款條件的貸款。重新 磋商的貸款及應收款項須接受持續 監測,以釐定彼等是否仍減值或已 逾期。

## (ii) 持至到期投資

本集團會從個別和綜合兩個層面 考慮持至到期投資是否出現減值。 若確定減值,個別減值撥備是以資 產賬面值與該資產原本的實際利率 (如果折現影響重大)折現方式計算 預計未來現金流量的現值之間的差 額計量。

#### (n) Impairment of assets (continued)

#### (ii) Held-to-maturity investments (continued)

All held-to-maturity investments found not to be individually impaired are then collectively assessed for any impairment that has been incurred but not yet identified.

If in a subsequent period the amount of an impairment loss decreases and the decrease can be linked objectively to an event occurring after the impairment loss was recognised, the impairment loss is reversed through profit or loss. A reversal of impairment losses shall not result in the asset's carrying amount exceeding that which would have been determined had no impairment loss been recognised in prior years.

#### (iii) Available-for-sale financial assets

Where there is objective evidence that an available-for-sale financial asset is impaired, the cumulative unrealised loss that had been recognised in other comprehensive income is reclassified to profit or loss. The amount of the cumulative loss that is recognised in profit or loss is the difference between the acquisition cost (net of any principal repayment and amortisation) and current fair value, less any impairment loss on that asset previously recognised in profit or loss.

Impairment losses recognised in profit or loss in respect of available-for-sale equity securities are not reversed through profit or loss. Any subsequent increase in the fair value of such assets is recognised in other comprehensive income.

Impairment losses in respect of available-for-sale debt securities are reversed if the subsequent increase in fair value can be objectively related to an event occurring after the impairment loss was recognised. Reversals of impairment losses in such circumstances are recognised in profit or loss.

## (iv) Other assets

Internal and external sources of information are reviewed at each balance sheet date to identify indications that the following non-financial assets may be impaired or an impairment loss previously recognised no longer exists or may have decreased:

- furniture and equipment;
- investments in subsidiaries and associates; and
- goodwill.

If any such indication exists, the asset's recoverable amount is estimated.

#### (ii) 持至到期投資(續)

在個別層面沒有出現減值的所有持 至到期投資會接受綜合評估,以確 定是否有任何已出現但未確定的減 值情況。

如果在往後期間,減值虧損金額減少,而該減少是可客觀地與確認減值虧損後發生的事件有關連,則減值虧損會透過損益賬回撥。減值虧損回撥不得導致資產賬面值超出減值虧損從未在往年確認而應已釐定的資產賬面值。

#### (iii) 可供出售金融資產

倘有客觀證據顯示可供出售金融資產已經出現減值,確認於其他全面收益之累計未變現虧損於損益態內重新分類。在損益賬內確認的累計損失數額等於購入成本(已扣除任何本金還款和攤銷)與當期公平價值之間的差額,減去之前已在損價值販內確認的該資產的任何減值虧

在損益賬所確認有關可供出售股本 證券之減值虧損不會透過損益賬撥 回。該等資產其後之任何公平價值 增加確認為其他全面收益。

倘可供出售債務證券之公平價值在 日後增加,而有關的增加可以客觀 地與確認減值虧損後發生的事件聯 繫起來,便會將減值虧損轉回。在 該等情況下,減值虧損轉回須在損 益賬內確認。

## (iv) 其他資產

於各結算日,本公司審閱內部及外來資料以辨認以下非金融資產可有減值跡象或先前已確認之減值虧損已不再存在或可能已減少:

- 一 傢俬及設備;
- 一 附屬公司及聯營公司投資;及
- 一 商譽。

如果出現減值跡象,資產的可收回 數額便會作估計。

#### (iv) Other assets (continued)

#### Calculation of recoverable amount

The recoverable amount of an asset is the greater of its fair value less costs to sell and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. Where an asset does not generate cash inflows largely independent of those from other assets, the recoverable amount is determined for the smallest group of assets that generate cash inflows independently (i.e. a cash-generating unit).

#### Recognition of impairment losses

An impairment loss is recognised in profit or loss whenever the carrying amount of an asset, or the cash-generating unit to which it belongs, exceeds its recoverable amount. Impairment losses recognised in respect of cash-generating units are allocated first to reduce the carrying amount of any goodwill allocated to the cash-generating unit (or group of units) and then, to reduce the carrying amount of the other assets in the unit (or group of units) on a pro rata basis, except that the carrying value of an asset will not be reduced below its individual fair value less costs to sell, or value in use, if determinable.

## Reversals of impairment losses

An impairment loss is reversed if there has been a favourable change in the estimates used to determine the recoverable amount.

A reversal of impairment losses is limited to the asset's carrying amount that would have been determined had no impairment loss been recognised in prior years. Reversals of impairment losses are credited to profit or loss in the year in which the reversals are recognised.

## (o) Cash equivalents

Cash equivalents are short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition.

#### 計算可收回數額

## (o) 等同現金項目

等同現金項目為短期和流動性極高的投資項目。這些項目可以容易地換算為已知的現金數額,而所須承受的價值變動風險甚小,並在購入後三個月內到期。

#### (p) Employee benefits

#### (i) Short term employee benefits

Short term employee benefits include salaries, annual bonuses, paid annual leave, contributions to defined contribution retirement plans and the cost of non-monetary benefits and are accrued in the year in which the associated services are rendered by employees of the Group. Where payment or settlement is deferred and the effect would be material these amounts are stated at their present values.

#### (ii) Defined benefit retirement scheme

The Group's net obligation in respect of its defined benefit retirement scheme is calculated by estimating the amount of future benefit that employees have earned in return for their service in the current and prior periods; that benefit is discounted to determine the present value and the fair value of any scheme assets is deducted. The calculation is performed by a qualified actuary using the projected unit credit method. When the calculation results in a benefit to the Group, the recognised asset is limited to the present value of economic benefits available in the form of any future refunds from the scheme or reductions in future contributions to the scheme. Service cost and net interest expense (income) on the net defined benefit liability (asset) are recognised in profit or loss as part of "Staff costs". Current service cost is measured as the increase in the present value of the defined benefit obligation resulting from employee service in the current period. When the benefits of a scheme are changed, or when a scheme is curtailed, the portion of the changed benefit related to past service by employees, or the gain or loss on curtailment, is recognised as an expense in profit or loss at the earlier of when the scheme amendment or curtailment occurs and when related restructuring costs or termination benefits are recognised. Net interest expense (income) for the period is determined by applying the discount rate used to measure the defined benefit obligation at the beginning of the reporting period to the net defined benefit liability (asset). The discount rate is the yield at the end of the reporting period on high quality corporate bonds that have maturity dates approximating the terms of the Group's obligations. Remeasurements arising from defined benefit retirement schemes are recognised in other comprehensive income and reflected immediately in retained earnings. Remeasurements comprise actuarial gains and losses, the return on scheme assets (excluding amounts included in net interest on the net defined benefit liability (asset)) and any change in the effect of the asset ceiling (excluding amounts included in net interest on the net defined benefit liability (asset)).

#### (p) 僱員福利

#### (i) 短期僱員福利

短期僱員福利包括薪酬、每年花紅、有薪年假、定額供款退休計劃供款及非貨幣福利成本,於本集團僱員提供有關服務之年度內累計。倘延遲付款或清償將會帶來嚴重影響,該等數額須按現值列賬。

#### (ii) 定額福利退休計劃

本集團有關其定額福利退休計劃的 淨義務乃估計僱員於本期及過往期 間的服務所賺取的未來福利金額 而計算;該福利已折現以釐定其現 值, 並扣減相關資產的公平價值。 有關計算由合資格精算師使用預計 單位信貸方法進行。倘計算結果對 本集團有利,則確認的資產僅限以 任何未來由計劃退款或未來減少向 計劃供款的方式獲得經濟利益的現 值。服務成本及定額福利負債(資 產)淨值的利息支出(收入)淨額乃 於損益中確認為「僱員成本」的一部 分。本期服務成本乃按本期僱員服 務產生的定額福利責任現值的增加 而計量。倘計劃的福利出現變動, 或計劃縮短,有關僱員過往服務變 動福利的比例,或縮短的收益或虧 損於計劃修訂或縮短發生及當有關 重組成本或終止福利已確認時較 早者於損益中確認為支出。期內利 息支出(收入)淨額乃應用於報告期 初用於計量定額福利責任的折現 率折現至定額福利淨負債(資產)而 釐定。折現率乃高質素企業債券於 報告期末的收益率,有關的債券到 期日與本集團所承擔責任的條款相 若。定額福利退休計劃產生的重新 計量乃於其他全面收入中確認且立 即於保留溢利中反映。重新計量包 括精算收益及虧損,計劃資產之回 報(不包括計入定額福利淨負債(資 產)的淨利息內的金額)及資產上限 影響的任何變動(不包括計入定額 福利淨負債(資產)的淨利息內的金 額)。

#### (q) Income tax

Income tax for the year comprises current tax and movements in deferred tax assets and liabilities. Current tax and movements in deferred tax assets and liabilities are recognised in profit or loss except to the extent that they relate to items recognised in other comprehensive income or directly in equity, in which case the relevant amounts of tax are recognised in other comprehensive income or directly in equity, respectively.

Current tax is the expected tax payable on the taxable income for the year, using tax rates enacted or substantively enacted at the balance sheet date, and any adjustment to tax payable in respect of previous years.

Deferred tax assets and liabilities arise from deductible and taxable temporary differences respectively, being the differences between the carrying amounts of assets and liabilities for financial reporting purposes and their tax bases. Deferred tax assets also arise from unused tax losses and unused tax credits.

Apart from certain limited exceptions, all deferred tax liabilities, and all deferred tax assets to the extent that it is probable that future taxable profits will be available against which the asset can be utilised, are recognised.

The amount of deferred tax recognised is measured based on the expected manner of realisation or settlement of the carrying amount of the assets and liabilities, using tax rates enacted or substantively enacted at the balance sheet date. Deferred tax assets and liabilities are not discounted.

The carrying amount of a deferred tax asset is reviewed at each balance sheet date and is reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow the related tax benefit to be utilised. Any such reduction is reversed to the extent that it becomes probable that sufficient taxable profit will be available.

Current tax balances and deferred tax balances, and movements therein, are presented separately from each other and are not offset. Current tax assets are offset against current tax liabilities, and deferred tax assets against deferred tax liabilities if the Bank or the Group has the legally enforceable right to set off current tax assets against current tax liabilities and the following additional conditions are met:

 in the case of current tax assets and liabilities, the Bank or the Group intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously; or

#### (q) 所得税

遞延税項資產及負債乃分別來自可扣税 及應課税暫時性差異,即因資產及負債 分別就財務報告及税基而言之賬面值之 間的差異而產生。遞延税項資產亦會因 未動用税項虧損及未動用税項抵免而產 生。

除若干有限例外情況外,所有遞延税項 負債及所有遞延税項資產當其甚有可能 用於抵銷未來應課税溢利時均會予以確 認。

遞延税項確認額乃按資產及負債之賬面 值之預期變現或支付形式,使用於結算 日已頒佈或實質頒佈之稅率計算。遞延 税項資產及負債不予折現計算。

於各結算日,遞延税項資產之賬面值均 進行覆核,對預期不再有足夠之應課稅 溢利以供使用有關遞延税項則予扣減。 倘若有可能獲得足夠之應課稅溢利,則 任何有關扣減均會被撥回。

即期税項結餘及遞延税項結餘以及有關變動,均會個別呈列及不作抵銷。如本行或本集團可依法行使權利將即期税項資產抵銷即期税項負債,並在符合下列其他條件之情況下,即期税項資產方會與即期税項負債抵銷,以及遞延税項資產會與遞延稅項負債抵銷:

#### (q) Income tax (continued)

- in the case of deferred tax assets and liabilities, if they relate to income taxes levied by the same taxation authority on either:
  - the same taxable entity; or
  - different taxable entities, which, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered, intend to realise the related current tax assets and settle the related current tax liabilities on a net basis or realise and settle simultaneously.

## (r) Financial guarantees issued, provisions and contingent liabilities

#### (i) Financial guarantees issued

Financial guarantees are contracts that require the issuer (i.e. the guarantor) to make specified payments to reimburse the beneficiary of the guarantee (the holder) for a loss the holder incurs because a specified debtor fails to make payment when due in accordance with the terms of a debt instrument.

Where the Group issues a financial guarantee to customers, the fair value of the guarantee (being the guarantee fees received) is initially recognised as deferred income within other liabilities.

The deferred income is amortised to profit or loss over the term of the guarantee as income from financial guarantees issued. The carrying amount of the guarantee issued is remeasured in accordance with Note 2(r)(ii) if and when:

- it becomes probable that the holder of the guarantee will call upon the Group under the guarantee; and
- (ii) the amount of that claim on the Group is expected to exceed the amount currently carried in other liabilities in respect of that guarantee i.e. the amount initially recognised, less accumulated amortisation.

#### (q) 所得税(續)

倘本集團向客戶發出財務擔保,該 擔保的公平價值(即已收擔保費用) 最初確認為其他負債內的遞延收 入。

遞延收入按擔保年期攤銷至損益 賬作為已發出財務擔保的收入。此 外,倘出現如下情況,即須按照附 註2(r)(ii)重新計量已發出擔保之賬 面值:

- (i) 擔保的持有人可能根據擔保 向本集團催收款項;及
- (ii) 預期向本集團提出的申索款 額高於現時就該擔保列於其 他負債項下的數額(即最初確 認的金額,扣除累計攤銷)。

#### (ii) Other provisions and contingent liabilities

Provisions are recognised for other liabilities of uncertain timing or amount when the Group or the Bank has a legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditures expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

#### (s) Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable. Provided it is probable that the economic benefits will flow to the Group and the revenue and costs, if applicable, can be measured reliably, revenue is recognised in profit or loss as follows:

#### (i) Interest income

Interest income from interest-bearing financial instruments is recognised in profit or loss on an accruals basis using the effective interest rate method. Interest income from trading assets and financial assets designated at fair value through profit or loss is recognised on basis of accrued coupon and is recognised in net interest income.

The effective interest rate method is a method of calculating the amortised cost of a financial asset and of allocating the interest income over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash payments or receipts through the expected life of the financial instrument or, when appropriate, a shorter period to the net carrying amount of the financial asset. When calculating the effective interest rate, the Group estimates cash flows considering all contractual terms of the financial instrument (for example, prepayment, call and similar option) but does not consider future credit losses. The calculation includes all fees and points paid or received between parties to the contract that are an integral part of the effective interest rate, together with transaction costs and all other premiums or discounts. Cash rebates granted in relation to residential mortgage loans are capitalised and amortised to profit or loss over their expected life.

#### (ii) 其他撥備及或然負債

撥備乃本集團或本行因過往事件引致之法律或推定義務而可能需要付出經濟利益以履行有關義務及能作出可靠估計時,就未能確定之時間或數額之其他負債確認。倘金錢時間價值乃屬重大,撥備則以預計用以履行有關義務之開支現值列賬。

倘可能無須付出經濟效益,或未能 可靠估計付出之金額,有關義務則 披露為或然負債,除非付出經濟利 益之可能性極微。需就未來事件發 生與否方能確認之可能義務亦只披 露為或然負債,除非付出經濟利益 之可能性是極微。

#### (s) 收益確認

收益乃按已收或應收代價之公平價值計量。當經濟利益很可能流入本集團,而收入及成本(倘適用)能可靠地計算時,收益會按下列方式在損益賬確認:

#### (i) 利息收入

計息金融工具之利息收入採用實際 利率法按應計基準於損益賬內確認。持作交易用途之資產及指定為 通過損益以反映公平價值之金融資產的利息收入按應計票息基準確認 為淨利息收入。

實際利率法乃計算金融資產之攤 餘成本及按有關期間攤分利息收 入之方法。實際利率乃按金融工具 預計年期折讓估計日後現金付款或 收入(或適當時按較短期間折讓金 融資產之賬面淨值)之比率。計算 實際利率時,本集團估計現金流量 時,考慮到金融工具之一切合約條 款(例如提前還款,認購或類似期 權),而並無計及未來信貸虧損。計 算範圍包括實際利率為主體部分訂 約各方所付或所收之一切費用及代 價,交易成本及其他所有溢價或折 讓。住宅按揭貸款之現金回贈會予 以資本化,並以其預計期限在損益 賬內攤銷。

#### (s) Revenue recognition (continued)

(ii) Net income from financial instruments designated at fair value through profit or loss and net trading income

Net income from financial instruments designated as fair value through profit or loss and net trading income comprise all gains and losses from changes in fair value (net of accrued coupon) of such financial assets and financial liabilities, foreign exchange differences and dividend income attributable to those financial instruments.

#### (iii) Fee and commission income

Fee and commission income arises on financial services provided by the Group including cash management services, brokerage services, investment banking services, investment management services and project and structured finance transactions services. Fee and commission income is recognised when the corresponding service is provided, except where the fee is charged to cover the costs of a continuing service to, or risk borne for, the customer or is interest in nature. In these cases the fee is recognised as income in the accounting period in which the costs or risk is incurred or is accounted for as interest income.

Origination or commitment fees received by the Group which result in the creation or acquisition of a financial instrument are deferred and recognised as an adjustment to the effective interest rate unless it is a trading asset or liability or a financial asset designated at fair value through profit or loss. In this case it is immediately recognised in profit or loss. If the commitment expires without the Group making a loan, the fee is recognised as revenue on expiry.

(iv) Finance income from finance lease and hire purchase contracts

Finance income implicit in finance lease and hire purchase payments is recognised as interest income over the period of the leases so as to produce an approximately constant periodic rate of return on the outstanding net investment in the leases for each accounting period. Contingent rentals receivable are recognised as income in the accounting period in which they are earned.

#### (v) Rental income from operating lease

Rental income received under operating leases is recognised as other operating income in equal instalments over the periods covered by the lease term, except where an alternative basis is more representative of the pattern of benefits to be derived from the leased asset. Lease incentives granted are recognised in profit or loss as an integral part of the aggregate net lease payments receivable. Contingent rentals receivable are recognised as income in the accounting period in which they are earned.

#### (s) 收益確認(續)

費用及佣金收入乃本集團提供金融 服務,包括現金管理服務管理服務 管理服務管理服務等管理服務 資銀行服務、投資最大級資量及結構性融資交易 所得收入。費用及佣金鄉補內客戶 相關服務時確認,以彌補為客戶外外 相關提供服務之成本、或為客戶外外 大大數等情況。 在或風險之會 為收入入賬。

本集團已收因增設或購入金融工具 而產生之辦理或承擔費用,除有關 於持作交易用途之資產或負債或之 定為通過損益以反映公平價值之之 融資產的相關款項直接於損益賬內 確認外,將作為實際利率之集團 延及確認。如承擔期滿而本集團 須作出貸款,則該費用於期滿時確 認為收入。

(iv) 來自融資租約及租購合約之財務收 入

融資租約之隱含財務收入及租購付款於租約年期確認為利息收入,以令每個會計期間租約尚餘淨投資額的定期回報率大致相同。應收或然租金於賺取之會計期間確認為收入。

#### (v) 經營租賃產生之租金收入

根據經營租賃應收之租金收入於租 賃期間內以等額方式在其他營運收 入中確認,但如有另一基準更能代 表租賃資產所產生之利益之模式則 除外。已授出之租賃獎勵於損益賬 內確認為應收總租賃款項淨額的一 部份。應收或然租金在各自賺取的 會計期間確認為收益。

#### (s) Revenue recognition (continued)

#### (vi) Dividend income

Dividend income from unlisted investments is recognised when the shareholder's right to receive payment is irrevocably established. Dividend income from listed investments is recognised when the share price of the investment goes exdividend.

#### (t) Translation of foreign currencies

The Group and the Bank's functional currency is Hong Kong Dollars. Foreign currency transactions during the year are translated into Hong Kong dollars at the exchange rates ruling at the transaction dates. Monetary assets and liabilities denominated in foreign currencies are translated into Hong Kong dollars at the exchange rates ruling at the balance sheet date. Exchange gains and losses are dealt with in profit or loss.

Non-monetary assets and liabilities that are measured in terms of historical cost in a foreign currency are translated into Hong Kong dollars using the exchange rates ruling at the transaction dates. Non-monetary assets and liabilities denominated in foreign currencies that are stated at fair value are translated into Hong Kong dollars at exchange rates ruling at the dates the fair value was determined.

Exchange differences relating to financial instruments held at fair value through profit or loss and derivative financial instruments are included in net income from financial instruments designated at fair value through profit or loss and net gain/(loss) on derivative financial instruments, respectively. All other exchange differences relating to monetary items are presented as gains less losses from dealing in foreign currencies in profit or loss and are reported within "Other operating income". Differences arising on translation of available-forsale equity instruments are recognised in other comprehensive income.

The results of foreign operations are translated into Hong Kong dollars at the exchange rates approximating the foreign exchange rates ruling at the dates of the transactions. Assets and liabilities are translated at the closing rate at the date of that balance sheet. All resulting exchange differences are recognised in other comprehensive income and accumulated in equity in the foreign exchange reserve.

On disposal of a foreign operation the cumulative amount of the exchange differences relating to that foreign operation is reclassified from equity to profit or loss when the profit or loss on disposal is recognised.

#### (t) 外幣換算

本集團及本行的記賬單位幣別為港元。 本年度內外幣交易以交易日之匯率換算 為港元。以外幣結算的貨幣性資產及負 債以結算日之匯率換算為港元。所有外 幣換算之損益均撥入損益脹內處理。

以外幣定值並以歷史成本列賬之非貨幣 資產與負債按交易日的匯率換算為港 元。以外幣結算及以公平價值列賬之非 貨幣資產與負債於釐定公平價值當日按 當時匯率換算為港元。

通過損益以反映公平價值計入損益賬之金融工具及衍生金融工具的匯兑差額分別包括於指定為通過損益以反映公工具淨值之金融工具淨收益及衍生金融工具淨溢利/(虧損)。其他有關貨幣性項目的匯兑差額則於損益賬內呈列為外幣買淨盈虧,並於「其他營運收入」內呈報。換至可供出售股本工具之差額確認為其他全面收益。

海外業務的業績按與交易日的匯率相若 的匯率換算為港幣。資產及負債則按結 算日的收市率換算。產生的所有匯兑差 額確認為其他全面收益,並於外幣換算 儲備內累計為權益。

出售海外業務時,在權益內確認與該等 海外業務有關之匯兑差額之累計金額, 於確認出售盈虧時由權益重新分類至損 益。

#### (u) Related parties

For the purposes of these financial statements, a party is considered to be related to the Group if:

- (a) a person, or a close member of that person's family, is related to the Group if that person:
  - (i) has control or joint control over the Group;
  - (ii) has significant influence over the Group; or
  - (iii) is a member of the key management personnel of the Group or the Group's parent.
- (b) an entity is related to the Group if any of the following conditions applies:
  - the entity and the Group are members of the same group (which means that each parent, subsidiary and fellow subsidiary is related to the others).
  - (iii) one entity is an associate or joint venture of the other entity (or an associate or joint venture of a member of a group of which the other entity is a member).
  - (iii) both entities are joint ventures of the same third party.
  - (iv) one entity is a joint venture of a third entity and the other entity is an associate of the third entity.
  - (v) the entity is a post-employment benefit plan for the benefit of employees of either the Group or an entity related to the Group.
  - (vi) the entity is controlled or jointly controlled by a person identified in (a).
  - (vii) a person identified in (a)(i) has significant influence over the entity or is a member of the key management personnel of the entity (or of a parent of the entity).

Close members of the family of a person are those family members who may be expected to influence, or be influenced by, that person in their dealings with the entity.

## 14. SEGMENT REPORTING

Segment information is presented in respect of the Group's operating segments which are the components of the Group about which separate financial information is available and evaluated regularly by the Chief Executive Officer in deciding how to allocate resources and in assessing performance.

#### **Operating segments**

The Bank and its subsidiaries are principally engaged in the provision of banking and related financial services. Reportable segments of the Group are set out below.

Consumer Banking business comprises Consumer Finance activities including credit card merchant acquiring, provision of credit card advances, mortgage lending and other consumer lending and Retail Banking services such as securities brokerage, the sales and distribution of wealth management products to wealth management clients, defined as those with a higher value of assets under administration, provision of banking services to the mass market segment, and provision of insurance and unit trust wealth management services.

Corporate & Institutional Banking comprises the Commercial Banking business and Corporate Banking business. Commercial Banking business includes commercial lending to small and medium enterprises. Corporate Banking business covers trade financing, syndicated loans and other corporate lending to large enterprises.

Financial Markets mainly engages in foreign exchange and fixed income securities trading activities; the marketing of investment products to non-bank enterprises and managing the Group's investment portfolio. Moreover, it also manages the overall funding, liquidity and interest rate risk positions arising from the banking activities of the Group.

#### Segment results, assets and liabilities

For the purpose of segmental analysis, the allocation of revenue reflects the benefits of capital and other funding resources allocated to the operating segments by way of internal capital allocation and fund transfer-pricing mechanisms. To reflect the benefit of joint efforts of two operating segments on a third-party fee-related transaction, operating income derived from the transaction is split and recorded with jointly agreed splitting ratio in the relevant operating segments.

Cost allocation is based on the direct costs incurred by the respective operating segments. For consistency with internal management reporting, there is no apportionment of central management overheads and only wholly and directly attributable costs of support units are charged to the respective operating segments. Rental charges at market rates for usage of premises are reflected in "Operating Expense" and "Inter-segment Expense" for the respective operating segments.

Segment assets mainly include advances to customers less impairment, investment in securities and financial instruments, inter-bank placements, current assets and premises attributable to the operating segments.

Segment liabilities mainly include deposits from customers, certificates of deposit and debt securities issued, inter-bank borrowings, and accruals attributable to the operating segments.

The sale to customers of derivatives as risk management products and the subsequent use of derivatives to manage the resulting positions is an integral part of the Group's business activities. Derivatives are also used to manage the Group's own exposures to market risk as part of its asset and liability management process. The principal derivative instruments used by the Group are interest and foreign exchange rate related contracts, which are primarily over-the-counter derivatives. The Group also purchases exchange traded derivatives. Most of the Group's derivative positions have been entered into to meet customer demand and to hedge these and other trading positions or for balance sheet management. For accounting purposes, derivatives are classified as either held for trading, qualifying for hedge accounting, or managed in conjunction with financial instruments designated at fair value through profit or loss.

The zero coupon bond with a face value of HK\$520 million and issue price of 48.076615% was issued by the Bank on 12 April 2007. The maturity date for the bond is 12 April 2022 but it can be called by 12 April 2017 on the 10th anniversary of issuance. At the same time, the Bank entered into an interest rate swap to hedge the interest rate risk associated with the bond. Under the terms of the interest rate swap, the Bank makes quarterly floating rate interest payments and receives fixed rate interest income.

The carrying amount of financial liabilities designated at fair value through profit or loss at 31 December 2014 was HK\$137.6 million (2013: HK\$161.1 million) lower than the contractual amount at maturity for the Group and the Bank.

The zero coupon bond issued is measured at fair value using valuation techniques based on observable market conditions existing at the balance sheet date; however data in respect of the Bank's credit risk volatilities and correlations require management's estimation. The total loss arising from the change in the fair value of the zero coupon bond recognised in profit or loss during the year is HK\$23.5 million (2013: gain of HK\$9.1 million). There is no gain or loss recognised during the year attributable to change of credit spread (2013: loss of HK\$3.7 million).

To the extent the Bank's credit risk volatilities that are not supported by observable market prices are altered by 10% in either direction the fair value of the zero coupon bond would either be lower by HK\$1.9 million (2013: HK\$3.0 million) or higher by HK\$2.0 million (2013: HK\$3.0 million).

If at any time the HKMA determines (having regard to the applicable regulatory framework) that these subordinated notes no longer qualify as supplementary capital, the Bank may, on or after 1 January 2014 at its option and subject to the prior written approval of the HKMA, provide notice to such effect to Noteholders, such notice being a "Change in Status Notice". Upon a Change in Status Notice becoming effective, these subordinated notes shall cease to constitute subordinated obligations of the Bank and shall thereafter constitute direct, unconditional, unsubordinated and unsecured obligations of the Bank and shall at all times thereafter rank pari passu and without any preference among themselves. The payment obligations of the Bank under these subordinated notes shall, save for such exceptions as may be provided by applicable legislation, at all times thereafter rank at least equally with all its other present and future unsecured and unsubordinated obligations including liabilities in respect of deposits.

These subordinated notes bear interest at 6.125% per annum, payable semi-annually. Upon a Change in Status Notice becoming effective, the interest rate for these subordinated notes will become 5.625% per annum, payable semi-annually. These subordinated notes are stated at amortised cost.

All preference shares were redeemed on 24 December 2013 and cancelled on 6 January 2014.

#### 43. EMPLOYEE RETIREMENT BENEFITS

#### (a) Defined benefit retirement plans

The Group operates a retirement scheme, namely the Fubon Bank (Hong Kong) Limited Retirement Scheme ("the Scheme"), which incorporates a defined benefits plan for 27% (2013: 29%) of its full time employees. The Scheme is administered by trustees who are independent. The assets of the Scheme are held separately from those of the Group. The Group has secured Mandatory Provident Fund ("MPF") exemption status for the Scheme. The Scheme is funded by contributions from the Group in accordance with the trust deed governing the Scheme and based on an independent actuary's recommendations. The latest independent actuarial valuation of the Scheme was at 31 December 2014 and was prepared by Jacklyn Zhang, Fellow of the Society of Actuaries, of Mercer (Hong Kong) Limited using the projected unit credit actuarial cost method. The actuarial valuation indicates that the Group's obligations under the Scheme are 77.56% (2013: 76.85%) covered by the plan assets held by the trustee.

The Scheme offers a lump sum at retirement based on final salary and years of service or employee and employer contributions if greater. The contribution based benefit is notionally invested in a "guarantee fund" (for which the Group acts the Guarantor), with no less than a 5% p.a. return.

The Scheme is closed to new entrants except that in exceptional circumstances new individual entrants are allowed to join at the Group's discretion, so that the plan's size is contained. However, the defined benefit element and the 5% p.a. guaranteed return offered on contributions exposes the Group to actuarial risks such as interest rate risk, investment risk and longevity risk.

The amounts recognised in the consolidated balance sheet are as follows:

A portion of the above liability is expected to be settled after more than one year. However, it is not practicable to segregate this amount from the amounts payable in the next twelve months, as future contributions will also relate to future services rendered and future changes in actuarial assumptions and market conditions.

The Scheme follows a tri-annual funding valuation schedule when at each funding valuation, the contributions for the following three years are set. The last funding valuation was as of 31 December 2011 and it was assessed at that valuation that the entity contributes 13.7% of member's salary. The funding valuation as of 31 December 2014, in which valuation the 2015 contribution level will be reviewed, is being carried out the Scheme actuary.

In addition to the above, the Group acts as the "Guarantor" to meet the 5% year return on the defined contribution benefits. ## (b) Mandatory Provident Fund Scheme ("MPF Scheme")

The Group also operates an MPF scheme under the Hong Kong Mandatory Provident Fund Schemes Ordinance for employees employed under the jurisdiction of the Hong Kong Employment Ordinance and not previously covered by the Scheme. The Group participates in an approved MPF scheme with the Bank Consortium Trust Company Limited to provide a scheme choice to both existing and new employees. The MPF scheme is a defined contribution retirement scheme administered by an independent trustee.

Under the MPF scheme, the employer and its employees are each required to make mandatory contributions to the scheme at 5% of the employees' relevant income, subject to a cap of monthly relevant income of HK\$30,000 (HK\$25,000 prior to June 2014). Contributions to the scheme vest immediately.

In addition to the mandatory contribution, employees will have an one-off election to make a voluntary contribution of 5% of employee's relevant income. At the same time, the employer will make a matching voluntary contribution accordingly.

# 49. FINANCIAL RISK MANAGEMENT

This section presents information about the Group's exposure to and its management and control of risks, in particular, the primary risks associated with its use of financial instruments:

- Credit risk: losses resulting from customer or counterparty default and arising from credit exposures in all forms, including settlement risk.
- Market risk: exposures to market variables such as interest rates, exchange rates and equity markets.
- Liquidity and funding risk: risk that the Group is unable to meet its payment obligations when due, or that it is unable, on an ongoing basis, to borrow funds in the market on an unsecured, or even secured basis at an acceptable price to fund actual or proposed commitments.
- Operational risk: risk arising from matters such as non-adherence to systems and procedures or from frauds resulting in financial or reputation loss.

- 信貸風險:客戶或交易對手拖欠款項而 招致損失的風險,以及各類型信貸風 險,包括結算風險。
- 市場風險:市場變數風險,例如利率、匯率及股市等。
- 流動資金及融資風險:本集團未能在付款責任到期時履行付款責任,或無法持續在市場上以無抵押或甚至以有抵押的方式按可接受之價格借入資金,藉此為實際或建議之承擔提供所需的資金的風險。
- 營運風險:由於未遵守制度及程序等事項而引致之風險或由欺詐致使財務或聲譽受損而引致之風險。

The Group has established policies and procedures to identify and analyze these risks, to set appropriate risk limits and controls, and to monitor the risks and limits continually by means of reliable and up-to-date management and information systems. The Group continually modifies and enhances its risk management policies and systems to reflect changes in markets, products and best practice risk management processes. Internal auditors also perform regular audits to ensure compliance with the policies and procedures.

This note presents information about the Group's exposure to each of the above risks, the Group's objectives, policies and processes for measuring and managing risks, and the Group's management of capital.

#### (a) Credit risk management

Credit risk is the risk of suffering financial loss in the event that any of the Group's borrowers or market counterparties fail to fulfil their obligation to the Group. It arises mainly from loans and advances, debt securities held and counterparty credit risk arising from derivative contracts entered into with customer. It can also arise from trading and treasury activities.

The Group manages credit risk through a framework of controls to ensure credit risk taking activities are based on sound principles and in line with the overall business objectives of the Group. It has established a set of credit policies and procedures, which define the credit risk taking criteria, credit approval authorities delegated from the Board, the credit monitoring processes, the credit rating system and the loan impairment policy.

The Board of Directors has delegated credit approval authorities to the following in descending order of authority: the Executive Credit Committee, the Credit Committee and the Wholesale Credit Committee.

The Executive Credit Committee serves as the Credit Committee of the Board of Directors to review and approve credits that require the approval of the Board of Directors. In addition, it approves the Group's credit policies and overall credit risk profile, taking into consideration relevant law and regulations.

The Credit Committee is a management level committee that provides management oversight of the Group's credit risk management. It ensures that the Group has in place an effective credit risk management framework and that its credit risks are within the credit policies and credit risk profile as specified by the Board of Directors or its delegated committees. The Credit Committee reviews and endorses all credit policies and the overall credit risk profile for the Executive Credit Committee's approval, and reviews and approves credit related guidelines. It also conducts ongoing review of the market environment and makes necessary policy recommendations to the Executive Credit Committee to ensure that the credit risk profile of the Group is within the established risk appetite of the Group. The Credit Committee also reviews and approves credits that are within the authority as delegated by the Board.

此附註呈列有關本集團就上述各項風險所承担 之風險、本集團計量及管理風險之目標、政策 及程序,以及本集團之資本管理。

信貸風險指因本集團貸款人或市場交易 對手未能履行其對本集團之承擔而遭受 的財務虧損。主要源於貸款及放款、所 持債務證券及因與客戶訂立衍生合約產 生的交易對手信貸風險。亦可源於買賣 及財資活動。

本集團透過控制框架管理信貸風險,以 確保產生信貸風險之活動基於完善的原 則及與本集團整體業務目標一致。其亦 設立一系列信貸政策及程序,以界定產 生信貸風險的標準、董事會授權的信貸 批准機構、信貸監控過程、信貸評級系 統及貸款減值政策。

董事會已授權以下部門依次審批信貸: 執行信貸委員會、信貸委員會及批發信 貸委員會。

執行信貸委員會以董事會信貸委員會的 身份,審閱及批准需由董事會審批的客 戶信貸。同時根據相關法律及規則審批 本集團的信貸政策及總體信貸風險框架。

#### (a) Credit risk management (continued)

The Wholesale Credit Committee reviews and approves wholesale credits that are within its authority as delegated by the Board of Directors.

The credit departments, Enterprise Credit Risk Management Department and Consumer Credit Risk Management Department, provide centralised management of credit risk for corporate credits and retail credits respectively. They are responsible for:

- independent evaluation of credit applications;
- monitoring the loan portfolio and conducting regular analysis;
- managing problem credits to achieve the highest recovery;
- recommending loan classification, individual impairment and charge-off; and
- reporting to the Credit Committee and Executive Credit Committee regularly on aspects of the loan portfolio.

Specific policies and measures to address different kinds of credit related activities are set out below:

#### (i) Corporate lending

Credit risk from corporate lending is managed by conducting thorough credit evaluation, credit mitigation through collateral and guarantee, internal credit rating system and post-approval monitoring system. Subject to the size of the credit, value of collateral and the internal credit rating of the borrower, different levels of credit approval authority are required. Credit decisions take into account facility structure, tenor, the repayment ability of the obligor and credit mitigation through collateral and guarantee.

The Group has established limits for exposures to individual industries, borrowers and groups of borrowers, regardless if the credit exposure is in the form of funded or non-funded exposures. The Group also undertakes ongoing credit review and monitoring at several levels. The relevant policies and procedures also take into account the rules under the Hong Kong Banking Ordinance, regulatory requirements of the HKMA and best market practices.

The credit risk management procedures are designed to promote early detection of counterparty, industry or product exposures that require special monitoring. Overall portfolio risk is monitored by the Control and Risk Management Division on an on-going basis. Regular management reports are submitted to the Credit Committee regularly for review. The loan portfolio reports cover information on large exposures, country exposures, industry exposures, loan quality and loan impairment level.

#### (i) 企業借貸

企業借貸產生的信貸風險透過進行全面信貸評估,以抵押品及擔保減促低信貸評估,內部信貸理。受限於內部信貸風險、內部信貸理。受限於於不管理。受限於大人。 貸規模、抵押品價值及貸款人內貸課級,需要不同水平的信貸評級,需要不同水平的信貸課級,需要不考慮融資結構、開限、債務人還款能力以及抵抵押品及擔保減低信貸。

無論信貸風險是由於借貸或非借貸交易而產生,本集團已制定個別行業之風險限額、貸款人及貸款人團體之風險限額。本集團亦在不同層次持續開展審閱及監控。相關政策及程序亦參考香港《銀行業條例》內之規則、金管局監管規定以及最佳市場慣例。

信貸風險管理程序旨在促進提早發現需要特別監控之交易對手、行業或產品風險。監控及風險管理部險。監控及風險管理報告定期提交信貸數組合整體風險。會審閱。貸款組合報告包括有關大資、國家風險、國家風險、行業風險、國家風險、平等資料。

#### (ii) Consumer credit risk

Consumer credit risk is product driven, arising from consumer finance products such as credit cards, unsecured personal loans and mortgage loans. Because of the homogeneous nature of these products, credit risk management procedures are primarily based on statistical analyses of risks with respect to different products and types of customers. The Group determines product terms and desired customer profiles on a regular basis by developing, validating and fine-tuning internal scorecards and stress testing models. The relevant credit risk management procedures also include on-going product portfolio analysis and review, clear rules for loan classification and impairment, and regular reporting to Credit Committee.

#### (iii) Counterparty credit risk

Unlike on-balance sheet instruments, where the credit risk is generally represented by the principal value or the notional amount, credit risk for derivatives is the positive replacement cost together with an estimate for the potential future exposure from changes in market value. These credit exposures are managed as part of the overall credit limits to the counterparties. The credit risk exposure on derivatives is disclosed in Note 19(b) to these financial statements. The Group uses the current exposure method for the purpose of providing capital for such counterparty exposures.

Wrong way risk occurs when the credit exposure to a counterparty is strongly correlated with collateral held and any market risk factors impacting the transaction. Credit exposures and potential losses may increase as a result of adverse change in market conditions. The Group has various policies and procedures to control wrong-way risk, and undertaking of wrong way risk transaction would require prior approval.

## (iv) Credit-related commitments

The risks involved in credit-related commitments and contingencies are essentially the same as the credit risk involved in extending loan facilities to customers. These transactions are, therefore, subject to the same credit application, portfolio management and collateral requirements as for loan transactions.

#### (v) Concentration of credit risk

Concentration of credit risk exists when changes in geographic, economic or industry factors similarly affect groups of borrowers or market counterparties whose aggregate credit exposure is material in relation to the Group's total exposures. The Group's financial risk exposure is diversified by obligor group, industry and product, but is concentrated in Hong Kong.

Analysis of credit risk concentration of respective financial assets is disclosed in Notes 15 to 23.

#### (iv) 與信貸有關之承擔

與信貸有關之承擔及或然項目所涉及之風險基本上與向客戶提供貸款之信貸風險相同。因此,該等交易須遵守與申請貸款交易相同之信貸申請、該等貸款組合要求及抵押品規定。

#### (v) 信貸風險過分集中

當地域、經濟或行業因素之變動對不同類別之貸款人或市場交易對手產生類似影響,而彼等之信貸風險加起來對本集團之總風險而言屬重大時便會出現信貸風險過份集中之問題。本集團之金融風險已因債務人組別、行業及產品而分散,但集中於香港。

有關各類金融資產之信貸風險集中情況之分析於附註15至23內披露。

#### (vi) Credit risk mitigation

The Group's credit evaluation focuses primarily on the borrower's repayment ability from its cash flow and financial condition. In addition, the Group employs various credit risk mitigation techniques such as appropriate facility structuring, posting of collateral and/or third party support as well as transfer of risk to other third parties, which form an integral part of the credit risk management process. There is immaterial credit and market risk concentration within the credit risk mitigations used by the Group. The most commonly used credit risk mitigation measures are provided below:

#### Collateral

The Group holds collateral against loans and advances to customers mainly in the form of cash deposits, marketable securities, mortgage interest over property and guarantees. The Group has in place policies and procedures that govern the assessment, acceptance and the periodic valuation of the collateral. Collateral taken to secure corporate and retail loans is revalued periodically ranging from daily to semi-annually depending on the type of collateral. For treasury operations, collateral taken is marked to market on a periodic basis that is mutually agreed with the counterparty.

#### Master netting agreements

Collateral generally is not held over loans and advances extended to banks, except when securities are held as part of reverse repurchase and securities borrowing activity. However, where applicable, the Group manages its credit exposure to banks by entering into master netting arrangements whenever it is appropriate and feasible to do so. The netting arrangement results in the settlement of counterparty exposure on a net basis in the event a default occurs.

The Group's preferred agreement for documenting derivatives activity is the ISDA Master Agreement which covers the contractual framework within which dealing activity across a full range of over-the-counter products is conducted and contractually binds both parties to apply close-out netting across all outstanding transactions covered by an agreement if either party defaults or following other pre-agreed termination events.

It is also common for the Group to execute a Credit Support Annex in conjunction with the ISDA Master Agreement with the counterparty under which collateral is passed between the parties to mitigate the market contingent counterparty risk inherent in outstanding positions.

本集團傾向以國際掉期業務及衍生 投資工具協會(「ISDA」)總協議作為 衍生工具活動的協議文件。該協議 為買賣各種場外交易產品的交易活 動提供主體合約模式,倘若任何一 方違約或提前終止交易,則雙方受 合約約束須對協議所包含的全部未 平倉交易採用淨額結算。

有關雙方會於簽訂ISDA總協議時亦 簽訂信用擔保附件(「CSA」),此乃 普遍的做法。根據CSA,抵押品會 由交易其中一方轉交另一方,以減 低未平倉交易的市場或有交易對手 国險。

#### (b) Market risk management

Market risk arises on all market risk sensitive financial instruments, including securities, foreign exchange contracts, equity and other derivative instruments, as well as from balance sheet or structural positions. The Bank transacts in the money market, foreign exchange market, equity market and capital market giving rise to market risk exposures. Positions are taken as a result of the execution of customers' orders, and market making activities, and offsetting transactions taken in order to hedge the Bank's open position. The Bank does not engage in significant proprietary trading.

The objective of market risk management is to avoid excessive exposure of earnings and equity to loss and to reduce the Group's exposure to the volatility inherent in financial instruments.

The Board reviews and approves policies for the management of market risks including dealing authorities and limits. The Board has delegated the responsibility for ongoing general market risk management to the Asset and Liability Committee. This committee articulates the interest rate view of the Bank and decides on future business strategy with respect to interest rates. It also reviews and sets funding policy and ensures adherence to risk management objectives.

The Group has also established clear market risk policies, including limits, reporting lines and control procedures, which are reviewed regularly and approved by the Board. Market risk is managed within various limits approved by the Board. These limits are determined for each financial instrument and include limits on product volume, gross and net positions, position concentrations, mark to market limits, stop loss limits and risk position limits.

The sale of derivatives to customers as risk management products and the subsequent use of derivatives to manage the resulting position is an integral part of the Group's business activities. These instruments are also used to manage the Group's own exposures to market risk as part of its asset and liability management process. The principal derivative instruments used by the Group are interest and foreign exchange rate related contracts, which are primarily over-the-counter derivatives. The Group also purchases exchange traded derivatives. Most of the Group's derivatives positions have been entered into to meet customer demand and to hedge these and other positions.

#### (b) 市場風險管理

市場風險管理之目標為避免盈利及股本遭受過度損失及減少本集團因金融工具本身固有波幅所引申之風險。

董事會檢討及審批有關市場風險管理之 政策包括處理授權及限額事宜。董事會 已將持續一般市場風險管理之責任授予 資產負債委員會。該委員會負責因應 行對利率走勢之預測,而決定有關業務 策略。該委員會亦審閱及制訂融資政策 並確保各風險管理目標獲得遵從。

本集團亦制定清晰之市場風險政策,包括限額、報告制度及控制程序,並由董事會定期予以檢討及批准。市場風險政策在經由董事會批准之各限額內予以管理。此等限額乃就各金融工具釐定,包括就產品量、倉盤總額及淨額、倉盤限額及下額、止蝕限額及風險倉盤限額設定之限額。

#### (b) Market risk management (continued)

One of the tools used by the Group to monitor and limit market risk exposure is Value-at-risk (VAR). VAR is a technique that estimates the potential losses that could occur on risk positions as a result of movements in market rates and prices over a specified time horizon and to a given level of confidence. The calculation uses the variance-covariance model as the means to estimate the statistical confidence level.

The VAR technique is only effective for potential loss events which are not correlated. The Group therefore augments its VAR limits with other positions and sensitivity limit structures. Additionally, the Group applies a wide range of sensitivity analysis, both on individual portfolios and on the Group's consolidated positions to assess the potential impact on the Group's earnings as a result of extreme movements in market prices.

#### (i) Sensitivity analysis of market risk exposures

### Trading market risk

#### Currency risk

At 31 December 2014, if Hong Kong Dollar had strengthened by 0.5% against other currencies, with all other variables held constant, the profit before tax for the year would have been HK\$860,000 lower (2013: HK\$5,000 lower).

Conversely, if Hong Kong Dollar had weakened by 0.5% against other currencies, with all other variables held constant, the profit before tax for the year would have been HK\$860,000 higher (2013: HK\$5,000 higher).

#### Interest rate risk

The Group measures trading book interest rate risks through Present Value of Basis Point (PVBP). PVBP is a sensitivity test to measure the potential profit or loss fluctuation on interest rate positions upon a basis point movement.

The Group adopts a sensitivity test of a 100 basis points movement. At 31 December 2014, 100 basis points upward movement in interest rate would not result in a material downward profit movement (2013: Nil). Conversely, 100 basis points downward movement in interest rate would not result in a material upward profit movement (2013: Nil).

#### Equity risk

At 31 December 2014 and 2013, the Group has no equity position in its trading portfolio. As such, any movement in the Hang Seng Index would have no impact on the Group.

#### Non-trading market risk

#### Currency risk

All of the Bank's foreign currency position arises from the Bank's non-trading activities (e.g. investments, lending and deposit taking) are captured and transferred to the Financial Markets Division. The Financial Markets Division monitors these foreign currency exposures and minimizes foreign currency asset and liability mismatch by entering into foreign currency spot and forward transactions. Market Risk Management Department monitors those outstanding foreign currency positions on a daily basis and report to the Asset and Liability Committee regularly.

#### Interest rate risk

Interest rate risk primarily results from timing differences in the repricing of interest-bearing assets, liabilities and commitments. Interest rate risk is managed by the Financial Markets Division within limits approved by the Board, including interest rate gap limits. The Group also uses interest rate swaps and other derivatives to manage interest rate risk.

Structural interest rate risk arises primarily from the deployment of non-interest bearing liabilities, including shareholders' funds and current accounts, as well as from certain fixed rate loans and liabilities. Structural interest rate risk is monitored by the Asset and Liability Committee ("ALCO").

At 31 December 2014, if other market variables including prime rate were held constant, an increase in HKD market interest rates of 100 basis points would result in an increase in earnings over the next 12 months of HK\$62.5 million (2013: HK\$57 million increase), but decrease in economic value of HK\$0.5 million (2013: HK\$10.5 million decrease); while an increase in USD market interest rates of 100 basis points would result in a decrease in earnings over the next 12 months of HK\$34.5 million (2013: HK\$28 million decrease), or an increase in economic value of HK\$71 million (2013: HK\$49 million increase).

Conversely, if other market variables including prime rate were held constant, a decrease in HKD market interest rates of 100 basis points would result in a decrease in earnings over the next 12 months of HK\$62.5 million (2013: HK\$57 million decrease), but increase in economic value of HK\$0.5 million (2013: HK\$10.5 million increase); while a decrease in USD market interest rates of 100 basis points would result in an increase in earnings over the next 12 months of HK\$34.5 million respectively (2013: HK\$28 million increase), or a decrease in economic value of HK\$71 million (2013: HK\$49 million decrease).

Equity risk

At 31 December 2014 and 2013, the Group does not hold non-trading listed equity securities. As such, any movement in the Hang Seng Index would have no impact on the Group.

The Group holds non-trading unlisted equity investments and uses the net asset value reported by the management of the investee companies to determine the fair value of the investment. A sensitivity analysis on the fair value of these unlisted equity investments is disclosed in Note 46(a)(ii).

The method and assumptions used in the above sensitivity analysis on interest rate risk, currency risk and equity risk are performed on the same basis for both 2014 and 2013.

#### (ii) Analysis of currency risk exposures

The Group's foreign currency positions arise from foreign exchange dealing, commercial banking operations and structural foreign currency exposures. All foreign currency positions are managed by Financial Markets Division within limits approved by the Board. Structural foreign currency positions represents foreign currency investments in the an associate of HK\$907.1 million as of 31 December 2014 (2013: HK\$907.1 million). The Group seeks to match closely its foreign currency denominated assets with corresponding liabilities in the same currencies.

#### (c) Liquidity risk management

The purpose of liquidity management is to ensure sufficient cash flows to meet all financial commitment and to capitalise on opportunities for business expansion. This includes the Group's ability to meet deposit withdrawals either on demand or at contractual maturity, to repay borrowings as they mature, to comply with the statutory liquidity ratio, and to make new loans and investments as opportunities arise. The Group maintains a stable and diversified funding base of core retail and corporate customer deposits as well as portfolios of highly liquid assets.

It is the responsibility of the Group's management to ensure compliance with local regulatory requirements and limits set by Risk Committee of the Board ("RC"). Liquidity is managed on a daily basis by the Bank's Funding Desk Department. The Funding Desk Department is responsible for ensuring that the Group has adequate liquidity for all operations, ensuring that the funding mix is appropriate so as to avoid maturity mismatches and to minimise price and reinvestment rate risk in the case of a maturity gap, and monitoring relevant markets for the adequacy of funding and liquidity.

Compliance with liquidity and funding requirements is monitored by the ALCO and is reported to the Risk Committee of the Board on a regular basis. This process includes:

- maintaining balances within relevant regulatory requirements;
- projecting cash flows under various stress scenarios and considering the level of liquid assets necessary in relation thereto;
- monitoring balance sheet liquidity and loan to deposit ratios against internal requirements;
- maintaining a diverse range of funding sources with adequate back-up facilities;
- managing the concentration and profile of debt maturities;
- managing lending commitment to customers within predetermined limits;
- managing debt financing plans;

#### (c) 流動資金風險管理

本集團管理層的職責為確保遵守本地監管規定及董事會風險委員會(「風險委員會」)設立的限制。本行的資金部每負責金的政治的流動資金進行管理。資金的無力,確保本集團擁有充足流動資金以應付所有營運活動、確保有適當之資金組合降為與免期限錯配並在存在年期差距時降的場份。 價格及再投資利率風險並監察相關市場之資金充足性及流動性。

資金流動性及融資規定之遵守乃由資產 負債委員會監管及定期向董事會風險委 員會報告。該猧程包括:

- 一 於有關監管規定範圍內維持平衡;
- 預測各種壓力情況下的現金流量及 考慮與此有關的必要流動資產水 平;
- 依照內部規定監控資產負債流動性 及貸款對存款比率;
- 借助充足預備融資維持不同範圍的 融資資源;
- 一 管理債務期限集中度及狀況;
- 一 按預定限額管理客戶借貸承擔;
- 一 管理債務融資計劃;

- monitoring of depositor concentration in order to avoid undue reliance on large individual depositors and ensuring a satisfactory overall funding mix; and
- maintaining funding contingency plans, which identify early indicators of stress conditions and describe actions to be taken in the event of difficulties arising from systematic or other crises, while minimising adverse long-term implications for the business.
- managing liquidity on a legal entity and on a group basis.
   Intragroup funding transactions are carried out at arm's length and treated in the same way as transactions with non-related third parties.

#### Primary sources of funding

Customer deposits form a significant part of the Group's overall funding. The Group places considerable importance on the stability of these deposits, which is achieved through the Group's retail and corporate banking activities and by maintaining depositor confidence in the Group's capital strength. In order to lengthen the duration of the funding, the Group issues certificates of deposit with different maturities from time to time. Interbank markets are also accessed for the purposes of providing additional funding, maintaining a regular presence in local money markets and optimising asset and liability maturities.

#### The management of funding and liquidity risk

As part of its liquidity risk management, the Group focuses on a number of components, including maintaining sufficient liquid assets, maintaining diversified sources of liquidity, reserving necessary funding capacity and contingency planning. The Group manages liquidity risk by holding sufficient liquid assets (e.g. cash and short term funds and securities) of appropriate quality to ensure that short term funding requirements are covered within prudential limits. Debt securities held are marked to the market on daily basis to ensure their market liquidity. The Group also adopts a funding strategy that is to achieve diversification of funding by controlling the concentration of top depositors, wholesale funding and reliance on foreign exchange swap markets. Moreover, adequate standby facilities are maintained to provide strategic liquidity to meet unexpected and material cash outflows in the ordinary course of business.

In addition to observing the statutory liquidity ratio, the Group has established different liquidity risk metrics, including but not limited to the liquidity ratio, loan-to-deposit ratio, cumulative cash flow gap, concentration of funding sources and medium-term funding ratio to measure and analyse its liquidity risks. Financial Control Division is responsible for measurement and monitoring of these liquidity metrics and reporting to the ALCO regularly.

除緊守法定的流動資金比率外,本集團已設立不同的流動資金風險標準以衡量及分析流動資金風險,包括(但不限於)流動資金比率、貸存比率、累計現金流差別、資金來源集中度及中期資金比率。財務管理部負責計量及監管該等流動資金標準及定期向資產負債委員會匯報。

#### Core deposits

The Group monitors the stability of customer deposits by means of the core deposit ratio, which is the ratio of core deposits to total customer deposits. The Group categorizes customer deposits into core deposits after taking into consideration of nature of deposits, relationship history with customers and stability of customer's total balance. An alert trigger level is set on the core deposits ratio which is monitored by the ALCO.

#### Loan to deposit ratio

The Group emphasises the importance of customer deposits as a source of funds to finance lending to customers, and mitigate against reliance on short-term interbank funding. A limit on the loan to deposit ratio is established and approved by the Risk Committee of the Board and monitored by the ALCO.

#### Cash flow projection and stress testing

The Group conducts cash flow analysis and cash flow projection arising from on- and off-balance sheet items over a set of time horizons on a regular basis to identify funding needs in specific time buckets. The Group also regularly performs stress tests on its liquidity position. In the stress test, both on- and off-balance sheet items with a cash flow impact are considered, with applicable hypothetical and historical assumptions. Three stressed scenarios, namely an institution-specific crisis scenario, a general market crisis scenario, and a combined scenario are adopted with minimum survival period defined pursuant to HKMA's latest Supervisory Policy Manual "Sound Systems and Controls for Liquidity Risk Management". Stress testing assumptions are reviewed and approved by ALCO regularly to ensure their continued appropriateness.

#### **Liquidity Cushion**

The Group maintains a stock of high-quality readily liquefiable assets as a liquidity cushion against a range of stressed scenarios. The eligible assets are unencumbered, low credit risk and low market risk. The liquidity cushion is segregated from debt securities held for trading purposes. A certain portion of the liquidity cushion is made up of the most liquid and readily marketable assets (such as debt securities issued by government or multinational development banks) that can be easily liquidated to meet funding needs in the initial phase of liquidity stress.

The size of the liquidity cushion shall be adequate to meet the Group's day-to-day liquidity needs and also emergency funding needs under both normal and stress market conditions. The minimum required size of the liquidity cushion is determined with reference to the funding gap generated from the Group's regular liquidity stress testing results. Management alert triggers are established by the ALCO to ensure sufficient size of liquidity cushion is maintained and appropriate diversification among the liquidity cushion is achieved. The size and mix of the liquidity cushion is reviewed by the ALCO regularly.

#### Contingent liquidity risk

The Group provides customers with committed and standby facilities. These facilities increase the funding requirements of the Group when customers drawdown. The liquidity risk associated with the potential drawdown on non-cancellable committed facilities is factored into our stressed scenarios and a management alert trigger is set for these facilities.

#### Contingency funding plan

The Group has formulated a Contingency Funding Plan ("CFP") that describes the Group's strategy for dealing with any liquidity problem and the procedures for making up cash flow deficits in emergency situations. The CFP is designed to be pro-active and pre-emptive. The Group utilises early warning indicators, which cover both qualitative and quantitative measures, monitoring both internal and external factors. Should there be any early signs of significant impact on the Group's liquidity position the management would be informed for their consideration. Once the CFP is triggered, a Crisis Management Team, which is led by senior management, is formed to handle the crisis. Strategy and procedures in obtaining contingency funding, as well as roles and responsibilities of parties concerned are clearly stated.

The CFP is subject to regular testing to ensure its effectiveness and operational feasibility, particularly in respect of the availability of the contingency sources of funding listed in it. Moreover, the CFP is subject to review and update on a regular basis to ensure it remains robust over time. Any changes to the CFP would be approved by the Roard

#### Liquidity ratio under the Hong Kong Banking Ordinance

The Group maintained an average liquidity ratio of 48.56% for the period ended 31 Dec 2014 (2013: 48.06%), which was well above the statutory minimum ratio of 25%. The ratio is computed in accordance with the Fourth Schedule of the Hong Kong Banking Ordinance and is computed on a consolidated basis which comprises the Bank and Fubon Credit (Hong Kong) Limited as designated by the HKMA for regulatory purposes.

#### (d) Operational risk management

Operational risk refers to the risk of loss resulting from inadequate or failed internal processes, people or systems, or from external events. Given that operational risk is inherent in all business products, activities, processes and systems, the Group has developed, implemented and maintained a robust operational risk management framework to facilitate the timely identification, effective assessment and mitigation of the risk. Internal controls, an integral part of a sound operational risk management framework, are maintained by the departmental operational manuals which provide guidance on the baseline controls to ensure a well controlled and sound operating environment. Through this framework, the management oversight for risk exposures, especially in the prioritisation and allocation of limited risk mitigating resources, can further be strengthened.

The RC provides oversight of the risk management of the Group. With assistance from Internal Control and Compliance Committee ("ICC"), the RC regularly reviews the operational risk framework and approves the risk profiles and the risk management policies. The ICC also plays an active role to assist the RC in reviewing risk management reports submitted by risk management units and monitoring the implementation of mitigating measures for risk events identified and rectifications found in Control Self Assessment and Key Risk Indicator.

Operational Risk Management Department ("ORMD"), a central operational risk management function, assists management in setting corporate level policies and guidelines concerning operational risk management and controls, designing and implementing operational risk management and reporting tools, consolidating regular reports for submission to the ICC and the RC, providing operational risk management training and advising departments on operational risk management issues.

Departments are required to review their procedures regularly to ensure compliance with the internal control standards and regulatory requirements. They are also required to appoint an Internal Control Support Officer ("ICSO"), representing the department to work closely with ORMD and Compliance Department on internal control and regulatory compliance related activities and initiatives.

Each new product or service introduced is subject to a rigorous review and approval process where all relevant risks are identified and assessed by departments independent of the risk-taking unit proposing the product or services. Variations of existing products or services are also subject to a similar process. In addition, the Group maintains business continuity plans and tests contingency facilities regularly to ensure an ability to operate on an ongoing basis and limit losses in the event of severe business disruption.

Internal Audit Division and Compliance Departments play an essential role in monitoring and limiting operational risk. Their foci include evaluating the adequacy of all internal controls independently, ensuring adherence to operating guidelines (including regulatory and legal requirements) and making improvement recommendations pro-actively.

#### (d) 營運風險管理

風險委員會監察本集團的風險管理。在內部監控及合規委員會的協助下,風險管理及合規委員會的協助下,審別營運風險框架、審別別及風險管理政策。內部監控及風險管理政策,以協助風險委員會審閱由風險管理單位提交的風險管理報告及監控已識別風險事項減低措施的實施、自我監控評估中發現的待糾正事項及主要風險指標。

營運風險管理部作為管理營運風險功能,協助管理層制定有關營運風險管理及監控的企業層面政策及程序、設計並執行營運風險管理及報告工具、定期向內部監控及合規委員會及風險委員會作綜合匯報、提供營運風險管理培訓及向各部門提供有關營運風險問題的建議。

各部門須定期檢討彼等的程序以確保遵 守內部監控準則及監管規定。彼等亦須 指定一位內部監控員,以代表該部門就 內部監控及監管合規相關活動及措施與 營運風險管理部及合規部緊密合作。

各新產品或服務須進行嚴格檢閱,並於 建議該產品或服務之獨立風險管理部門 定義及評估所有相關風險完成後,可可 引進。更改現有產品或服務亦須受類似 程序限制。此外,本集團定期維持業務 連續性計劃及測試或然設備,以確保有 能力按持續基準經營及限制因嚴重業務 中斷而造成的虧損。

內部審核部及合規部門在監察及限定營運風險方面發揮關鍵作用。彼等的焦點包括獨立評估所有內部監控的充分性,確保遵守營運指引(包括監管及法定規定)以及主動提出改善建議。

#### (e) Capital management

The HKMA sets and monitors capital requirements for the Group as a whole. In addition to meeting the regulatory requirements, the Group's primary objectives when managing capital are to safeguard the Group's ability to continue as a going concern so that it can continue to provide returns for shareholders and benefits for other stakeholders, by pricing products and services commensurately with the level of risk and by securing access to finance at a reasonable cost

The Group actively and regularly reviews and manages its capital structure to maintain a balance between the higher shareholder returns that might be possible with higher levels of borrowings and the advantages and security afforded by a sound capital position, and makes adjustments to the capital structure in light of changes in economic conditions.

The Group's capital management is overseen by the ALCO and reviewed regularly by the Board of Directors. Key tools adopted include capital budgeting, monitoring, stress testing. An annual capital budget is prepared during the annual budgeting process to assess the adequacy of the Group's capital to support current and future business activities taking into account projected business growth and any new business activities. The annual budget is approved by the Board of Directors. Actual capital adequacy is measured and compared against the approved budget on a regular basis. In addition, regular stress testing and scenario analysis of major sources of risk faced by the Group is performed to assess impact on capital adequacy ratios.

The principal forms of capital are included in the following balances on the consolidated balance sheet: share capital, reserves and subordinated notes issued. Capital for regulatory purposes also includes the collective impairment allowance held in respect of advances to customers as allowed by the Banking (Capital) Rules.

The Group adopts the standardised approach for the calculation of risk-weighted assets for credit risk and market risk, and the basis indicator approach for the calculation of operational risk.

Consistent with industry practice, the Group monitors its capital structure on the basis of its capital adequacy ratio and there have been no material changes in the Group's policy on the management of capital during the year.

The Bank computes its capital adequacy ratios of the Bank and certain specified subsidiaries in accordance with the Banking (Capital) Rules of the Hong Kong Banking Ordinance. Certain non-banking financial subsidiaries are also subject to the supervision and capital requirements of local regulatory authorities. The Group regularly measures and monitors capital adequacy of these regulated subsidiaries.

The Group and its individually regulated operations have complied with all externally imposed capital requirements throughout the years ended 31 December 2014 and 2013, and were above the minimum required ratio set by the HKMA.

#### (e) 資本管理

金管局設立及監管本集團之整體資本規定。除達至監管規定外,本集團管理資本之主要目標為保證本集團之持續經營能力,從而透過與風險水平相當之產品與服務定價及確保能夠以合理成本融資,持續為股東提供回報及向其他權益持有人提供利益。

本集團積極及定期審閱及管理其資本結構,並在可能以高借貸水平所產生的較高股東回報,以及良好資本狀況所提供之優勢與擔保之間保持平衡,並就經濟狀況之變動對資本結構作出調整。

資本的主要形式包括以下於綜合資產負債表的餘額:股本、儲備及已發行後償票據。就監管目的而言,資本亦包括《銀行業(資本)規則》所允許的就客戶貸款所持有之綜合減值撥備。

本集團採用標準化方法計算信貸風險及 市場風險之風險加權資產以及採用基本 指標方法計算營運風險。

為遵守行業慣例,本集團根據資本充足 比率監管其資本結構,年內本集團之資 本管理政策並無重大變動。

本行根據香港《銀行業條例》的《銀行業 (資本)規則》計算本行及若干指定附屬公司的資本充足比率。若干非銀行金融附屬公司亦須遵守當地監管機構的監督及資本規定。本集團定期計量及監管該等受監管附屬公司的資本充足性。

截至二零一四年及二零一三年十二月三 十一日止整個年度本集團及其自主監管 業務均符合全部外在施加之資本規定, 並高於金管局頒佈之最低比率規定。

#### (f) Transfers of financial assets

As of 31 December 2014, the Group entered into repurchase agreements with certain banks to sell available-for-sale financial assets of carrying amount of HK\$7,939.7 million (2013: HK\$5,418.1 million) which are subject to the simultaneous agreements ("repurchase agreements") to repurchase these financial assets at agreed dates and prices. The consideration received under these repurchase agreement totalling HK\$7,626.8 million (2013: HK\$5,213.3 million) was reported as "Deposits and balances of banks" at 31 December 2014 (Note 29).

As stipulated in the repurchase agreements, there was no transfer of the legal ownership of these financial assets to the counterparty banks during the covered period. However, the Group was not allowed to sell or pledge these financial assets during the covered period unless both parties mutually agree with such arrangement. Accordingly, these financial assets were not derecognised from the financial statements but regarded as "collateral" for the secured lending from these counterparty banks. Normally, the counterparty banks could only claim from the collateral when there exists an event of default on the secured lending.

As at 31 December 2014 and 2013, there were no outstanding transferred financial assets in which the Group had a continuing involvement, that were derecognised in their entirety.

# 50. IMMEDIATE PARENT AND ULTIMATE CONTROLLING PARTY

At 31 December 2014, the directors consider the immediate parent and ultimate controlling party of the Group is Fubon Financial Holding Company Limited, which is incorporated in the Republic of China.

#### 49. 財務風險管理(續)

#### (f) 金融資產轉讓

截至二零一四年十二月三十一日,本集團與若干銀行訂立回購協議以出售賬面值7,939,700,000港元(二零一三年:5,418,100,000港元)之可供出售金融資產,並受限於在協定日期及以協定價格回購該等金融資產之同步協議(「回購協議」)。根據該等回購協議收取之代價總額7,626,800,000港元(二零一三年:5,213,300,000港元)於二零一四年十二月三十一日列作「銀行同業之存款及結餘」(附註29)。

如回購協議所規定,於覆蓋期間並無轉讓該等金融資產之法律所有權至對手銀行。然而,本集團於覆蓋期間並不允允告或抵押該等金融資產,除非訂款協議。因此,該等金融資產並無於財務報告終止確認但被視作該等對手銀行提供有抵押借貸之「抵押品」。對手銀行一般只有在有抵押借貸布建約事件時才會索償抵押品。

於二零一四年及二零一三年十二月三十 一日,既有已轉讓金融資產已全部終止 確認,且本集團並無持續牽涉其中。

#### 50. 直接母公司及最終控股公司

於二零一四年十二月三十一日,董事認為,本 集團的直接母公司及最終控股方為富邦金融 控股股份有限公司。該公司於中華民國註冊成 立。

#### 51. ACCOUNTING ESTIMATES AND JUDGEMENTS

In preparing these financial statements, certain assumptions and estimates have been made by management of the Group. The accuracy of these assumptions and estimates are continuously reviewed by management with reference to actual results, historical experience and other factors, including projection of future cash flows and possible outcomes from future events. Management believes that the assumptions and estimates made are reasonable and supportable.

Notes 26 and 46 contain information about the assumptions and risk factors relating to fair value of bank premises and financial instruments. Other key sources of estimation uncertainty are as follows:

#### (a) Impairment losses

#### Advances to customers

Loan portfolios are reviewed periodically to assess whether impairment losses exist. Management makes judgements as to whether there is any objective evidence that a loan portfolio is impaired, i.e. whether there is a decrease in estimated future cash flows. Objective evidence of impairment includes observable data that the payment status of borrowers in a group has adversely changed. It may also include observable data of local economic conditions that correlate with defaults on the assets in the group. If management has determined, based on their judgement, that objective evidence for impairment exists, expected future cash flows are estimated based on historical loss experience for assets with credit risk characteristics similar to those of the group. Historical loss experience is adjusted on the basis of current observable data.

Management reviews the methodology and assumptions used in estimating future cash flows regularly to reduce any difference between loss estimates and actual loss experience.

In assessing the need for a collective impairment allowance, besides factors such as credit quality, portfolio size, concentrations, management also considers economic factors. In order to estimate the required adjustment to the collective impairment allowance from economic factors, the Group makes assumptions and judgements to determine the relevant economic indicators and their relevant weighting based on historical experience and current economic conditions.

#### Available-for-sale equity securities

The Group determines that available-for-sale equity securities are impaired when there has been a significant or prolonged decline in the fair value below cost. The determination of when a decline in fair value is significant or prolonged is judgmental by nature so profit and loss could be affected by differences in this judgment.

#### (a) 減值虧損

管理層定期對估計未來現金流量所使用 之方法及假設進行檢討以減少虧損估計 與實際損失之間之差異。

於評估綜合減值撥備的需要時,管理層除考慮信貸素質、組合規模、信貸集中等因素外,亦需一併考慮經濟因素。為估計經濟因素對所需綜合減值撥備的影響,本集團根據過往經驗及現今經濟情況對相關經濟指標及其他所佔比重作出估計及判斷。

# 可供出售股本證券

於公平價值出現重大或持續下跌至低於 成本數額時,本集團確定可供出售股本 證券減值。確定何時公平價值的下跌屬 重大或持續時須按其性質予以判斷,故 溢利及虧損可能因所作判斷之差異而受 到影響。

#### (b) Fair value determination

The Group determines the fair values of financial assets and liabilities which are carried at fair value based on quoted market prices whenever possible. If such quoted market prices are not available or an active market does not exist, the Group determines the fair values based on internally developed models which make use of market parameters, including interest rate yield curves, historical and/or implied option volatilities, currency rates, prices of the underlying instruments, and the net assets of the underlying investments. Model assumptions and correlation among these parameters can affect the estimates of the fair values of these financial instruments.

#### (c) Held-to-maturity investments

The Group classifies non-derivative financial assets with fixed or determinable payments and fixed maturity which the Group has a positive intention and ability to hold to maturity as held-to-maturity investments. In making this judgement, the Group evaluates its intention and ability to hold such investments till maturity.

If the Group fails to hold these investments to maturity other than in certain specific circumstances, the Group will have to reclassify the entire portfolio of held-to-maturity investments as available-for-sale.

This would result in held-to-maturity investments being measured at fair value instead of at amortised cost.

#### (d) Other accounting estimates

Judgement has been exercised in determining the amount which may be payable to customers in respect of complaints or legal claims arising from the sale of investment products and establishing a reserve included in other liabilities. A charge has been recognised in profit or loss representing amounts paid and an estimate of future amounts which could be payable.

## 52. EVENTS AFTER THE BALANCE SHEET DATE

#### Non-adjusting post balance sheet event

On 12 January 2015, the Bank completed an acquisition of 42,803,987 shares of XBCL, an associate of the Group, from two independent third parties at a total consideration of RMB192,617,000. The Group's equity holding increased from 17.29% to 19.99% of the capital of XBCL after the acquisition.

The Group is in the process of making assessment of what the impact of these amendments is expected to be in the period of initial application. So far it has concluded that the adoption of them is unlikely to have a significant impact on the consolidated financial statements except for the following:

Amendments to HKAS 19, Defined benefit plans: Employee contributions

These amendments clarify how an entity should account for contributions to defined benefit plans made by employees or third parties that are linked to services, based on whether those contributions are dependent on the number of years of service provided by the employee.

#### HKFRS 9, Financial instruments

In September 2014, the HKICPA issued HKFRS 9 'Financial Instruments', which is the comprehensive standard to replace HKAS 39, and includes requirements for classification and measurement of financial assets and liabilities, impairment of financial assets and hedge accounting. The main changes to the requirements of HKAS 39 are summarised below.

Classification and measurement of financial assets and liabilities:

All financial assets are classified into two measurement categories: amortised cost or fair value on the basis of both an entity's business model for managing groups of financial assets and the contractual cash flow characteristics of the individual assets. These two categories replace the four categories under the current HKAS 39.

Financial assets are measured at fair value through profit or loss, if they do not meet the criteria specified for measurement at amortised cost or if doing so significantly reduces or eliminates an accounting mismatch. An entity has the option to designate all subsequent changes in fair value of an equity instrument not held for trading at fair value through other comprehensive income with no recycling of gains or losses to the income statement. Dividend income would continue to be recognised in the income statement.

Financial assets which contain embedded derivatives are to be classified in their entirety either at fair value or amortised cost depending on whether the contracts as a whole meet the relevant criteria under HKFRS 9.

HKFRS 9 retains all the existing requirements for derecognition of financial instruments and most of the requirements for financial liabilities, except that for financial liabilities designated under the fair value option other than loan commitments and financial guarantee contracts, fair value changes attributable to changes in own credit risk are to be presented in the statement of other comprehensive income, and are not subsequently reclassified to income statement but may be transferred within equity.

Impairment of financial assets:

The impairment requirements apply to financial assets measured at amortised cost and fair value through other comprehensive income, and lease receivables and certain loan commitments and financial guarantee contracts. At initial recognition, allowance (or provision in the case of commitments and guarantees) is required for expected credit losses resulting from default events that are possible within the next 12 months. In the event of a significant increase in credit risk, allowance (or provision) is required for expected credit losses resulting from all possible default events over the expected life of the financial instrument.

The assessment of whether credit risk has increased significantly since initial recognition is performed for each reporting period by considering the change in the risk of default occurring over the remaining life of the financial instrument. The assessment of credit risk, and the estimation of expected credit losses, shall be an unbiased and probability-weighted amount that is determined by evaluating a range of possible outcomes. It shall also take into account the time value of money and reflect reasonable and supportable information that is available without undue cost or effort at the reporting date about past events, current conditions and forecasts of future economic conditions.

Hedge accounting requirements in HKFRS 9 align hedge accounting more closely with risk management, establish a more principle-based approach to hedge accounting and address inconsistencies and weaknesses in the hedge accounting model in HKAS 39. The standard does not explicitly address macro hedge accounting strategies, which are being considered in a separate project. To remove the risk of any conflict between existing macro hedge accounting practice and the new general hedge accounting requirements, HKFRS 9 includes an accounting policy choice to remain with hedge accounting under HKAS 39.

The Group is currently assessing the impact on the implementation of HKFRS 9 as a whole on its mandatory application date of 1 January 2018, but due to the complexity of the classification and measurement, impairment, and hedge accounting requirements and their interrelationships, it is not possible to quantify the potential effect at this stage.

In addition, the requirements of Part 9, "Accounts and Audit", of the new Hong Kong Companies Ordinance (Cap. 622) come into operation from the Group's first financial year commencing after 3 March 2014 (i.e. the company's financial year which began on 1 January 2015) in accordance with section 358 of that Ordinance. The Group is in the process of making an assessment of the expected impact of the changes in the Companies Ordinance on the consolidated financial statements in the period of initial application of Part 9. So far it has concluded that the impact is unlikely to be significant and will primarily only affect the presentation and disclosure of information in the consolidated financial statements.

#### (ii) Counterparty credit risk-related exposures for derivatives

Credit risk for derivatives is the positive replacement cost together with an estimate for the potential future exposure from changes in market value. These credit exposures are managed as part of the overall credit limits to the counterparties. The Bank uses the current exposure method for the purpose of providing capital for such counterparty exposures.

Wrong way risk occurs when the credit exposure to a counterparty is strongly correlated with collateral held and any market risk factors impacting the transaction. Credit exposures and potential losses may increase as a result of adverse change in market conditions. The Bank has various policies and procedures to control wrong-way risk, and undertaking of wrong way risk transaction would require prior approval.

Under the terms of our current collateral obligations under derivative contracts, we estimate based on the positions as at 31 December 2014 and 31 December 2013 that the Bank would be required to post additional collateral of HK\$25.7 million and HK\$4.0 million, respectively, in the event of one notch downgrade in the Bank's credit ratings.

The following tables summaries the Group's main default risk exposures which arise from securities financing transactions and derivative contracts, which are calculated using the current exposure method.

## (J) ADDITIONAL DISCLOSURES ON EQUITY EXPOSURES IN BANKING BOOK

Equity holdings taken by the Group are differentiated between those taken for strategic reasons and those for long term investment for capital gains. Equity holdings taken for strategic reasons include the Group's investment in companies providing financial services which nourish the spectrum of the Bank's banking services. These include provident fund services provision, electronic payment services provision, and e-banking infrastructure and platform provision. All these investments are classified as "available-for-sale financial assets" and measured at fair value as described in Notes 2(g) and 46.

## (K) ADDITIONAL DISCLOSURES ON RISK MANAGEMENT ON INTEREST RATE EXPOSURES IN BANKING BOOK

In accordance with the prudential return "Interest Rate Risk Exposures" issued by the HKMA, the Bank calculates, on a quarterly basis, the impact on earnings over the next 12 months under a scenario of which all interest rates other than prime rises 200 basis points.

As at 31 December 2014, the 200 basis points interest rate rise would increase earnings over the next 12 months on the HKD interest risk positions by HK\$125 million (2013: HK\$114 million) and decrease earnings over the next 12 months on the USD interest risk positions by HK\$69 million (2013: HK\$56 million).

#### (L) CORPORATE GOVERNANCE

The Bank is committed to high standards of corporate governance, and has fully complied throughout the year with the guidelines on "Corporate Governance of Locally Incorporated Authorised Institutions" and "Guideline on a Sound Remuneration System" issued by the HKMA.

## (L) 企業管治

## (M) KEY COMMITTEES

The Board of Directors has established five Board Committees to assist it in carrying out its responsibilities comprising the Audit Committee, Nomination and Remuneration Committee, Risk Committee, Executive Credit Committee and Executive Committee. In addition, a number of management level committees have been set up by the Board to oversee the effectiveness of the Bank's daily operations including, the Management Committee, Asset and Liability Committee, Internal Control and Compliance Committee, Credit Committee and Wholesale Credit Committee. The composition and function of these committees are set out below:

#### (i) Audit Committee

The Audit Committee comprises three members including one Non-Executive Director and two Independent Non-Executive Directors. The Audit Committee is chaired by an Independent Non-Executive Director who has appropriate accounting professional qualifications. The Committee meets at least four times a year and additionally when deemed necessary.

The Audit Committee is required to ensure that there is adequate supervision of the Bank's financial reporting processes, systems of internal control, that the internal audit function is effective and backed by adequate resources and has appropriate standing within the Bank. It is also required to ensure that there is coordination between the internal and external auditors, to monitor compliance with internal policies, statutory regulation and to consider recommendations made by the internal and external auditors.

The Audit Committee has to review the Bank's financial reporting process, the systems of internal control, the internal audit function and the risk management process. In particular, the review undertaken by the Audit Committee on the internal audit function includes the Internal Audit Charter and its approval, the annual audit plan, internal audit reports and special investigation reports issued, and ensuring that appropriate management actions are taken following the major audit findings.

The Audit Committee has also to review the appointment of external auditors and to discuss with them the nature and scope of their audits. The Audit Committee will also review the interim and annual financial statements before recommending them to the Board for approval.

#### (M) 主要委員會

審核委員會須檢討本行之財務報告程序、內部監控系統、內部審核職能及風險管理程序。特別是檢討內部審核職能方面,審核委員會的檢討範圍包括內部審核報告及其批准、年度審核計劃、已發佈之內部審核報告及特別調查報告及特別調查報告及保證於重大審核結果後採取合適管理行動。

審核委員會亦對外聘核數師之委任進行檢討,並與其就審計之性質及範圍進行討論。審核委員會亦將於向董事會建議 批准中期及年度財務報告之前審閱有關報告。

## (M) KEY COMMITTEES (continued)

#### (ii) Nomination and Remuneration Committee

The Nomination and Remuneration Committee comprises the Non-Executive Chairman, Non-Executive Vice Chairman and three Independent Non-Executive Directors of the Bank. The Committee meets periodically and as required and provides oversight of the management of the Bank's human resources including the appointment of directors and the Chief Executive Officer & Managing Director ("CEO"). The Committee has to establish the Bank's overall human resources management framework to ensure that the Bank is in compliance with the applicable government regulations and follows the market best practice whenever possible. The Committee is also responsible to ensure that directors and the CEO appointed possess the necessary and appropriate qualifications to perform and discharge their duties.

The Committee regularly reviews whether each existing Director continues to remain qualified for his post. It also reviews the structure, size and composition of the Board and makes recommendations on any proposed change to the Board.

The Committee reviews and approves the remuneration of Directors, members of board-level committees and Senior Management (as defined under the Remuneration Policy of the Bank).

#### (iii) Risk Committee

The Risk Committee comprises five members including two Non-Executive Directors, two Independent Non-Executive Directors and one Executive Director. The Committee meets at least four times a year and additionally when deemed necessary. Its mandate is to establish the Bank's overall risk appetite and risk management framework, and to oversee Senior Management's implementation of the Bank's risk policies.

The Risk Committee will review annually the Bank's risk appetite statement and risk management strategy. It will ensure that an appropriate infrastructure, adequate resources and systems are in place for risk identification, risk assessment, risk monitoring and overall risk management. It is also required to provide oversight of the Bank's risk activities and ensure it is in compliance with all relevant legal and regulatory requirements and that the best practices are adopted by the Bank wherever feasible.

The Risk Committee is required to ensure that the staff responsible for implementing risk management systems and controls perform their duties independent of those involved in the Bank's risk taking activities.

該委員會定期審查是否每位現任董事繼續符合資格擔任其職務。其亦審查董事會結構、規模及組成並就董事會任何建議變動作出推薦建議。

該委員會審閱及批准董事、董事會級別 委員會及高級管理層成員的的薪酬(定義 見本行薪酬政策)。

#### (iii) 風險委員會

風險委員會由五名成員組成,包括兩名 非執行董事、兩名獨立非執行董事及一 名執行董事。該委員會每年舉行四次會 議並在視作必要時舉行額外會議。其職 責為建立本行的整體風險承受能力及風 險管理框架,以及監管高級管理層實施 本行的風險政策。

風險委員會將每年審查本行的風險承受能力聲明及風險管理策略。其將確保針對風險識別、風險評估、風險監管及整體風險管理的適當基礎設施、充足資源及系統均就緒。其亦須監查本行的風險活動及確保遵守所有有關法律及監管規定以及本行於可行情況下採納最佳慣例。

風險委員會須確保負責實施風險管理系 統及控制的員工獨立於涉及本行風險活 動的員工之外履行彼等的職責。

#### (iv) Executive Committee

The Executive Committee comprises the Non-Executive Chairman, Non-Executive Vice Chairman and the CEO of the Bank. It will exercise the powers and authority delegated by the Board from time to time concerning the management and day-to-day running of the Bank. The Executive Committee will meet periodically and as required and will operate as a general management function under the auspices of the Board.

#### (v) Executive Credit Committee

The Executive Credit Committee comprises the Non-Executive Chairman, Non-Executive Vice Chairman and the CEO of the Bank. It has the delegated authority to approve credit referrals or credit related matters which require the approval of the Board. The Executive Credit Committee will meet as required to review and approve requests for customer credit facilities that require the approval of the Board. The Executive Credit Committee will approve the Bank's credit policies and overall credit risk profile.

#### (vi) Management Committee

The Management Committee is chaired by the Bank's CEO, and comprises senior management personnel as appointed by the CEO. The Management Committee is the key decision making body for the Bank and is responsible mainly for the running of the Bank's day to day business under the authority delegated by the Board and within the strategy and business plan as approved by the Board. This Committee is also responsible for the formulation of the Bank's business strategies and major bank-wide initiatives for the Board's approval. The Management Committee meets at least once a month to evaluate and approve new business proposals, coordinate among business and support units during the implementation process, monitor the implementation of the approved business strategies and bank-wide initiatives, review the achievement of business targets and objectives and the financial performance of the Bank.

#### (vii) Asset and Liability Committee

The Asset and Liability Committee ("ALCO") comprises the CEO, Chief Financial Officer and senior management personnel as appointed by the CEO. The committee is responsible for providing oversight of the Bank's operations relating to interest rate risk, market risk and liquidity risk (collectively known as "financial risks") as well as capital management. The committee initiates, reviews and endorses for the Risk Committee of the Board's approval the Bank's policies on financial risks and capital management. It approves guidelines relating to such policies, reviews and approves all major financial risk management reports. ALCO also oversees the Bank's investment activities by establishing investment strategies within policies laid down by the Board and reviews actual performance.

#### (viii) Internal Control and Compliance Committee

The Internal Control and Compliance Committee ("ICC") comprises the Bank's CEO, Chief Financial Officer, Head of Control & Risk Management and the heads of different control, business and support functions. The responsibilities of the Committee include providing oversight of the Bank's exposure to operational and legal risks, overseeing the Bank's compliance and anti-money laundering ("AML") activities, ensuring the Bank has in place an effective internal control and compliance framework, assisting the Risk Committee in establishing a sound internal control and monitoring system to ensure overall compliance within the Bank.

To ensure an effective internal control and compliance framework is in place, the ICC reviews policies and approves guidelines relating to control and compliance risks, receives and discusses reports submitted by various risk management units and promotes internal control and compliance culture. To maintain the Bank's overall compliance standards, the ICC reviews and discusses major compliance or AML or operational risk events, latest developments in statutory or regulatory requirements applicable to bank, progress of implementation of new statutory or regulatory compliance requirements and progress of rectification of audit findings.

#### (ix) Credit Committee

The Credit Committee ("CC") meets weekly and its mandate is to provide oversight of the Bank's credit risk management. The committee is chaired by the Bank's CEO, and consists of senior executives of the Bank, all are members of the Management Committee

The CC reviews and endorses credit policies and credit risk profile of the bank for the Executive Credit Committee ("ECC")'s approval, and reviews and approves credit related guidelines. The Committee also reviews and approves requests for credit facilities that are within the CC's authority as delegated by the Board, and reviews and endorses requests before their submission to the ECC for approval.

The CC will also conduct on-going reviews on the market environment and make necessary policy recommendations to the ECC to ensure the credit risk profile of the Bank is within the established risk appetite. In this regard, the CC will provide periodic and timely credit related management and stress testing reports to the ECC for review.

## (x) Wholesale Credit Committee

The Wholesale Credit Committee ("WCC") is chaired by the Head of Control and Risk Management Division of the Bank, and comprises senior officers of the Bank. It meets weekly to review and approve request for corporate and commercial credit facilities that are within its authority as delegated by the Board.

#### (ix) 信貸委員會

信貸委員會每周會晤且其授權為監查本 行的信貸風險管理。該委員會由本行行 政總裁任主席,由本行高級行政人員組 成,且均為管理委員會的成員。

信貸委員會審閱及批准本行信貸政策及 信貸風險狀況,以供執行信貸委員會批 准,以及審閱及批准信貸相關指引。該 委員會亦在董事會授予信貸委員會的授 權內審閱及批准信貸融資要求,及審閱 及同意要求,再提交執行信貸委員會以 供批准。

信貸委員會亦將對市場環境進行持續檢討,並向執行信貸委員會作出必要的政策建議,以確保本行的信貸風險狀況在設定的風險取向範疇內。就此而言,信貸委員會將定期及及時向執行信貸委員會提供信貸相關管理及壓力測試報告以供審閱。

## (x) 批發信貸委員會

批發信貸委員會由本行監制及風險管理 部門主管任主席,由本行的高級行政人 員組成。該委員會每週會晤以在董事會 授予之授權範圍內審閱及批准企業及商 業信貸融資請求。

#### (N) DISCLOSURE ON REMUNERATION

#### **General**

The Bank's remuneration system is applicable to all staff of the Bank and its subsidiaries. During the financial year, the Nomination and Remuneration Committee reviewed and approved, inter alia, the Bank's Remuneration Policy.

The Bank's remuneration system is based on the following principles:

- alignment of compensation to its profitability, risk and capital;
- maximization of employees' and the Bank's performance;
- attraction and retention of talent and skilled staff; and
- calibration to the differing needs of each division and staff's levels of responsibility.

The remuneration packages of the Bank's staff may comprise fixed and variable components which are structured to reflect the prevailing context in which the Bank operates and the Bank's intended performance. Fixed pay includes base salary, fixed allowance and year-end double pay, while variable pay may cover sales incentives, year-end discretionary bonus and share options. The use of different variable pay forms depends on a number of factors such as the appropriateness of the forms in coping with the long and short term business goals of the Bank, staff retention and risk factors. Deferment mechanism on variable pay will be implemented if the staff member's variable pay in cash exceeds the pre-determined thresholds. The deferment period for the excess portion of the variable pay in cash will be 6 months for general staff and 36 months for Senior Management reflecting their relative responsibilities and role. The award of deferred variable pay in cash should also be subject to pre-defined conditions such as the performance and behaviour of the staff member concerned. In addition, a clawback mechanism may be applied in specific circumstances related to the staff member's individual performance.

The Nomination and Remuneration Committee when considering the budget for salary increase will take into account a number of factors including, but not limited to, latest market and industry practice, yearly inflation rate, the results of annual surveys on trends in pay and salary adjustments made in the last financial year. The salary increase budget will be approved by the Nomination and Remuneration Committee and the salary increase for individual staff members will be determined by the CEO taking into consideration performance of the relevant staff, latest market situation and industry practice and any pertinent reasons for the recommendation which may be relevant.

- yearly inflation rate;
- the results of annual surveys on trends in pay;
- performance of the relevant staff; and
- attraction and retention of talent.

Note i Senior Management refers to those senior executives whose performances have significant impact on the Bank's operations and results. They include the following positions:

- Managing Director/Chief Executive
- Alternate Chief Executive
- Executive Director
- Executive Vice President
- Management Committee Member

Note ii Key Personnel refers to those executives other than Senior Management who are engaged in trading and dealing activities which involve the assumption of material risk or the taking on of material exposures on behalf of the Bank. In the financial year, the Bank did not have such personnel.

## (O) MARKET RISK MANAGEMENT

Details of the Group's market risk management policies and measures have been set out in Note 49(b).

The Group calculates VAR with a confidence level of 99%, a holding period of one trading day and using a 1-year historical observation period. The VAR methodology adopted by the Group is historical simulation approach. Historical simulation uses scenarios derived from historical market rates/prices and takes account of the relationships between different markets and rates. The VAR model is helpful in measuring the bank's exposure to day-to-day market fluctuations. It is not intended to measure the bank's exposure to individually significant events such as the bankruptcy of a major financial institution.

The Group has measured VAR for all material trading portfolios. The VAR results as shown in the below table are calculated independently according to the underlying positions, and historical market movements.

The Group adopts a prudent approach to managing its trading portfolios, and reduces any excessive market risk by executing offsetting transactions or hedging contracts with other market counterparties. Market risk ensues once the Group takes positions in markets such as foreign exchange, interest rates, securities and equities. Such positions are driven by execution of customer orders, proprietary trading and hedging.




## Daily Distribution of Trading Revenue for the Year Ended 31 December 2014

This shows a maximum daily loss of HK\$493,501 (2013: HK\$973,621) with 45 days (2013: 56 days) out of 247 days (2013: 250 days) showing losses. - A robust organization structure with clearly defined responsibilities and delegation management
- A strong internal control framework with clearly defined segregation of duties that reflects best market practice
- A strong compliance and anti-money laundering culture supported by an appropriate framework
