

Fubon Bank (Hong Kong) Limited (the “Bank”)
Notice of Amendment to “Terms and Conditions for Fubon Business Online Service”

With effect from 14 November 2016 (“Effective Date”), the “Terms and Conditions for Fubon Business Online Service” (the “Terms and Conditions”) of the Bank will be revised. Details are as follows:

A. Clause 1 - DEFINITIONS

1. Deletion of “Digital Certificate” and “PKI Token”
(Delete the terms of digital certificate in view of their inapplicability)
2. Change the heading from “OTP” to “Security Code”
3. Amendment of “Password”
(Rephrase the terms to make them more precise due to the deletion of digital certificate)

B. Clause 4 - SYSTEM ADMINISTRATOR AND USER

1. Amendment of Clause 4.1(f) (ii) for accepting payees by a user
2. Deletion of Clause 4.1(f) (iv)
(Delete the terms of OTP in view of their inapplicability)
3. Amendment of Clause 4.4(b) for confirming the identity of the Customer by Security Device
4. Deletion of Clause 4.4(d)
(Delete the terms of OTP in view of their inapplicability)
5. Amendment of Clause 4.5(c) for adding/amending the particulars of payees

C. Clause 5 - SECURITY DEVICE

1. Change the heading from “DIGITAL CERTIFICATES” to “SECURITY DEVICE”
2. Deletion of Clause 5.2, 5.4 -5.6 and 5.8. Rearrange the numbering of Clause 5.3 to 5.2; Clause 5.7 to 5.3 and Clause 5.9 to 5.4.
(Delete the terms of digital certificate in view of their inapplicability)
3. Amendment of Clause 5.2 – 5.4
(Rephrase the terms to make them more precise due to the deletion of digital certificate)
4. Addition of Clause 5.5 for the purpose of the security device

D. Clause 6 - AUTHORIZATION TO THIRD PARTIES

1. Deletion of original Clause 6 – ONE-TIME PASSWORD and rearrange the numbering of Clauses 7-19 in original Terms and Conditions to Clauses 6-18
2. Amendment of Clause 6.1 for the application of authorized person

E. Clause 8 - SECURITY MEASURES

1. Amendment of Clause 8.1 for security device
(Rephrase the terms to make them more precise due to the deletion of digital certificate, PKI token and OTP)

F. Clause 9 - UNDERTAKINGS AND LIABILITIES OF THE CUSTOMER

1. Amendment of Clause 9.5 for security device
(Rephrase the terms to make them more precise due to the deletion of digital certificate, PKI token and OTP)

G. Clause 10 - DISCLAIMERS AND LIABILITIES OF THE BANK

1. Amendment of Clause 10.5 for liability
(Rephrase the terms to make them more precise)
2. Amendment of Clause 10.6 for loss or damage
(Rephrase the terms to make them more precise due to the deletion of digital certificate)

Please note that the above amendments shall be binding on you if you continue using the relevant banking services on or after the Effective Date. The Bank may however not be able to continue providing the relevant banking services to you if you do not accept the above amendments. Please refer to the applicable terms and conditions and notify the Bank to terminate the Service(s) in accordance with your right of termination provided in the “Terms and Conditions for Fubon Business Online Service” before the Effective Date if you do not accept the above amendments.
