

Notice of Amendment to List of Service Charges for Retail Banking Services

With effect from 10 October 2017 ("Effective Date"), Fubon Bank (Hong Kong) Limited (the "Bank") will revise its service charges and/or the remarks therein (as underlined below) and also introduce the new service charges for Retail Banking Services, details are as follows:
