Notice of Amendment of "Fubon JETCO Pay Terms and Conditions"

Please note that Fubon Bank (Hong Kong) Limited (the "Bank") will amend the "Fubon JETCO Pay Terms and Conditions" as below:

First, the Bank will soon increase the daily fund transfer maximum limit for Fubon JETCO Pay to HKD10,000. "Fubon JETCO Pay Terms and Conditions" will be revised as follows:

Please refer to the applicable terms and conditions and notify the Bank to terminate the service(s) based on the customer's right of termination pursuant to the "Fubon JETCO Pay Terms and Conditions".
