

## Notice of Amendment to List of Service Charges of Fubon Bank

With effect from 10 December 2018 (“Effective Date”), Fubon Bank (Hong Kong) Limited (the “Bank”) will revise its service charges and/or the remarks therein and also introduce the new service charges (expired contents are strikethrough and new contents are underlined below) as below:

In addition, if customers apply cheque book via the Bank's branches, maximum number of books per order is 2 books for Personal Customer and 5 books per order for Corporate Customer.
- (2) Withdrawal of notes is subject to availability and pre-arrangement may be required.
- (3) Initial deposit amount for all types of Corporate Account is HK\$50,000.
- (4) The definition of "Overseas/Special Company" is (1) Overseas company not registered in Hong Kong under Part 16 of Companies Ordinance (applicable to limited companies only) and the Business Registration Ordinance; or (2) Hong Kong incorporated company with corporate shareholder(s) and/or corporate director(s) that are incorporated overseas; or (3) Hong Kong incorporated company with 4-layer structure or above.
- (5) This includes all overdraft and loan secured against pledged deposit, insurance policy and wealth management products.
