


 **Limited-Time AUD Inward Remittance**

The balance of all accounts, including Savings Accounts, Current Accounts and Time Deposits of the same currency of sole name account will be counted towards the calculation of "Eligible New Fund ". Fubon Bank reserves the right of final decision should there be any dispute in the definition of "Eligible New Fund".


 **General Terms & Conditions:**

 - b) Place a new AUD time deposit account via branch or Fubon+ mobile app, with a minimum deposit equivalent to AUD 100,000 or above; and
 - c) Hold a valid Fubon magi©Money Manager HKD interest-bearing current account OR a Fubon HKD Statement Savings Account.
4. Each eligible customer shall only be entitled to "Cash Reward" HKD500 once under this promotion.
