

“Fubon Bank Extra Rewards for Credit Card Application” Promotion Terms and Conditions

1. The “Fubon Bank Extra Rewards for Credit Card Application” Promotion (“Promotion”) runs from 24 August 2026 to 30 September 2026, both dates inclusive (“Promotion Period”).
2. During the Promotion Period, customers who fulfill the following conditions shall be eligible to receive an extra HK\$200 cash rebate (“Extra Cash Rebate”):
 - i. Successfully submit an application for the Fubon iN ShopBack Visa Platinum Credit Card (“Eligible Credit Card”) issued by Fubon Bank (Hong Kong) Limited (“the Bank”) via the Fubon GO mobile application or the Bank website, and enter the promotional code “FBAD26” (“Designated Promotional Code”) in the Promotional Code/Referral Code field;
AND
 - ii. the application is approved by the Bank; **AND**
 - iii. Successfully activate the Eligible Credit Card within one month of card issuance.
3. For the purpose of this Promotion, Extra Cash Rebate are the designated rebate or reward independent of other welcome reward(s) or gift(s) which may be applicable to the Eligible Credit Card. For the avoidance of doubt, the eligibility criteria, terms and conditions applicable to any other welcome gifts are separately provided and not covered under this Promotion. The grant of the Extra Cash Rebate does not necessarily entitle the customer to any other welcome reward(s) or gift(s), and vice versa. 4. “Eligible Customers” refers to customers who, at the time of submitting the Eligible Credit Card application and during the preceding six months, have not held any credit card of co-branded card issued by the Bank, including supplementary cards.
5. Each customer is eligible to receive the Extra Cash Rebate only once during the Promotion Period.
6. The Promotion is **subject to limited quotas of 500 units. Quotas are allocated on a first-come, first-served basis based on the completion of all eligibility conditions. The Bank will not notify customers of the remaining quota.**
7. The following classes of customers are not eligible for this Promotion: (i) joint account holders; (ii) corporate account holders; and (iii) individual customers who do not submit their Eligible Credit Card applications via Fubon GO or the Fubon Credit Card online application webpage and input the Designated Promotional Code.
8. Subject to the Bank’s verification and determination on eligibility, the Extra Cash Rebate will be credited to that Eligible Credit Card account on or before 31 March 2027 and will be displayed on the credit card statement. If customer does not receive the Extra Cash Rebate before 30 April 2027 and fails to notify the Bank by this date, the customer shall be deemed to have irrevocably forfeited and relinquished all rights to the Extra Cash Reward, and the Bank shall have no obligation to issue the Extra Cash Reward or provide compensation in any form or manner. For the avoidance of doubt, the Bank’s records and decisions on eligibility, rewards fulfillment and any other matters arising from this Promotion shall be final and conclusive.

9. Customer must hold a valid good standing of Eligible Credit Card account at the time the Extra Cash Rebate is credited in order to receive the relevant cash rebate.
- 10. If an Eligible Customer who has received the Extra Cash Rebate cancels the Eligible Credit Card within 14 months after from the date of card issuance, the Bank reserves the right to debit a handling fee to recover the cost of the Extra Cash Rebate or welcome rewards the cardholder has received against his/her account without prior notice.**
11. For all records of services, applications, transactions and any other matters in this Promotion, the Bank's record shall prevail and binding on all parties.

13. The Bank reserves the right to suspend, modify, or terminate the above and any other offers and revise their terms and conditions at any time without prior notice. In the event of any dispute, the Bank's final decision shall prevail.
14. These terms and conditions shall be governed by and construed in accordance with the laws of Hong Kong.
15. No person other than the Eligible Customers and the Bank will have any right under the Contracts (Rights of Third Parties) Ordinance (Chapter 623 of the Laws of Hong Kong) to enforce or enjoy the benefit of any of the provisions of these terms and conditions.
16. In the event of any discrepancy between the English and Chinese versions, the English version shall prevail.
